Expression of Legislative Sentiment in Memory of the Honorable Nancy Randall Clark, of Freeport

Representative **GIDEON**: Thank you, Mr. Speaker. Mr. Speaker, I rise today in memory of the Honorable Nancy Randall Clark. When Nancy was in the room, there was no doubt who was in charge. She was practical. She was forceful. She was always a problem solver. Nancy was a community leader. She was deeply beloved in our town of Freeport and we miss her greatly already.

For me, personally, she was a mentor. She was the first woman to serve as Majority Leader in the Maine Senate. And today, as we celebrate Maine Women's Day at the State House, it seems especially poignant that we remember Nancy Randall Clark. Nancy was a master at the Harraseeket Grange. She was the president of the Freeport Women's Club. She belonged to the Freeport Elder's Association. She was an incredible teacher. She was a member of the Freeport Community Services and a member of the Daughters of the American Revolution. And each one of these things meant so much to her. Thank you for remembering Nancy with me today.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Kennebunk, Representative Babbidge.

Representative **BABBIDGE**: Thank you, Mr. Speaker, I rise briefly to also honor Nancy Clark. Not only did she frequent these halls for 20 years, but as the head of our professional organization, she was the face of Maine teachers for many years, always smiling, energetic, efficient, upbeat, and on task. She deserves all the recognitions that she received during her life and I'm pleased to honor her today.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Eagle Lake, Representative Martin.

Representative **MARTIN**: Thank you, Mr. Speaker and Members of the House, I had distributed an article which appeared about Nancy Randall Clark, which I think most of you might find very interesting and give you a good background of why she was the person that everyone liked to have around her.

My relationship with her began when I was Democratic Floor Leader. She was elected for the first time as we were in the minority. Made it very clear that it was her desire that we become in the majority even though some of you may know that Nancy was raised as a Republican and became a Democrat came from a Republican family, as I did. And she came forth as a person, more important than being a member of a particular party, but interested in the future of the state. I recall a lot of things about her, some of which I can talk about, others which I cannot. But I can tell you, it's a great day that today is Women's Day in the Legislature because her goal was that women could control and be in charge of legislative committees.

I remember her coming into the office when I became Speaker and she indicated that the lack of number of women serving as Chairs had to change. And so, low and behold, by acts and otherwise, there was a majority of Chairs that were chaired by women in my second term as Speaker. And she came in and she said, "Well, that's a start. Now you have to go the rest of the way." I said, "Come on. We've done great things here together." But she was one of those who rarely took no for an answer, very forceful, and was a person who worked, not for the party, but for the people of Maine.

And so, it is, I think, a great day that we spend a few minutes talking about Nancy Randall Clark, for a person who was an inspiring person, who was a real legislator who wanted to work and make the system work. And so, I am pleased to be able to say a few things about her today. There's absolutely, to quote myself from the article, "She was extremely effective and she was an advocate for the goals that she stood for." And so, I am pleased that we, today, can adjourn in her memory.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Saco, Representative Hobbins.

Representative **HOBBINS**: Thank you very much, Mr. Speaker and Men and Women of the House, this brings back old memories of when I first began my political career. It's hard to believe it was 44 years ago. I came up to the State House to see whether or not I, as an honorary page, whether or not I would consider running for the Legislature and to begin the process of picking up my nomination papers.

Well, who did I run into at the time, was Nancy Randall Clark, who is in Augusta for two purposes: one, to pick up her nomination papers, and secondly, in her role as the president of the then called the Maine Teacher's Association. It was from that point on that I became friendly with Nancy and we both kind of followed our way through the political process, she running for a legislative seat in 1972 from the Town of Freeport, and my having to get through a five-way primary before I would be able to get to that point. She was very encouraging to me during that period of time and had some mutual teacher friends through the Maine Teacher's Association and through her professional affiliations who, ironically, became very helpful to my campaign. In fact, was the co-chair of my first campaign.

She was an incredible person that you could find her in this chamber at night time and she was roaming around the State House and she had permission from five or six legislators that she could empty out their waste baskets and take out from their waste baskets any reports or any periodicals—anything that she could send on to her constituents. And one, in particular, is someone who he referred to himself, self-imposed, "The Dean of the House," and it wasn't John Martin—he really was the Dean but the Honorable Louis Jalbert. Well, Louis Jalbert, God rest his soul, she really liked him because she could mind his empty boxes or his waste baskets and take anything she wanted. She had that kind of permission. But her constituent work to her constituents was that way. She would want to make sure that whatever was wasted here got in the hands of the constituents and those other individuals that she represented and others.

I have to tell you, she also held the record of bringing the most pages of any legislator, and probably to this day, from the greater Freeport area to the Legislature to act as honorary pages. Unfortunately, at the time, I had just turned 21 years of age and she got a big kick out of the fact that she would always bring the National Honor Society or the officers of their senior class at the time to the Legislature and she just got the biggest kick out of sending me notes from certain legislators of the opposite sex of myself because she thought that was kind of cute.

But, in fairness to her, she really was a real model for young women throughout the State of Maine, always was looking to promote themselves. I remember when my daughter Delia, it was the joint convention of the Legislature, and my daughter Delia was three years old and she came over to see Delia and she said, "Are you going to be a teacher or a lawyer like your mommy or daddy?" And she said, "I don't know," she said, "I might consider be a doctor." And so the interesting part about it is my doctor just got through school and she now is a chiropractic physician.

She always kept up with those in the Legislature that she knew throughout the years. She really followed politics well. She was delighted when our colleague, Representative Gideon, was elected to the Legislature, as she was every other, and she was very delighted to have a President of the Senate, former President Beth Edmonds, elected as President of the Senate. To her, those were the accomplishments. All of the individuals in this body should owe a great deal to individuals like Nancy Randall Clark. She truly was a great public servant, a wonderful person, and a good friend. Thank you.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Cape Elizabeth, Representative Monaghan.

Representative **MONAGHAN**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House, I'll be really brief. I worked for Senator Clark—I think it was my third job—in the Maine Senate in the mid-'80's. I was a young twenty-something-yearold legislative aide and she was a wonderful person. So very sad to see of her passing a couple of weeks ago. Along with Dan Parody, we worked in our often stressful environment. We had a lot of things going on at once, a lot of deadlines to be met, and I'll always remember some of her great advice that she gave me. She was just a great mentor; very considerate and firm. But, she reminded me that, "You know, Kimberly, this job can be a very stressful job, so my advice to you is that it's never a bad idea to start early and buy that wrinkle cream and put it on day and night, especially around the lip lines." And I always just remember her saying that. She'll be greatly missed.
