Enclosed are the reports required under 5 MRSA, §12023, due February 1, 2016. The reports include a list of all procurements in 2015 exceeding \$10,000 for which competitive procurement was waived and a list of contributions made in 2015 that exceed \$1,000.

In 2015, the Maine Turnpike Authority made \$109 million in payments to approximately 700 vendors. The vast majority of these payments, approximately \$98 million paid to 323 vendors, were for competitively bid products or services or were legally or legislatively required. The Authority sole-sourced approximately \$10 million in 2015. Most of these products or services were either proprietary in nature or were procured under long-term contracts. As these long-term contracts expire, the Authority will seek competitive bids.

Section 12023(2c) requires a description of changes to the written policies and procedures required by Section 12022.

There were no changes to the policies and procedures required by this section in 2015, therefore, there is nothing to report.

I am pleased to submit on behalf of the Board of Trustees of the Maine Community College System (MCCS) the attached report on certain procurements, contributions, and policy changes for the period July 1, 2014 through June 30, 2015 as required by 5 MRSA, §12023.

To report the information required by §12023, MCCS developed a customized reporting feature in the business management module of our information systems for each of the seven colleges and the System Office, and then fed that module with data from the purchase order, cash disbursement, and credit card systems. Combined, the seven colleges and the MCCS System Office make tens of thousands of purchases and expenditures each year. While the task of reporting on these transactions is complex, our review indicates that the colleges' compliance with existing policies is extremely high, and expenditures are consistently mission related. In those few areas where we have identified need for improvement, refinements have been made or are under way.

MCCS will continue to use its internal controls and annual outside audit to adapt its systems to changing needs, and our Board of Trustees will continue its own ongoing attention to these matters at its regular meetings.

I wish Bob a long and healthy retirement and thank him on behalf of the people of Maine for the positive and important difference he's made in the lives of so many of our state's young people. Thank you.
