Dear Honorable Members of the 127th Legislature:
Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing

LD 1562, "An Act To Make Technical Changes to the Laws Governing Child Support."

The Maine Parentage Act established the concept of "de facto parents" in Maine, and this bill purports to conform child support laws to that change. In doing so, however, it forces judges to order multiple parents to pay child support to a parent who is a child's primary residential care provider. For example, if a child lives with her mother but has both a living biological father and a stepfather, and the mother leaves the stepfather, both the biological father and the stepfather may have to pay child support to the mother.

Child support should be the obligation of one parent to another. Whenever possible, with the exception of surrogacy, a biological, non-custodial parent should be vested with the obligation of child support. When that is impossible, the court may consider other options to provide for a child's support. But this legislation unfairly obligates de facto parents, which may include step parents or even grandparents, to share a child support obligation with a biological parent who is otherwise capable of fulfilling it.

This bill also contains technical language to conform statute to a recent DHHS rule change. Previously, child support amounts were determined in part by the age of a child, with those older than 12 receiving greater support and those under 12 receiving a lesser amount. That language change is necessary and I gave the bill's sponsor an opportunity to recall this bill so that it may be amended and signed.

For these reasons, I return LD 1562 unsigned and vetoed. I strongly urge the Legislature to sustain it.

The **SPEAKER**: The Chair recognizes the Representative from Hancock, Representative Malaby.

Representative **MALABY**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House, this is, in many ways, a very simple bill with somewhat profound consequences. Frankly, simply put, this bill creates a "rebuttable presumption" that is in the best interest of a child in state custody to be placed with their kin, with a family member.

Current law is such that it states that is to be done "when possible." Federal law encourages us to do it. This amendment gives grandparents, aunts, uncles, and those who can provide a safe and stable home a better opportunity to have a placement of a child in their family. You know, when a child is needlessly thrown into foster care, or reasonably thrown into foster care for that matter, they lose not only mom and dad, but often brothers, sisters, aunts, uncles, grandparents, teachers, friends, classmates. They're cut off from everyone so loving and familiar. For a young child, it's an experience akin to a kidnapping and often children feel they must've done something terribly wrong and now they're being punished. And the emotional trauma can last a lifetime.

Currently, we use something called the Best Interest Standard to choose between equally positioned decisions. You know, that is a standard that comes out of what's called Title 19.

These laws are actually from Title 22. Title 19 would be when we have two parents and they're equally positioned, what is in, then, the best interest of the child? I believe it is always in the best interest of the child to look first at the family. And I created within this amendment, a rebuttable presumption that the family, you know, should be the best place to put the child.

But it's not the same thing as choosing between a grandparent and a foster home that a child does not know. Every study, every study that has ever been reviewed on this issue has found that children taken from their parents by the state do better when they are placed with kinship families. They do better on every metric, including a substantially less use of antipsychotic medication that seems to find its way into our child welfare system.

In Maine, the DHHS has not had a great record historically, but it is much, much, much improved in recent years. There's a lot we can do to support families. There are several other states that use this standard, this provision in law, specifically Connecticut and Louisiana, and there's several others such as Washington and Minnesota, that have specific provisions which protect the rights of grandparents and families.

You know, the problem becomes, when a child is taken by DHS because the parents are unsafe, DHHS then, often, makes the decision as to where to place the child. It's not always made by the courts. It's a recommendation. You know, if the grandparents or a relative disagrees with that decision, they have to wait, in some cases as much as six to nine months before they get a chance to have a judge hear their case. By that time, the child has already been placed in a foster home and has spent a significant amount of time bonding with a foster family.

And when the court eventually hears the grandparent's case or the family's case, DHHS can argue—and according to many family and child protective attorneys I have spoken to, often does argue—that the child shouldn't be placed with the grandparents because the child has, at this point, bonded with the foster parents and it would not be in the best interest of the child to move yet again.

Essentially, this decision to reject the grandparents was wrong, but it is validated by the passage of time and that's wrong. We ought to be doing something more to protect the rights of families in this situation because when the parental rights to the child are terminated, all of the family's rights are terminated as well. I am sure that many of you have had calls from grandparents wondering why they can't access their grandchild who is in foster care.

You know, there is, indeed, a grandparents visitation rights provision, in 22 MRSA 4005-E, but it is an extraordinary high bar and a threshold to meet and there are some people who are just not in the position financially to hire an attorney to go through a year's worth of process to get access to their family members and that's a sad situation.

And what this amendment does not do, it does not change the standard safety that must be shown for the placement of a child. It does not create a new standard. The standard would still be what is in the best interest of the child. Nor does it restrict DHHS's ability to act swiftly and decisively to remove a child from a place where the child is unsafe or in jeopardy. I just ask that you vote with me on this. I think this is a bill that would seek to preserve family structure, something that we have not done well.

Representative **HOBBS** of Saco **REQUESTED** that the Clerk **READ** the Committee Report.

The Clerk **READ** the Committee Report in its entirety.

The **SPEAKER**: The Chair recognizes the Representative from Saco, Representative Hobbs.

Representative **HOBBS**: Thank you, Mr. Speaker, Women and Men of the House, this particular bill took a lot of energy and work of the committee over a two year period of time. We commended the gentleman from Hancock, Representative Malaby, because of his dedication and sincerity to this issue. And we took much time, four work sessions the last regular session, three work sessions this session. We spent more time on this bill, fine tuning the final language, which received a unanimous report from our committee.

Our committee is diligent in their work. We called upon the Department of Health and Human Services, we called upon the Attorney General's Office, we called upon all the stakeholders to have input in this particular bill. The bill, as amended from the committee, is not everything that the good gentlemen and good Representative from Hancock would like.

However, the problem is, the amendment that was put on in the other body, unfortunately, was never discussed, debated, or had a public hearing on a significantly substantive change of the standard, the presumptive standard, from what is in the best interest of the child to a presumption that a family member would have the priority. One of the problems with the amendment that was put on in the other body is that it threatens the possibility of losing federal funds because if a placement is made with a family member before there's been vetting, a home study done, those are the protective issues that we, as the guardians of our children in the State of Maine, need to care about. And unfortunately, having the presumption, as is required with the amendment, changes the whole perspective of what has been, really, the foundation of the protection of individuals who we need to protect and that's those who are in need and those who are young in the state and in need of services.

I hope we will not take that extra step. We worked on this bill significantly and we came up, what we thought, was a better system with the help of the Department of Health and Human Services, with the help of the Attorney General's Office, and with the diligence of my committee. And I would hope that this body will honor the hard work of the Judiciary Committee and move to Insist on this bill after the motion to Recede and Concur has been voted on. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Portland, Representative Moonen.

Representative **MOONEN**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women in the House, I rise in opposition to the pending motion. I wanted to respond to a couple of comments from the Representative from Hancock, Representative Malaby. I certainly understand the concern about parental rights. I think all of us have a concern about parental rights and if we were in this situation, we would be concerned if it was our parental rights that were being challenged.

But I think it's really important to remember that this is not a standard situation that we're talking about. This situation is an emergency child protective service scenario. And when that happens, it's usually because we're facing a situation with domestic violence or drug abuse in the home, physical abuse, any number of scenarios where the Department of Health and Human Services feels that the situation is so bad that they absolutely cannot wait any time at all to take the child out of that home. And so, in that case, they go to the court for a preliminary protective order.

So, I've heard concerns that it takes six to nine months to get a hearing. In this case of a preliminary protective order, that is absolutely not true. A hearing is required within 10-14 days of an emergency preliminary protective order being issued. So, the situation is so bad that HHS feels they can't wait. But if the

parent feels that HHS is wrong, they are guaranteed a hearing within 10-14 days.

Secondly, I've heard that a lot of people can't afford an attorney to challenge custody and if this were a standard situation, that would be true in some situations. But again, this is an emergency preliminary protective situation and in that case, because of due process concerns, because it is the state, because it is HHS taking a child out of their home, the state pays for anyone to get an attorney who cannot afford one. So, again, this is a scenario where the idea that somebody won't get an attorney is not true. If they can't afford one, the state will provide one for them.

So, given that this is a fairly dramatic scenario where HHS feels that the situation is so dire that they can't wait, I think it's a very dangerous idea to say that we should put parental rights in that situation above the best interest of the child. We have the standard of best interest of the child for a reason, a very good reason, and I think we should stick with it. So I ask you to oppose this motion and if no one has asked for a roll call, I would request one.

The SPEAKER: The Chair recognizes the Representative from Hancock, Representative Malaby.

Representative **MALABY**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House, I wanted to correct a few misstatements made by the last speaker who referred to, among other things, a six to nine month wait for a parental trial or trial. I was referencing, and quite clearly, I might add, the grandparents' rights who often take six to nine months to have a trial. Also, when the previous speaker said that an attorney would be appointed, that is absolutely correct.

However, my concern here, and the focus of this bill, is not just the parents' rights, it is the family's rights. And so, I spoke to the fact that there are many grandparents who cannot afford an attorney so that they can seek the right to see their child. Because should they have a child, perhaps, who is, you know, let's say, they're drug abusers, and the state determines appropriately to take their children away. I would like to see the grandparents have the opportunity to take possession of that child. And some of them, some of them, do not have the ability to afford an attorney wait nine or 10 months to go to court and have their day in court. And so, my point is, with this very language that I've brought forth, is to coerce, to begin to create a rebuttable presumption that the best place for the child is with the family. Now, that's a rebuttable presumption, which is to say that can easily be disproven by the state if that should be the case.

And in reference to the speaker previous, is the good gentleman from Saco, he is indeed correct. This language had not been discussed. But he knew that I tried every possible way that I could to encourage the creation of language that would foster a more open PPO process and one which would result with children being placed with family. I think that's critical.

Furthermore, this language was recommended to me by the National Center for Child Welfare Reform, a well-regarded nonprofit, nonpartisan organization. I thank you for allowing me to speak twice on this issue.

The SPEAKER: A roll call has been ordered. The pending question before the House is to Recede and Concur. All those in favor will vote yes, those opposed will vote no.

If I may read you the first sentence from the testimony from the Department of Health and Human Services, "OCFS, the Office of Child and Family Services, has already recognized the need for technological improvements with regard to the system and is currently in the process of analyzing the system surrounding the CACFP with the goal of improving them. They're already doing this. They're already moving forward. We don't need a bill asking them to do it. Thank you very much.

The SPEAKER: The Chair recognizes the Representative from South Portland, Representative Hamann.

Representative **HAMANN**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House, while it's true that the Director of Office of Child and Family Services has been undertaking some technological improvements to a number of the systems that they operate, this particular process isn't just about putting fillable forms online, as the Director indicated that he was working on now. Simply putting forms, making forms fillable online, a fillable PDF, is only one component of what this bill would do.

This bill would actually streamline the application process, simplify it, clarify it. Currently, it's several downloads, zip files. Five different programs are integrated into one long application and it's unclear within that application, which program you may or may not be filling out, which form. It's all very complicated. So this bill simplifies that process, streamlines that process, so that Maine schools and daycare centers are able to tap into a potential of \$50 million of federal money to bring into the State of Maine, into schools, to help offset school budgets and daycare programs.

Currently, the CACFP program, Maine's only utilizing one percent of the total funds and we could be tapping into, like I said, a potential of \$50 million. At its core, this bill is a food insecurity bill addressed at child hunger and it's a good bill that will remove

bureaucracy for schools and get food into the hands of kids who need it.

The SPEAKER: The Chair recognizes the Representative from Harpswell, Representative McCreight.

Representative **McCREIGHT**: Thank you, Mr. Speaker, last weekend I attended a forum on child hunger in the Brunswick area and I just wanted to support what my colleague from South Portland just mentioned. There were representatives from local schools, from food banks, from agencies that try to help prevent children from going hungry and this was one of the issues they addressed. The form is much too complicated. They can't find the section that they're trying to fill out. They can't determine what section they should fill out. So I support the motion. Thank you.
