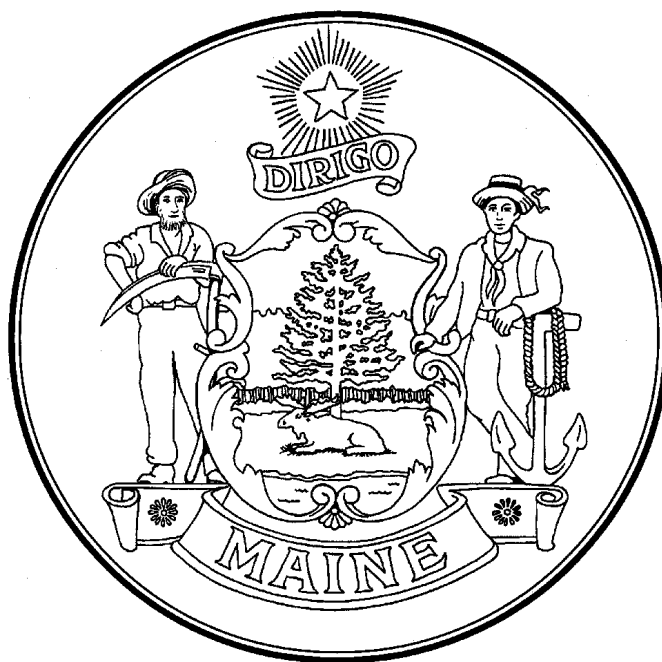

**JOINT RESOLUTION
RECOGNIZING THE EFFORTS OF FIRST RESPONDERS
IN THE TRAGIC MASS SHOOTING IN LEWISTON**

WHEREAS, on October 25, 2023, a mass shooting in Lewiston took the lives of 18 people and injured 13 others; and

WHEREAS, the shooting uprooted the lives of innumerable family members, friends, partners and community members in Lewiston and beyond; and

WHEREAS, first responders in Lewiston and from around the State immediately took action to respond to the medical needs of those injured and to prevent the crisis from developing further; and

WHEREAS, first responders who assisted during the crisis came from municipal and county fire and police departments, private and volunteer ambulance services and the State of Maine; and

WHEREAS, these first responders included paramedics, law enforcement officers, emergency medical technicians, medical professionals and firefighters; and

WHEREAS, these individuals exhibited remarkable courage, character and resilience in a moment of dire need for Lewiston and the State in service to a greater mission to ensure that our State and its many communities remain safe and secure; and

WHEREAS, we owe these individuals a deep debt of gratitude for their response to the mass shooting in Lewiston and for the critically important work they do every day; now, therefore, be it

RESOLVED: That We, the members of the One Hundred and Thirty-first Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize the heroic efforts of first responders in the mass shooting in Lewiston.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Rotundo.

Senator **ROTUNDO:** Thank you, Mr. President, Colleagues of the Senate. Today, I rise in recognition of the first responders, members of law enforcement, and health professionals who responded courageously to the devastating attack in Lewiston on October 25th. In our darkest hours, it is the heroism of everyday Mainers that just takes our breath away. It gives one hope and reminds us of who we are. So, it's truly an honor to have a chance to recognize this heroism on the floor of the Senate today. In the midst of a horrible attack on our city of Lewiston, first

responders, members of law enforcement, and healthcare professionals sprung into action from communities all across the state. It made clear that the people of Lewiston, our community, was not alone. So, today, on National Law Enforcement Appreciation Day, I want to express my gratitude on behalf of the Legislature and the citizens of Lewiston for these brave people who showed up when we needed them most. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Lafountain.

Senator **LAFOUNTAIN:** Thank you, Mr. President, Members of the Senate. I rise today to add my heartfelt thanks and appreciation to the brave men and women who jumped into action on the evening of October 25th. As a former fire chief of Waterville and Winslow, I have responded to many late-night emergencies, often with unpredictable outcomes. First responders are taught and trained to expect the unexpected, and it's often said we help people on the worst day of their lives. But nothing could have prepared anyone for the events that they all went through. The personnel who responded to the scenes in Lewiston that night showed incredible bravery and selflessness. From first responders in Lewiston to those from surrounding communities who provided mutual aid support, words cannot express how grateful we all are for their actions. As the city of Lewiston continues the grieving process and begins to heal, we must never forget the toll taken on the community. My colleagues and I are committed to doing the best we can to ensure that a tragedy like this does not happen again here in Maine. Thank you again to the first responders for your fortitude in helping those in need. We are forever indebted to you. Together, we are Lewiston strong.

THE PRESIDENT: The Chair recognizes the Senator from Waldo, Senator Curry.

Senator **CURRY:** Thank you, Mr. President. When I chose to serve and was elected to serve, I did not know so much of my focus would be on fire and EMS, and it is a great joy of my service to be connected with those across the state who are championing both fire and EMS. And I want to thank all of the first responders, law enforcement, fire and EMS, and make sure that you know that we see you. We see the work that you are doing, we see you running into situations where everyone else is running away. We see the after-effects. We see that you are dealing with responding to what is then needed and taking that back with you as professionally as you can, and we see the support that you need, and we promise that support -- I promise that support. I will champion you, and I will champion your efforts, and I just want to say thank you. Thank you for all of your professionalism and your commitment and service to this state.

Joint Resolution in Memoriam:

WHEREAS, the Legislature has learned with deep regret of the death of:

The Honorable Lois Galgay Reckitt, of South Portland, a member of the Maine House of Representatives who represented House District #122. Representative Reckitt was the Executive Director of Family Crisis Services in Portland for 36 years and was the driving force behind Maine's proposed Equal Rights Amendment. She won four elections to serve in the Legislature from 2017 to 2023. She championed many issues, most especially women's rights and the rights of other disadvantaged people. She helped to found the Maine Women's Lobby and was a board member for the National Organization for Women. During her last legislative session, she successfully sponsored a bill to partially decriminalize prostitution. As Executive Director of Family Crisis Services in Cumberland County, she served victims of domestic violence and promoted prevention efforts. In the 1980s, she was elected national executive vice president of the National Organization for Women and was a co-founder of the Human Rights Campaign Fund. Representative Reckitt will be long remembered and sadly missed by her family and friends and all those whose lives she touched;

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY:** Thank you, Mr. President. Thank you, Colleagues. I rise to share with you some of my memories of Representative Reckitt. We -- she was a constituent and a friend, and we spent a lot of time driving back and forth to the State House together, so I got to know her pretty well. And when I think of Lois, I think of her deep appreciation for legislative service. For her, it was truly an honor, it was her passion, and I think in many ways she saw it as the capstone of a life of service. I first really got to know Lois in 2019 on the bus tour, which is happening again toward the end of this week, and I watched her operate in this like speed dating. She very intentionally sat with every single legislator on that bus and forged a friendship with them. And it was beautiful to see those connections at the inception of the friendship and then to watch them persist and grow throughout the legislative service. She and I both were members of the Judiciary Committee in the 130th and in this Legislature, and in that committee, she - Lois - shared her vast experience with us in an effort to further and improve the work that we did together. She shared everything, from her experiences as a young girl being subject to incest, to her statewide work as an advocate for victims of sexual violence. All that informed and improved the work we did, and I also think that Lois's vulnerability about her own life experiences really enriched our work. She also, though, is not all serious. She had a great sense of humor, and she would use it a lot. She used it when she sensed that the energy in the room was flagging, she used it to kind of pick us up, and when things got a little hot in committee, she would use it to pull

the horseshoe back together. During the last year and a half of her service, Lois experienced a lot of pain and a lot of very challenging medical issues, but she really was undaunted in her service of her constituents and what she would refer to as the ocean end of South Portland, and also those throughout the state because she really did think of every Mainer as being her constituent. She took on and got passed landmark legislation to protect people who had been subject to sex trafficking. She was invited to participate at a symposium in Philadelphia - well, in Pennsylvania - toward the end of the summer, early fall. She was so excited to present information about the fight to get that bill passed at the symposium. But sadly, she was admitted to the emergency room the day that she was supposed to travel to Pennsylvania. But in true Lois fashion, she just pulled up her phone on her emergency room bed and connected to the symposium by Zoom and participated for several hours in the symposium. In her final days, Lois was - again, true to character and true to the passion that she brought to legislative service - she called me a couple days before she passed away and said, you know, I'd like to see you and by the way, can you bring over a box of tangerine popsicles when you come. And so, I did, and when I got there, she shared with me, you know, her perspectives and advice about the legislation that was going to be presented to Judiciary in the upcoming session to make sure that I knew what her thoughts were, and then - and this is where I need my tissue - she also shared very warm and encouraging thoughts about all of the committee members and asked me to pass on specific messages to people and just to let everybody know that she was thinking of our work and would be following us. And so, I think I'll sit down because I'm crying, but I do really appreciate the honor of serving with her, and I'm happy to share that all with you. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Sagadahoc, Senator Vitelli.

Senator **VITELLI:** Thank you, Mr. President, women and men of the Senate. I also rise to honor the late Lois Galgay Reckitt, who was a venerated lawmaker, a community leader, a changemaker, an unabashed feminist, and a persistent activist. She was intelligent and compassionate in equal measure. She was also a dear friend and colleague over many decades. Lois was a stalwart advocate for the rights of women, children, victims of sexual violence, and the LGBTQ+ community. She took the pain of her past and turned it into motivation, standing up for those who needed it. Whenever she saw a gap in advocacy or a social safety net, she put herself to the task of fixing it. We all deserve someone who will fight for our inalienable human rights, and in Maine, that person was Lois. I was so proud to fight alongside her, time and again, to try and pass an equal rights amendment for Maine. It was always clear to me that she was in it for the long haul. She never gave up, nor will I. She will be deeply missed, but I know her legacy will serve as inspiration for generations for champions for equal rights. May her memory be a blessing for her family and her loved ones and for all of us in the State of Maine. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I'd say I had the distinct honor and privilege to work alongside Representative

Reckitt on the Judiciary Committee this past year, and I know it came as a surprise to me, came as a surprise to her, and she kept telling me how much it came as a surprise to many of her democratic colleagues, just how close a friendship we managed to form despite being from different generations, different regions, different political parties, different ideological bents. There was something in Lois that I think really sets a standard for all of us as legislators, and that was her ability to possess the courage to stand her ground on matters she passionately believed in, and to not back down, while also possessing the good faith to seek common ground with those who we do not always -- do not always agree with. And I think that really led to some interesting moments of bipartisan accomplishments that because of that good faith, because of that ability to seek common ground that Lois had, we found some surprising opportunities to move things forward. So, just holding that out, the model that she set, the courage to stand her ground, and the good faith to seek common ground, I think Lois set the standard that we all can aspire to. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Hickman.

Senator **HICKMAN:** Thank you, Mr. President, women and men of the Senate. Lois Galgay Reckitt; when she came to the Maine House of Representatives, I think a term or two after I did, she sat two seats in front of me on the aisle, and I knew I recognized her from somewhere, but the photographic memory didn't work, so I didn't know where that was. Turns out, I met her two decades ago. I was doing a book reading from my memoir and she was there and, as one does at book readings, it was actually a book signing, and I signed her book. And a year ago, she presented my book back to me. She says, it doesn't look like I've read this, Senator, but I have. But it was in perfect condition, and she said open up to the title page, and I saw my signature and the date, and I cried. I was unfortunately unable to attend her memorial service because I wasn't feeling well, and you don't go to a memorial service if you're not feeling well. But I never took a day for granted that I was able to serve the people of the great State of Maine alongside what I always called a living legend. She was a fierce advocate who always amplified the voices of those who cried in the dark. She was a relentless warrior for freedom and justice for all people. She was a remarkable, down-to-earth human being with a heart bigger than a continent, and hilarious as all get-out. She would have me in stitches. Her humor was irreverent and surprising and disarming in every way. So, rest in power, dearest Lois, you will inspire me forever. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Daughtry.

Senator **DAUGHTRY:** Thank you, Mr. President, Ladies and Gentlemen of the Senate. Sometimes in our lives, we get a chance to meet an icon, and sometimes, if we're lucky, we get to not only meet and work with them, we get to call them a friend. For me, Lois was one of those people. I have family and friends who worked with her at family crisis services and even a friend who worked with her when she was a high school -- not when -- when she was a high schooler and when Lois was at NOW, at the National Organization of Women, and always spoke so highly of her. For me, I heard about her work and passion from them, and

she felt like this amazing icon and living legend, as Senator Hickman said. She was a pillar of the Maine feminist that I grew up caring about, and she is part of a vanguard of Maine women that I like to consider as sort of the founding mothers - some which sit here, near me, in this Chamber. And I'm still excited and stunned that I got to be a little part of her life and get to know more than just her resume. Getting to experience her wit and humor and warmth were an incredible part of my legislative service. And also, her incredible polished nails, which I did have painted in the same shade but unfortunately did not last quite long enough. Her love of the Red Sox and getting to celebrate all things Irish, she always told me that I was just Irish enough to count. And one of the things that I will always remember is when I got to work with her at Emerge Maine, I was part of the class where she was working on her pitch for running for office. And one thing that I will always take with me that I think can apply to so many people is she would stand up in front of the class and she'd start her speech and go I'm not from Maine, but I got here as fast as I could. Rest in peace, rest in power, we miss you, Lois.

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Keim.

Senator **KEIM:** I can't add much to what's been said, but Lois -- I served with Lois in my first term in office and was chair of Judiciary and gosh, it was such a pleasure to serve with her. She was smart and she was kindhearted and witty and always surprising. And I just loved at first, you know, being a little bit like oh, gosh, I'm supposed to be controlling this committee and, you know, she'd just go on and on and on at the mic. And then finally, you just sit back and enjoy the ride, right? Because it seems like she's going nowhere, but eventually, she brings it right back around. And she was connected to everyone. She'd get on mic, and it doesn't matter who was coming in front of committee, Lois could find a way that she knew them or she was connected to them. And I think we all can see why, because she made it an effort to be connected. So, politics aside, Lois led with her heart. She loved people, she was always kind - like, even when I voted against the thing she cared about the most, which is the ERA, you know, she was angry with me for a little bit, she really was, but, you know, there was a warmth there that went beyond that and that is what -- that's what marked her life and absolutely made her so successful at what she did. And she's a role model for all of us, just her love of people and her way to use humor to bring everyone together and really lighten the situation, even though she was talking about something she cared about so passionately. So, it was an honor to serve with Lois.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Bailey.

Senator **BAILEY:** Thank you, Mr. President. I'm probably not going to be able to talk long without crying, but it was an honor and a privilege to know Lois and to consider her my friend. I served with her both in Judiciary, I served with her in the House, and I just wanted to add to this two things that I know I just want to be part of the record, part of her legacy on a lighter note. First, was her hard work. And what I mean by that, as Senator Hickman alluded to, she read everything and as an example of that, we in Judiciary were working on the uniform digital asset act and as part of that learning about what access people do have for

peoples' digital social media after they pass away. And in true Lois fashion, she's like well, if I'm going to be discussing this, I want to know what I'm talking about. And so, she is probably the only legislator, if not the only person in the State of Maine, to have actually read the terms and conditions for Facebook from start to finish, and she educated the rest of the committee on it. But that is how hard Lois worked all the time. And the other thing I just wanted to say, Lois, is I am sure, and I am sure you are grateful that there are no private roads in heaven.

And in a place like northern Maine, having someone like that move into it and kind of kickstart things that maybe had languished for a long time was really quite amazing to watch. I mean, right out of the gate, she wanted to get her license to practice law in Maine, opened not one but two restaurants with a completely new menu for the area. And every time there was a public thing like Can-Am or Scarecrow Day or whatever the Chamber was putting on in the area, I mean, she was the first one to take off and do a whole bunch of things for the community. Like I said, the last Can-Am, I mean, the place was just mobbed. You couldn't hardly walk in there, and there she was, going around, you know, talking to people, handing out drinks, and things like that. But she just really was an amazing person that in a very short time, and you can see it all throughout Fort Kent, in a very short time, she made a lasting impact on the people up there with her humor, her vibrancy, everything that she brought, I mean, I just never had anyone ever have a bad word about her and nor should they have, because she was a super, super, dynamic person that the whole community is going to miss big time, and it's such a tragedy that somebody so young and energetic and community driven has been taken away. So, I just wanted to spend a moment to remember her because that's what people should do with really great people. So, with that, I'll sit down, and thank you, Madam President.
