**JOINT RESOLUTION
RECOGNIZING MARCH 2024 AS ARTS EDUCATION MONTH**

WHEREAS, Arts Education Month celebrates and amplifies the innovative work of arts educators in service of students and families in communities across the State; and

WHEREAS, the State recognizes arts learning, including dance, music, theater, visual arts and media arts taught by certified arts educators in partnership with community providers as an essential element and core content of a complete and balanced education for all students; and

WHEREAS, arts learning includes engagement with literary arts, folk and traditional arts and service-oriented projects and involves many interdisciplinary connections; and

WHEREAS, arts education provides substantial educational benefits to all elementary, middle and secondary school students; and

WHEREAS, arts education develops students' creative potential and supports collaboration, communication, problem-solving and critical thinking skills that are essential for our workforce in the 21st century; and

WHEREAS, arts education has the power to change students' lives; and

WHEREAS, students, families and community members benefit most from arts learning opportunities that are designed to be accessible to all and to make connections to the lived experience of students across the State; and

WHEREAS, arts education helps nurture healthy, inclusive communities where all points of view are respected; and

WHEREAS, while arts learning supports academic growth in a variety of content areas, each arts discipline has tremendous value as stand-alone academic content; and

WHEREAS, equitable access to arts education opportunities is sustained by a wide range of partners, including school leadership, educators, families, teaching artists, arts organizations, local and statewide organizations and government agencies; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to designate March 2024 as Arts Education Month and to recognize the professional expertise of arts educators and advocates around the State, invite community leaders to continue to strengthen and increase access to arts education for every student regardless of geographic location and give our full support for quality school arts programs for Maine's youth.

As a proud Brunswick High School graduate, and as an avid basketball fan, I am personally over the moon and so, so, so, so proud of this team. These women have inspired our entire town. And as a girl who grew up playing basketball, I can only imagine what an inspiration they would've been to me when I was little, considering what an inspiration they are to me today. Further, I have to add we also had the Bowdoin College Women's Basketball Team has been on a winning spree as well, and when I was meeting with the Brunswick fourth graders two weeks ago, who were excitedly telling me about how they got to meet this incredible team, I had one young boy come up to me and ask if boys can play basketball, too. Today, I am so proud to acknowledge not only my hometown and our high school girls basketball team by presenting a legislative sentiment to recognize your hard work, dedication and talent, I'm so proud of you all, so proud of the Dragons, and I wish you all the best as you finish this school year and your future endeavors, and I am very excited for next season. Thank you.

I have to give condolences to his wife, Vicki, of 50 years, as well as to his children, a few of which I know - Laurie, Shelly, Rob, who unfortunately passed away recently, and then Sharmin, Chris, and Jamie, who I've had the pleasure to know and get to know over the years. Senator **GROHOSKI**: Thank you very much, Mr. President. I just wanted to give members a quick overview of what this bill does and why I hope you'll join me in supporting it. As you probably know, we have a property tax fairness credit which is accessible for folks who file their income taxes, and this is a great opportunity to remind everyone to please remind your constituents that whether they owe money or not, they should file their income taxes because there are a lot of opportunities available when you do so. So, that's my PSA for you all this morning to pass on to the public. But the property tax fairness credit for folks over 65 allows that people who make -- who spend more than 4% of their income on property taxes can get up to \$2,000 back to help pay for those property taxes. This is available to people who rent or to people who own. We also have a similar program for people under 65, but that's not the program that we're looking to amend today. So, what this bill does is it says that if you are a person who's making under \$36,000 a year, instead of that threshold needing to be 4% of your income, if your property taxes are greater than 3% of your income, you would qualify for this benefit. I think that this is a really important measure because although the benefit is not huge, the amount of money that people that are in this sort of lower income level, people who have worked their entire lives, people who are on Social Security making \$22,000 a year, that is the average in the State of Maine, would get a benefit that I think will help them stay in their homes. We know that when people go into nursing homes, for instance, MaineCare pays roughly \$36,000 a year for them to be in a nursing home, and I would just point out that's if you live in an area that has a nursing home - unfortunately, Hancock County is the first county in Maine to have lost all of its nursing homes, a problem that we do need to solve - but I think this bill, which has a modest cost, could save the State a lot of money. For every person that we're able to keep out of a nursing home for a couple months, six months, a year, we save ten times as much as what we paid through this program to try and help them stay in their homes. So, I think this is a great opportunity to help seniors, help people who work their whole lives but don't have enough money coming back to them through Social Security to meet the increasing costs of property taxes, and I do think it will be an investment that saves the state money in the long term. So, I hope you'll join me in supporting it.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY:** Thank you, Mr. President, Colleagues of the Senate. I rise briefly because I don't want this moment to pass without us acknowledging the incredible contributions that Senator Keim has had in the work that we've done as a state to strengthen the way we protect Mainers' Sixth Amendment rights. LD 653 was originally offered by Senator Keim in the First Session, and she's worked tirelessly not just during this Legislature but for many years, she's been dedicated to protecting Mainers' Sixth Amendment rights. She's been an outstanding leader on this issue. And with this legislation as amended, we will accomplish a great step forward. And we're going to change the name of the Maine Commission on Indigent Legal Services, which frankly a lot of people have a hard time understanding what it refers to, to a name that accurately reflects the new role that this organization has in protecting Mainers' Sixth Amendment rights. It will become the Maine Commission on Public Defense Services. The legislation also establishes a number of crucial positions to build out Maine's system of public defender offices, which generally match our district attorney offices. The changes include transferring MCILS funds from an all-other to personal services account to allow the hiring of additional public defenders. It includes an emergency preamble that will allow the commission to proceed immediately with building out our public defense system. A yes vote will add an Aroostook and a Penobscot-Piscataquis office to our current

system within the next several months. This legislation is truly an emergency due to the lack of attorneys available for court appointments, 500 adults lack attorneys, and 150 of those are currently in jail right now. And I would just conclude again by acknowledging the contributions of Senator Keim in this really important area and ask that you all support the enactment of this legislation on an emergency basis.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I'm pleased to have an opportunity to rise in agreement with my colleague from Cumberland County, Senator Carney. This was a unanimous report out of the committee addressing something I think members of this body is aware is a constitutional crisis in our state, which is the lack of availability of attorneys for those who cannot afford them and yet face charges. Our Constitution does obligate us to provide legal representation to those who are being charged under the laws that we pass in this state, and we are not meeting that obligation right now. I believe, Mr. President, I think you assessed it very well in a recent joint meeting of the Appropriations Committee and the Judiciary Committee that what we're seeing right now with Indigent Legal Services is a slow-moving train wreck. And this legislation before us is the best proposal that I've seen for helping to get us on a path to meeting our constitutional obligations there. So, I'm really glad that we've found consensus around opening these public defender offices. I believe there will be additional public defender offices that may appear in the supplemental budget, but these are a good start from where we are right now. I will say as far as the name change goes, I suppose it's -- I suppose it's an improvement. So, it would be the Maine Commission on Public Defense Services. I wonder what the acronym will be like McPDS will be a wonderful organization to refer to. We had some debate in committee about what the acronym would be, but I suppose this will be all right. So, anyway, thank you, Mr. President, and I am proud to stand with all my colleagues on the Judiciary Committee in encouraging the passage of this measure right now.

THE PRESIDENT PRO TEM: The Chair recognizes the senior Senator from Oxford, Senator Keim.

Senator **KEIM:** Thank you, Mr. President Pro Tem. First, so much gratitude for my colleague from Cumberland, Senator Carney, for those kind words. When I first joined this august body, the very first thing that was thrown at my table -- on my table was the idea that Indigent Legal Services was a mess in need of serious reform. And I was sitting at my desk, leading Judiciary Committee as the Chair, and I was googling Indigent Legal Services. And I thought how do I fix this? Google doesn't even know what it is. And so, from that moment on, you know, I realized, of course, what a crisis actually has only escalated really with our Sixth Amendment rights and in -- and so began my deep dive into learning about it and trying to really educate my colleagues around the crisis that we were facing and just advocating it for so many years. So, actually, this is a pretty momentous time to just have the name changed so that, you know, in the future, some poor chair of Judiciary who is not at all involved in the legal community doesn't have to, you know, Google what they're trying to fix, but instead will just understand because generally people understand what public defense is. So,

I'm very pleased that there is a name change, we don't even have to use an acronym, we can just call it public defense and people are going to understand. And more importantly, the people of Maine, when we advocate for this, they'll know what their money is going to, and that's why I thought it was so important to change the name. They should understand because they will get behind it when they understand what it is, and it is a crisis, and so I'm so pleased to see this expansion of government, which I'm generally very opposed to, but in this area, it's so needed, and it has been building slowly to this point. And every step along the way has only gotten -- made our services better and so this isn't a rash decision, it has been building for years to this point. So, it's a culmination of so many hours of conversations about what to do. So, it is, again, a momentous time. Thank you.

The Chair noted the absence of the Senator from Aroostook, Senator **JACKSON**, and further excused the same Senator from today's Roll Call votes.

This being an Emergency Measure and having received the affirmative vote of 33 Members of the Senate, with no Senators having voted in the negative, and 33 being more than two-thirds of the entire elected Membership of the Senate, was **PASSED TO BE ENACTED** and having been signed by the President Pro Tem, was presented by the Secretary to the Governor for approval.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from York, Senator Ingwersen.

Senator **INGWERSEN:** Thank you, Mr. President. Thank you for the opportunity to speak on this bill, LD 1152. Public employees in the Maine Public Employees Retirement System, or Maine PERS, have no long-term disability program currently, and every year, teachers, state employees, first responders, and others, are simply falling through the cracks. My commitment and interest to long-term disability began many years ago. It's personal, and I have a bit of a story to tell. My teaching colleague and good friend, Bob Sprankle, suffered unbearable nerve pain from a hernia operation in 2007 that went on for eight years. He applied for long-term disability to discover that it wasn't available to him. He used his sick days, he borrowed from a sick leave bank, he took a short leave of absence, he used every avenue available to him because long-term disability was not something that was currently available. When Bob's options ran out, he returned to work, full of painkillers that really did little on most days, and rested when he could not do much. He set up a cot in his classroom, and he would rest there between classes and then get up to teach when he had to or when he was able to. For over seven years, Bob dealt with this unbearable pain, chronic pain, all the while trying to work and fight with Maine PERS, and he finally had to stop working altogether. Maine PERS currently has a short-term disability program, and while this program provides some financial security during short-term disabilities, when individuals like my friend, Bob, had long-term disability, their disability just fell outside the current program. This is devastating for our public employees. Too sick to work, and yet no long-term disability program to help you stay afloat financially. The lack of long-term disability is another way that our public employees are disadvantaged compared to those paying into the Social Security System. Individuals in Social Security have access to both short-term and long-term disability. Since public employees do not pay into Social Security in our state, they are not eligible for disability benefits in the Social Security program. Maine PERS has a gap in coverage. Social Security does not have the same gap, and it's important to note here that teachers and state employees pay

7.65% of their salary to Maine PERS, whereas if they were in Social Security, they would be required to pay 6.2%. In 2021, the Legislature made significant changes to the short-disability program and those improvements have helped both the system and its members. As part of that effort, a taskforce was convened to investigate the options to provide a long-term disability plan to all Maine PERS participants. The taskforce, which was led by Maine PERS, worked together and developed a framework for implementing such a program. LD 1152 is the fruit of that report. The taskforce was very clear, the more individuals in the plan, the more we can reduce cost for everyone. LD 1152 attempts to fill this gap in long-term disability and will help make sure such future disabled public employees such as teachers and state employees do not fall through the cracks again. I hope you'll support this legislation, and thank you very much.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Hancock, Senator Grohoski.

Senator **GROHOSKI**: Thank you, Mr. President. I just want to give a brief update on this bill. In 2019, the Maine Legislature passed what was LD 1028, An Act to Prevent and Reduce Tobacco Use with Adequate Funding and by Equalizing the Taxes on Tobacco Products and to Improve Public Health. This bill equalized taxes on all tobacco products to the rate of combustible cigarettes. Before the law passed, Maine was taxing other tobacco products at a much lower rate than cigarettes, which created a tax loophole for the tobacco industry to develop and market new products at a lower cost to attract new customers, many of whom become addicted to nicotine. This Legislature this Session, the Department of Administrative and Financial Services submitted LD 2028 as a department bill to correct technical issues in tax law. One portion of LD 2028 closes a loophole that inadvertently excluded certain synthetic nicotine products from being taxed correctly, in alignment with the law passed in 2019. Essentially, the 2019 law was drafted without the benefit of a crystal ball or the phrase including but not limited to. Let this be a lesson to everyone in their drafting. The Minority Report on LD 2028 attempts to align the policy debated and adopted previously by the Legislature and signed into law in 2019 to address youth nicotine addiction by taxing all products containing nicotine at the same rate. I support this bill because from a tax policy standpoint, the policy direction is clear, but the statute itself is lacking. This is a technical change which

addresses unfairness in our tax code. I also support the policy direction. The tobacco industry continues to innovate, and new products like nicotine pouches have high levels of nicotine and appeal to kids because they have a lower cost, thanks to this tax issue, and they are easy to conceal. The industry is spending millions of dollars marketing new smokeless products as less harmful, more convenient, and more socially acceptable alternatives to traditional cigarettes. The synthetic nicotine in these pouches is not recognized as a cessation product. If it were approved as such, it would be exempt from taxation in Maine. If you're not sure what a nicotine pouch is, I can give you one example, Zyn, which is spelled Z-Y-N. This is a tin that contains 15 small white rectangles that look a bit like those desiccant packages that are labeled do not eat that you get with your shoes and other things like that. Zyns are filled with nicotine and are meant to be placed under your lip like tobacco dip. No spitting is required, so nicotine pouches are even less visible than vaping. While Zyns are presented as a healthier, smoke-free alternative to cigarettes, they are still addictive, and we're already finding that dentists are reporting gum injuries for patients who use these pouches. In addition to changing brain chemistry, other health effect of nicotine use include increased blood sugar levels, increased heart rate and blood pressure, and increased risk of heart attack. Synthetic nicotine pouches are being marketed to kids as risk free and trendy, safe alternatives. The 2023 Maine Integrated Health Survey showed that 3.1% of Maine high school students are currently using chewing tobacco, snuff, dip, snus, or dissolvable tobacco products, which is twice the rate of national respondents using nicotine pouches. Our tax laws need to align with our public health policies, which recognize that nicotine, regardless of how it is consumed, is harmful to health. The department's proposal to close this loophole will help prevent these products from becoming the next vaping epidemic which we will soon be scrambling to protect our youth from if we do not act today. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Libby.

Senator **LIBBY:** Thank you, Mr. President. We all know you want to be called Mr. President instead of Pro Tem. It's an inside joke. Thank you, Mr. President. Well, I'd like to see -- first of all, I want to thank the Good Senator from Hancock, Senator Grohoski, for her hard work on this bill, and I agree with many components of the bill. But I think, you know, when we're trying to correct technical parts of the law, one of the technical parts of the law that we really need to correct is the difference between nicotine and tobacco, and that is just not done here. We are talking here about products -- some nicotine products -- I mean, even in the form of gum and other products, right? And just from a personal standpoint, my mother was a smoker when I was young, and my brother and I, we ganged up on her and we said, you know, we really don't want you to smoke. And I still kind of feel pushy about that, by the way, but she agreed not to, but she needed help. And smoking cessation can -- can be aided by some of these products that we're talking about here and that is why we're speaking about a Minority Report here is because people were conflicted between some of the -- some of the effects of nicotine products that are negative, but then there are the effects that are positive. And it was a very difficult vote. This is one of those everything including the kitchen sink kind of bills, if you -- if you read it. But I think I'm on the compassionate side of the bill, I

honestly do, and that would be the majority amendment, not the one we're considering here, and the -- the products that we're specifically talking about are called modern oral nicotine products, and they come in those various forms, but they include pharmaceutical grade nicotine, not tobacco leaf. And at some point, if we're going to talk about the technical parts of the law, we've got to define that. We can't just lump it together. And unfortunately, the Minority Report still does that despite some great effort here. So, I hope that you'll join me in opposing this item so that we can get to the Majority Report, and I thank you very much for your time.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Kennebec, Senator Hickman.

Senator **HICKMAN:** Thank you, Mr. President. May I pose a question through the Chair?

THE PRESIDENT PRO TEM: The Senator may proceed.

Senator **HICKMAN:** In the sales of tobacco products statute, tobacco product means any product that is made from or derived from tobacco or that contains nicotine, and those words are being added to the sales tax for the tobacco tax definition? Is that correct?

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Hancock, Senator Grohoski.

Senator **GROHOSKI:** Thank you very much, Mr. President, and thank you for the question from the Senator from Kennebec. The change would say tobacco products means any products that are made from or derived from tobacco -- let me just -- I'm engrossing the two bills in my head right now -- or that contain nicotine, whether natural or artificial, including but not limited to. So, that's the change. There is this bizarre artifact that I don't really know the history of or understand, but the FDA itself defines tobacco products as things that contain nicotine because originally, that was the only place where we were getting nicotine, where it was being extracted from. Over time, due to the marvels of modern science, we have figured out how to synthesize nicotine. And so, the FDA is recognizing that that shift has happened, but they haven't gone all the way upstream to redefine tobacco separately from nicotine, they've lumped any kind of nicotine, whether it's artificial or -- excuse me -- synthetically derived or if it comes from a plant, under tobacco. So, we are -- it is a little bit awkward, but we are falling in line with how the federal government defines tobacco, which can include synthetic nicotine.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from York, Senator Harrington.

Senator **HARRINGTON:** Permission to ask a question through the Chair?

THE PRESIDENT PRO TEM: The Senator may proceed.

Senator **HARRINGTON:** I guess I'm just curious, can you give a rundown on which products this will raise the tax on, i.e. chewing tobacco, premium cigars, etcetera?

THE PRESIDENT PRO TEM: The Chair recognizes the Senator

from Hancock, Senator Grohoski.

Senator **GROHOSKI**: Thank you, Mr. President. If Members don't mind, I would read what's in the current statute that's currently taxed at this rate. So, it's tobacco products, cigars, including premium cigars, cheroots -- I don't even know how to say that, sorry -- stogies; electronic smoking devices and liquids used in electronic smoking devices, whether or not they contain nicotine; periques, granulated, plug cut, crimp cut, ready rubbed and other smoking tobacco; snuff; snuff flour, snus; cavendish; plug and twist tobacco; finecut and other chewing tobaccos; shorts; refuse scraps, clippings, cuttings and sweepings of tobacco; and other kinds and forms of tobacco, prepared in such manner as to be intended for human consumption or as is likely to be consumed, whether smoked, heated, chewed, absorbed, dissolved, inhaled or ingested by any other means. So, all those things are currently taxed. What this adds is novel products such as the nicotine pouches, which don't fit into this very long list of things but do have parallels, for instance, with electronic smoking devices and liquids used in electronic smoking dissolved, whether or not they contain nicotine. So, I think that it is -- it's really just an issue where we tried to make a very comprehensive list a couple years ago and failed at anticipating what might be coming. And so, I hope this problem will be solved from henceforth by adding that but not limited to language because I think when we try to guess at what's coming ten or 15 years down the road, we just don't always get -- we don't have the full picture. So, the only thing that I'm aware of that's currently on the market that's not being taxed at this rate is the nicotine pouch.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Libby.

Senator **LIBBY**: Thank you. Just to follow up on the Good Senator's comments. My understanding is that we're also talking about other products such as -- it's mostly pouches, but other products such as gum, lozenges, and tablet form, those are all sold currently.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Hancock, Senator Grohoski.

Senator **GROHOSKI**: Thank you for allowing me to continue to answer questions, or to comment. So, if any of those items that Senator from Cumberland, Senator Libby, just mentioned are approved as FDA cessation devices, which I think a lot of gums, for instance, and patches are, then they are not taxed in the State of Maine. There may be products that I'm not aware of that are not approved devices but are those same delivery methods that I just might not be aware of.

Senator **BALDACCI:** Thank you, Mr. President. I just briefly wanted to take note of this bill. This is the Speaker's bill on mental health services, and it provides a number of important features that I think all of us want and have championed for a long time, including significantly additional money for 24-7 mental health services all over the state. In addition to the million dollars that's been set aside in the governor's budget for Lewiston to have a crisis receiving center and the money that we're annually funding in Portland for Preble Street, it will create two additional mental health crisis receiving centers, one in Penobscot County and one in Aroostook County, which will help greatly expand the services available for people and also to give law enforcement and others an alternative in terms of jail as an option in terms of treatment. So, there's a number of important things in this bill, including creating an Office of Violence Prevention and also budgeting additional \$6 million for medication management and to cut the waiting list. So, I just wanted people to take note, this is a very important bill, it was passed unanimously in the committee, and I appreciate your support.

Off Record Remarks

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Libby.

Senator **LIBBY:** Thank you. A comment that I made earlier that I wanted to clarify. Senator Bennett is actually a very good parliamentarian, one of the best that I've ever met, and so we've been having this debate in our caucus as to whether or not a President Pro Tem should actually be referred to as Mr. President. And there is some debate among academic circles and in government as to whether it should be Pro Tem or President. So, earlier, in jest, and kind of poking one of the best parliamentarians that I think I've ever met, that -- it was the reason for some of my comments. I just want to make those clear. Thank you very much.

THE PRESIDENT PRO TEM: The Chair thanks the member and would just add that Mr. President is in order, as is Madam President, as the circumstance may call.

All matters thus acted upon were ordered sent down forthwith for concurrence.

Off Record Remarks

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Pierce.

Senator **PIERCE:** Thank you. Women and men of the Senate, as we continue celebrating Women's History Month, I am proud to recognize Eliza Lothrop Homans, a trailblazer whose pioneering work in conservation helped shape her era and generations to come. Eliza was born in 1832 in Dover, New Hampshire. She spent her childhood in Boston and married Charles Dudley Homans in 1856. They lived in Boston but spent summers from the 1870s and onward at their cottage near Schooner Head Overlook, just a few miles from Bar Harbor. Mr. Homans died in 1886. In May of 1908, Eliza deeded 140 acres to the Hancock County Trustees of the Public Reservations, founded by George Dorr and Charles William Eliot, then President of Harvard. The goal of the Hancock County Trustees of the Public Reservations was to protect the stunning landscape around the 1,500 foot Cadillac Mountain. Eliza opted for the land transfer but asked that her name not be publicized. In her letter at the time of her gift, she said, 'I'm doing this because I've learned the lesson of conservation. I think that unless we do this Mount Desert Island is going to turn into an amusement park with possibly a merry-go-round.' This was the first land donation to the HCTPR that started the momentum for the subsequent land donations and purchases of what would become Acadia National Park. Her land transfer, which included part of Champlain Mountain, the Bowl, the Beehive, and Sand Beach, did have conditions, including the right to shoot, fish, boat, and keep a boathouse on the Bowl. The Beehive Mountain Aqueduct Company was also permitted to continue using the pond for public water supply. Eliza's land included what many hikers know now as the Beehive, a steep and challenging hike that offers breath taking views of Sand Beach

and into the Gulf of Maine. Eliza Homans died in 1914 in Bar Harbor. Between 1915 and 1916, the Homans Path was constructed in her name as a part of a trail network at and around Sieur de Monts, the area there. It's a steep trail consisting of granite steps, tight passages, and overhangs where hikers can continue on to the summit of Dorr Mountain. The pathway was lost in the 1940s but reopened in 2003 as a part of the Acadia Trails Forever Project. This path is dedicated to Eliza and serves as a reminder of her legacy and leadership in conservation. In addition to Eliza, many women have made great strides in Acadia history and conservation as whole. A few here include Beatrix Farrand, the landscape architect who is responsible for so much of the look Acadia's carriage roads. Ardra Tarbell worked in the Acadia National Park for 39 years, including being the first woman Chief Clerk and Administrative Officer under the first Superintendent and Park Founder, George Dorr. Florence Bascom, fondly called 'The Stone Lady,' was the first professional female geologist to survey Mount Desert Island, publishing 'The Geology of Mount Desert Island' in 1919. Margaret Stupka was a trained botanist, among the many park wives in the 1920s and '40s who serves the National Park Service without pay, working on trails and recording the botany of the land. And Roxanne Quimby, who carried on the inspiration from Eliza Homans by donating some more land to Acadia National Park and to the Katahdin Woods and Water National Monument. If you never had the opportunity to visit Acadia, hike the hundreds of trails that lead to the summit with extraordinary views to the west of our state and to the east of the scattering islands that lead to the open ocean, I encourage you to put it on your bucket list. You will not be disappointed. I am fortunate to have spent the last 30 years heading up to Mount Desert Island and Acadia National Park. My husband and his family have been living and visiting the area for over a century. In fact, Charles William Eliot is my husband's great-great-grandfather. We have biked the carriage trails and hiked the Beehive, Champlain, Dorr, and countless other trails, but I am embarrassed to say I'd never heard of Eliza Homans until this moment when I needed to do something on the floor. That's a loss. That's too bad. This summer I will have the opportunity to travel there again with my family and friends. For as long as I can remember, at the end of each day we gather around the dinner table to tell our stories and adventures of our time in the park that day. I will share Eliza's story, for in truth had it not been for her foresight and generosity our day in Acadia and the days of millions of visitors who come every year to Acadia National Park would have never been made possible. I appreciate the opportunity to recognize - to share this recognition and honor the many outstanding women who have made the park possible. Thank you, Mr. President.
