ONE HUNDRED AND THIRTY-SECOND LEGISLATURE
FIRST SPECIAL SESSION
1st Legislative Day
Tuesday, March 25, 2025

This being the day designated in the proclamation of the Governor for meeting of the One Hundred and Thirty-Second Legislature in extra session, the members of the House of Representatives assembled in their hall at 10:00 in the morning and were called to Order by the Speaker.

Prayer by Marc Swartz, Calvary Chapel, Augusta.
National Anthem by Abigail Gerrish, Mexico.
Pledge of Allegiance.

At this point, a message was received from the Senate, borne by Senator DUSON of Cumberland of that body, announcing a quorum present and that the Senate was ready to transact any business that might properly come before it.

A roll call was taken. 146 out of 151 Members answered to their names, and accordingly the Chair declared a quorum present.

The SPEAKER: The Chair recognizes the Representative from Fairfield, Representative Rudnicki.

Representative **RUDNICKI**: Mr. Speaker, could you inform us whether or not, in this illegal special session, if the Good Representative from Auburn gets her vote back?

The SPEAKER: The Chair would inform the Member that that is a decision of the Body.

The Following Proclamation: (H.C. 102)

**STATE OF MAINE
PROCLAMATION**

WHEREAS, there exists in the State of Maine an extraordinary occasion arising out of the need to resolve many legislative matters pending at the time of the adjournment of the First Regular Session of the 132nd Legislature of the State of Maine; and

WHEREAS, the public health, safety and welfare requires that the Legislature resolve these pending matters as soon as possible, and in any event prior to the date of the Second Regular Session of the 132nd Legislature of the State of Maine, including but not limited to the state budget, pending legislation, pending nominations of state board and commission members, and pending nominations of judicial officers by the Governor requiring legislative confirmation;

NOW, THEREFORE, I, JANET T. MILLS, Governor of the State of Maine, by virtue of the constitutional power vested in me as Governor pursuant to Article V, Part I, Section 13 of the Constitution of the State of Maine, do convene the Legislature of this State, and hereby request the Representatives and Senators to assemble at ten o'clock in the morning in their respective chambers at the Capitol in Augusta on Tuesday, March 25, 2025, in order to receive communications, resolve

pending legislation carried over from the First Regular Session of the 132nd Legislature and act upon pending nominations and whatever other business may come before the Legislature.

In testimony whereof, I have caused the Great Seal of the State to be hereunto affixed GIVEN under my hand at Augusta this twenty-first day of March Two Thousand Twenty-Five.

READ.

The SPEAKER: The Chair recognizes the Representative from Wales, Representative Greenwood.

Representative **GREENWOOD**: Thank you, Mr. Speaker. I rise to talk about the Proclamation and how we got here.

We started off Thursday morning with a prayer that openly mocked God. We then went through the day and pushed a budget with no regard for this side of the aisle. We then heard amendment after amendment from my side of the aisle, Mr. Speaker, and then, rather than taking a vote on the merit of the amendment, it was decided to motion to Indefinitely Postpone, which seems to be a way to shield or cover what the actual amendment is. We then continued through the day and recessed for a while, and then came back and then it was apparent that we were going to adjourn without day.

And I was just mortified that we have so much more work to do, Mr. Speaker. I even put together a carryover order, or an amendment to the one that was proposed by the Other Body, that I would agree there was lots of work to be done, but I was in agreement that we would carry it over to the next regular session, and that any committee work for the next two weeks or that had been scheduled would continue. Mr. Speaker, that seemed reasonable and fair. But that's not what happened.

We heard from the Good Senator from Cumberland, who came and announced to the Floor of the House that the Other Body had completed its work. We then sent our Good Representative from Portland to the Other Body to announce to them that we were done with our work. I was confident we weren't done with our work; still bills being referenced, still many haven't even come out of the Revisor's Office, Mr. Speaker.

Mr. Speaker, your side voted, as did ours, to adjourn without day, *sine die*. Announcing to the world that our work was done. I was willing to accept that and hoped to see you in January of 2026. But what I'm confused about is that just several hours later, on Friday, the 21st, just hours after the Body had spoken and said we were done our work, the Chief Executive ordered us back, declaring some sort of emergency or extraordinary occasion that I'm really unclear as to what happened from 12:30 a.m. on Friday morning, the 21st day of March, until a few hours later, when the Chief Executive declared this unusual, extraordinary, emergency circumstance.

Now, Mr. Speaker, I left here and I went to my day job; was there from about 1:15 in the morning till about 1:45 in the morning, and then I drove home, I went to bed, I got up early, had to get my kids off to school. It seemed like a normal day, Mr. Speaker. I wasn't aware of any natural disaster; hurricane, earthquake, sky falling, anything along those lines, Mr. Speaker. But the Chief Executive said that there is. So, I'm not sure if there was some sort of coordinated effort, and I would never question the motives or intentions of anybody in this Chamber, Mr. Speaker, but what I read here is, I think the Chief Executive called your side liars. Just a few hours before, this Body announced their work was done, and a few hours later, the Chief Executive says, no, you were lying, you're not done, and proclaims this occasion to bring us back.

So, I'll ask you, Mr. Speaker, if our work was done, and we voted on that, I would like to make a motion that we adjourn without day, *sine die*, and ask your support for that motion to reaffirm our vote from Friday morning at about 12:30 a.m.

Representative GREENWOOD of Wales moved that the House stand **ADJOURNED WITHOUT DAY**.

Representative MOONEN of Portland **REQUESTED** a roll call on the motion to **ADJOURN WITHOUT DAY**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The **SPEAKER**: The Chair recognizes the Representative from Pittsfield, Representative Collamore.

Representative **COLLAMORE**: Thank you, Mr. Speaker. Mr. Speaker, I'm at a crossroads right now. I'm disheartened, confused and more than a little hurt for my colleagues and my constituents. I'm not even sure what my role is here anymore.

Last week, a majority budget was passed to, quote, 'continue services,' but these continuing services are coming in at more than our projected revenues, about \$100 million over. Mr. Speaker, what is the point of working any bill with a fiscal note that isn't negative? I'm not sure how responsible it is of me to vote for anything with a fiscal note, including my own bills, one of which is to ensure that all caregivers have the ability to change the diapers of their children in State buildings, because we don't have access to diaper changing stations in all of our restrooms. That's only \$15,000, but how do I vote for that? We don't have \$15,000.

Mr. Speaker, I can't reconcile these two things. While I will continue to show up, work the bills hard, represent my constituents, I'm conflicted. Also, Mr. Speaker, the division in this Legislature is very disheartening. I think it's pretty well known, by you and all of our colleagues, that I am one who is willing to work across the aisle. I am very consistently, lately, feeling as though Members who are not in my party hate me, which I did not feel before, Mr. Speaker. This is my fifth year serving, and I have not felt so much hate as I do now. Just because I belong to the Republican party. I'm not consulted on schedules in my Committee as I was in the 131st. Members on the other side of the aisle ask me to sign onto bills as the token Republican. Mr. Speaker, I'm not questioning motives of anybody in the Chamber, but I do know the difference between someone asking me because they genuinely think that I am interested and wanting to work for or against something, versus somebody wanting a Republican on a bill.

I'm just letting you know how I feel, Mr. Speaker. I'm very concerned with what this means for our great State, I'm feeling very disheartened and I don't know a way forward, Mr. Speaker. But I feel the real emergency is the division, the lack of working together and working another 1,000-plus bills; I don't even know the official number; with fiscal notes when we are already in the negative. Thank you, Mr. Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Hodgdon, Representative Quint.

Representative **QUINT**: Thank you, Mr. Speaker. I actually, within my Committee, have had the opposite relationship with the Members. Up until last Thursday, I felt as though I could trust the other side of the Body with everything that they said. I felt respected and heard, and we had good relationships.

That trust is broken because of that vote on Thursday. And that's extremely disappointing, because we're in the Tax Committee and we're dealing with finances in this State and people are losing their homes over taxes. We need to be working together, and there has been a division put up that is very great at the moment. And I truly hope that I will accept that

the Members on the other side can be taken at their word from this point forward, Mr. Speaker, because that word was broken on Thursday. And I do have a question to the Chair, please?

The **SPEAKER**: The Member may proceed.

Representative **QUINT**: On Thursday, our House Calendar said our adjournment date was June 18th, and I notice our new House Calendar has no adjournment date. Is it the intention of the Speaker for this session to go on past the statutory adjournment date now that a Special Session has been called and we have so many bills left to do, or are we going to honor what, quite frankly, constitutionally and historically, within this building, has been our statutory adjournment date?

The **SPEAKER**: The Chair would inform the Member and the Body that it's the intention to work as earnestly as possible to complete our work within the timeframe of the previous statutory adjournment that applied to the First Regular Session. I, in my own personal interest, have as much desire to get our work done on time as probably everyone else in this Chamber who has work and families and other things that obligate them outside of that timeframe.

The Member may proceed.

Representative **QUINT**: Thank you very much, and thank you for publicly stating that, because it is a concern for all in this Body. But I do want to point out that I am in agreement with the Good Representative who has put forward this motion. We said on Thursday; or I did not say that, Mr. Speaker, you said on Thursday; that we were done, and I would think that the Body that voted to be done on Thursday would also vote to be done today as well. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Carmel, Representative Thorne.

Representative **THORNE**: Thank you Mr. Speaker. I'd like to pose a question through the Chair.

The **SPEAKER**: The Member may proceed.

Representative **THORNE**: Mr. Speaker, are you aware, or anybody else in this room aware of any money that is available to fund bills with a fiscal note on this Session going forward?

The **SPEAKER**: The Representative from Carmel, Representative Thorne, has posed a question through the Chair to any Member who wishes to answer.

The **SPEAKER**: A roll call has been ordered. The pending question before the House is to Adjourn Without Day. All those in favor will vote yes, those opposed will vote no.

William E. Haggett, of West Bath. Mr. Haggett served three years in the United States Air Force as a radar controller before working for Brown Wales Steel Company in Cambridge, Massachusetts. He was then recruited by Bath Iron Works to be an assistant buyer in the purchasing department. This began a 28-year career with BIW, where he held many roles before becoming President and Chairman of the Board. During his time at BIW, 75 ships were delivered to the United States Navy. For his exemplary leadership in the maritime defense industry, he was awarded the Fleet Admiral Chester W. Nimitz Award, and he served on a presidential commission on the merchant marine and defense under Presidents Ronald Reagan and George H. W. Bush. Will changing the timeline of Maine Learning Results address the alarming test results of our Maine students' performance as compared to students around the country? A second one was, will changing the review schedule impact a positive change with the Department of Education in local districts being held accountable for implementation of the Maine Learning Results? A third consideration, will changing this timeline consider the impact of the Department of Education declaring DIE as a priority over academic standards such as reading, writing, math, science and social studies? And a fourth one, which comes from the Maine Education Policy Research

Institute, otherwise known as MEPRI; in the report, it states, quote, "the EPS model focuses first on student outcomes, (Maine Learning Results), and second, on the services and resources needed to achieve these outcomes." The EPS model "defines what is adequate in terms of resources and dollars to provide the education necessary for each child to have the opportunity to achieve Maine Learning Results." So, it reinforces the question and the concern about how this timeline change would address content concerns and accountability within the EPS formula.

For those reasons, I will be opposing this bill. Thank you.

The SPEAKER: The Chair recognizes the Representative from Dexter, Representative Foster.

Representative **FOSTER**: Thank you, Mr. Speaker. In the words of the lady from Auburn, this bill is critical to ensuring that Maine's energy policy is rooted in economic pragmatism and prioritizes the well-being of our residents over arbitrary government mandates. The existing statutory goals for renewable energy consumption have resulted in significant economic consequences for Maine households and businesses. The time has come to repeal these mandates and refocus our approach on affordability, reliability and free market principles. Mr. Speaker, Ladies and Gentlemen of the House, I ask that you follow my light and vote down the pending motion.

The SPEAKER: The Chair recognizes the Representative from Freeport, Representative Sachs.

Representative **SACHS**: Thank you, Mr. Speaker. I rise in support of the pending motion.

This bill proposes to eliminate Maine's renewable portfolio standard, which requires that a specific amount of the electricity sold to consumers comes from renewable resources. Twenty-nine states, Washington, D.C. and three territories have an RPS. Maine's RPS was amended and endorsed in the 129th by a bipartisan vote, not only of the EUT Committee but also of the Legislature, including a Member who had voted for it who serves in this Body, to increase Maine's total RPS requirement to 80% by 2030. I oppose the pending motion because I support their bipartisan work.

RPS portfolio standards exist, as I said, in those 29 states because they save ratepayers money through both rate suppression on both supply and distribution part of the bill, and they generate significant economic development. RPS targets

are also designed to reduce reliance on fossil fuels and are crucial for controlling those electricity costs in Maine. As we know, fossil fuel prices, including natural gas, of which our supply definitely demands, they're volatile and can lead to unpredictable spikes in electricity rates, especially in a State like Maine. Expanding renewable resources reduces that exposure to the market fluctuations and enhances our energy security by utilizing locally available resources. And the evidence, Mr. Speaker, demonstrates that RPS targets have done just that.

According to a 2024 analysis from the Governor's Energy Office, our State renewable resource investments have saved Maine ratepayers more than \$21 million per year by suppressing prices in regional electricity markets, by outcompeting more expensive resources like those fossil fuels. Data from the Maine PUC also shows that past renewable energy procurements have driven generation costs down, which also have lowered bills, including the sale of energy from those approved procurements, reduced delivery prices for CMP by 5.5% and Versant residential customers by up to 3.8% in 2022, while helping to offset those high storm recovery costs. RPS standards also create jobs and provide significant economic development benefits. Maine's RPS has resulted over \$100 million in direct investment, \$900 million in operations and maintenance spending, over 1,000 full-time-equivalent jobs and over \$1 billion in worker income between 2008 and 2022, according to, again, a 2024 report commissioned by the GEO. Maine's clean energy economy grew three times faster than its overall economy between 2016 and 2022, according to the Maine Clean Energy Industry Report.

I say all this because these are all identifiable benefits that are supported by data from multiple sources, Mr. Speaker. There was no evidence presented at the hearing that removing RPS and simply letting the free market reign will replace or enhance the more than \$2 billion of tangible economic benefits. I urge the Body to follow the data and support the pending motion. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Presque Isle, Representative Underwood.

Representative **UNDERWOOD**: Thank you, Mr. Speaker. Anything that's named climate change produces nothing for the economy of this State. It adds no value to any product anywhere, because; until it can stand on its own and produce from its own energy resources a living, and also, to add something to the State coffers; it is, excuse my expression, worthless. Thank you, Mr. Speaker.

Representative **TUELL**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House, I rise in opposition to the motion, and I do so for several reasons.

First, quote-unquote, "there exists in the State of Maine an extraordinary occasion arising out of the need to resolve many legislative matters pending at the time of the adjournment of the First Regular Session," the Chief Executive stated mere hours after we folded up our tent and adjourned without day. This matter before us now, LD 72, does not in any way, shape or means qualify as, quote-unquote, "an extraordinary occasion," in my book. Nor does, quote-unquote, "the public health, safety and welfare require;" again as the Chief Executive so eloquently stated in that same order; require "that it be resolved as soon as

possible." Yet, Mr. Speaker, here we find ourselves, days after adjourning and quickly being compelled back into session, to deal with a laundry list of serious issues; issues such as property tax relief, the housing crisis, State spending, soaring energy costs, caring for older Mainers, ensuring that our schools do not lose federal funding and helping that our State keep and retain quality workers, just to name a few. What should pop up onto our agenda today as one of the first items we're dealing with? LD 72, a bill to designate the spring peeper as the State amphibian.

The first day of a special session, and one of the first things we're dealing with is picking a State amphibian. And in a few minutes, we'll be debating whether to approve a State reptile. While I'm well aware I cannot speak to that issue, there is an overarching issue that I can speak to. We are wasting taxpayers' money picking amphibians and reptiles and dogs and songs when we have thousands of truly important, burning issues before us that somebody felt could improve the quality of life of their constituents.

We will have many principled debates, much back-and-forth this session, but I can imagine the following conversation playing out in a grocery store or a coffee shop in each of our 151 districts. Constituent: "So, how'd you spend your first day back?" Representative: "We picked the State amphibian." "You picked a State frog, seriously?" "Well, the spring peeper is a symbol of Maine, and it is spring." "Have you looked out the window lately?" "So isn't the Fisher plow, why don't you put that one on the books?" "Never mind, my property tax bill is going through the roof, and all you did was vote on a State frog." That, Mr. Speaker, will be the conversation around kitchen tables, in supermarkets, coffee shops, on talk radio, social media from Kittery to Calais and from Madawaska to Machias tonight.

And that, Mr. Speaker, is why we should reject the motion before us, move on to another and spend our time debating the issues which are in keeping with the spirit of the Chief Executive's Proclamation. I encourage you to follow the advice of one Kermit the Frog, who thinks it could be nicer being red. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Westbrook, Representative Salisbury.

Representative **SALISBURY**: Thank you, Mr. Speaker. Mr. Speaker, I agree that we have a lot of bills that are in front of us in our special session that will rise to the level of seriousness that perhaps this one doesn't, but I would like to offer some compelling reason to support this.

This is some testimony that was provided to our Committee from Rita Scott, a fourth-grade student at Asa Adams Elementary School in Orono: "I am here in support of LD 72 proposing the spring peeper as our State amphibian. I love spring peepers. In my opinion, they are the best type of frog. When they start peeping, it means winter is finally over. We can play outside without snow gear and school will be over soon. They're like tiny alarms that tell you when spring has sprung, plus they're very important for our forest because they eat bugs, insects, and snails. Spring peepers are important to the health of our wetlands and forests. They remind us of the delicate balance of our natural world. Spring peepers peep because it's their mating call. If we don't hear the peepers, that means the balance of their habitat is off. Every spring, I eagerly anticipate their return, a sure sign that warmer days are ahead. I enjoy walking my dog on the little path my family calls lupine lane. In the warm weather, it's blooming with life. There are snails and frogs galore, and the air is filled with the enchanting chorus of spring peepers. I love to try and catch the peepers, but they're

really fast. It's so much fun to listen to them all peeping together. It sounds like a tiny orchestra."

I just want to point out, Mr. Speaker, that this bill has no fiscal note, and the only requirement would be that our State of Maine website would just be updated to show that the spring peeper is our State amphibian. Thank you.

The SPEAKER: The Chair recognizes the Representative from Hodgdon, Representative Quint.

Representative **QUINT**: Yes, Mr. Speaker. I just have a question. So, when we're giving speeches on the House Floor, it is acceptable to list a child and, like, where they're from and that sort of information, that is okay?

Representative **THORNE**: Thank you, Mr. Speaker. I request permission to speak on the record.

The SPEAKER: The Representative from Carmel, Representative Thorne has requested unanimous consent to address the House on the record. Hearing no objection, it is so ordered. The Member may proceed.

Representative **THORNE**: Thank you, Mr. Speaker. Today, we honor the courage, sacrifice and indomitable spirit of the brave men and women who have received the highest military decoration our nation can bestow, the Medal of Honor.

It is with deep gratitude and respect that we observe National Medal of Honor Day.

Since its creation during the Civil War in 1861 to honor six brave soldiers on the battlefield during the Civil War, more than 3,500 men and women have earned the Medal of Honor, including 66 from here in our great State of Maine. Each one has a story that resonates with the very best of who we are as a people. From the battlefields of the Civil War to the mountains of Afghanistan, Medal of Honor recipients have shown unparalleled bravery in the face of overwhelming odds.

On the National Medal of Honor Day, we remember the sacrifice and bravery of those who have worn the uniform and have gone above and beyond the call of duty. We also reflect on the sacrifices of their families, who bear the heavy weight of their loved ones' service. These families, too, deserve our deep respect, admiration, and recognition. Their support and love are crucial to the strength and resilience of our military. To the Medal of Honor recipients and all the men and women who serve in our armed forces, we owe you an indomitable debt of gratitude. You inspire us all and we promise to continue to support you, honor your sacrifices and stand united in defense of the principles that make our nation great. May God bless the State of Maine, and may God bless the United States of America. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from St. George, Representative Matlack, who wishes to address the House on the record.

Representative **MATLACK**: Thank you, Mr. Speaker. In reference to the Representative from Carmel's words just now, I would ask that he also include those who have now been deleted from that website under the new DEI rules, where Black generals are no longer considered Medal of Honor winners and other people of color and women are being deleted because they don't align with the white male figure that apparently has come to represent the United States. Thank you.

The SPEAKER: The Chair recognizes the Representative from Winter Harbor, Representative Faulkingham.

Representative **FAULKINGHAM**: Thank you, Mr. Speaker. Permission to speak on the record?

The SPEAKER: The Representative from Winter Harbor, Representative Faulkingham, has requested unanimous consent to speak on the record. Hearing no objection, it is so ordered. The Member may proceed.

Representative **FAULKINGHAM**: Thank you, Mr. Speaker. Mr. Speaker, "Master Sergeant Gary Gordon, United States Army, distinguished himself by action above and beyond the call of duty on 3 October 1993, while serving as a Sniper Team Leader, United States Army Special Operations Command with Task Force Ranger in Mogadishu, Somalia. Master Sergeant Gordon's sniper team provided precision fires from the lead helicopter during an assault, and at two helicopter crash sites, while subjected to intense automatic weapons and rocket propelled grenade fires. When Master Sergeant Gordon learned that ground forces were not immediately available to secure the crash site, he and another sniper unhesitatingly volunteered to be inserted to protect the four critically wounded personnel, despite being well aware of the growing number of enemy personnel closing in on the site. After his third request to be inserted, Master Sergeant Gordon received permission to perform his volunteer mission. When debris and enemy ground fires at the crash site caused him to abort the first attempt, Master Sergeant Gordon was inserted 100 meters south of the crash site. Equipped with only his sniper rifle and pistol, Master Sergeant Gordon and his fellow sniper, while under intense small arms fire from the enemy, fought their way through a

dense maze of shanties and shacks to reach the critically injured crew members. Master Sergeant Gordon immediately pulled the pilot and other crew members from the aircraft, establishing a perimeter which placed him and his fellow sniper in the most vulnerable position. Master Sergeant Gordon used his long range rifle and side arm to kill an undetermined number of attackers until he depleted his ammunition. Master Sergeant Gordon then went back to the wreckage, recovering some of the crew's weapons and ammunition. Despite the fact that he was critically low on ammunition he provided some of it to the dazed pilot and then radioed for help. Master Sergeant Gordon continued to travel the perimeter, protecting the downed crew. After his team member was fatally wounded, and his own rifle ammunition exhausted, Master Sergeant Gordon returned to the wreckage, recovering a rifle with the last five rounds of ammunition and gave it to the pilot with the words, 'good luck.' Then, armed only with his pistol, Master Sergeant Gordon continued to fight until he was fatally wounded. His actions saved the pilot's life. Master Sergeant Gordon's extraordinary heroism and devotion to duty were in keeping with the highest standards of the military service and reflect great credit on him, his unit and the United States Army."

That is the Medal of Honor citation of Gary Gordon of Lincoln, Maine. And yes, amen to men like that, brave men that keep our country free. And on National Medal of Honor Day, Mr. Speaker, of all days, I would hope that we can keep it solemn and not political and honor those men. Thank you, Mr. Speaker.
