Mr. Littlefield of Belfast, presented a petition of George E. Johnson and others to increase the salary of treasurer of Waldo county, and moved its reference to the Waldo county delegation.

On motion of Mr. Talbot of Lewiston, the petition was laid on the table.

The order passed by the House on Jan. 14th, passed by the Senate in concurrence on Jan. 15, creating a joint special committee to whom shall be referred all petitions, bills, orders and other papers especially relating to salaries, was taken up. The Senate have named upon that committee Engel of Penobscot, Clason of Kennebec, and Hinckley of Franklin. The Speaker appointed on the part of the House Messrs. Hutchins of Penobscot, 10ung of Hiram, Plummer of Lisbon, Wilson of Gorham, Burton of Union, Chatto of Brooksville, and Ames of Jefferson.

On motion of Mr. Talbot of Lewiston, the petition of George E. Johnson and others to increase the salary of the treasurer of Waldo county, was taken from the table.

On further motion by the same gentleman it was then referred to the committee upon salaries just appointed.

On motion of Mr. Talbot of Lewiston, Ordered, that the use of Representative hall be granted to Mr. E. C. Swett of Portland, on Tuesday evening, Jan. 26, '97, for his new illustrated lecture entitled "Picturesque Maine." On motion of Mr. Houghton of Fort Fairfield,

Ordered, That the committee on legal affairs be instructed to inquire into the expediency of amending the insolvent law so that no discharge shall be granted except in cases where a dividend is paid.

On motion of Mr. Durgin of Orono, Ordered, That the use of Representative hall be granted the committee on inland fisheries and game for a public hearing, Tuesday afternoon, Feb. 2.

On motion of Mr. Austin of Milford, Ordered, That the State librarian be and hereby is authorized to furnish each member of the House with one copy of "Reed's Rules."

REPORT OF COMMITTEES.

Mr. Durgin from the committee on inland fisheries and game, to which was referred an order of the Legislature relating to reimbursing of citizens of the State who may have crops injured by deer, reported legislation thereon inexpedient.

Mr. Durgin from the same committee, on petition of O. D. Lombard and by deer, reported legislation thereon Stetson pond from December 1 to May 1, reported petitioners have leave to withdraw for the reason that the matter contained in the petition can properly be acted on by the commissioners of inland fisheries and game under the general laws of the State.
