Senate Document No. 21. An act to authorize the county of Androscoggin to make a loan and issue bonds therefor, was read.

Mr. Savage of Androscoggin stated that he desired to correct a clerical error in the bill at this time, and on his motion the rules were suspended and the following amendment adopted.

Amend Senate Document No. 21 by striking out the word "reimbursed" in line 16 and insert in lieu thereof the word "repaid."

The bill as amended was assigned for its second reading Friday morning.

Senate Document No. 22. An act to amend section 17 of chapter 60 of the Revised Statutes relating to change

of name in divorce proceedings.

Senate Document No. 23. An act to amend section 1 of chapter 121 of the Revised Statutes relating to forgery.

An act additional to and amendatory of chapter 634 of the Private and Special Laws of 1893 as amended by chapter 50 of the Private and Special Laws of 1895, related to the Hampden and Winterport Electric Railway and Light Company.

An act to amend an act establishing a municipal court in the town of Waterville.

On motion by Mr. Clason of Kennebec, the Senate adjourned.

#### STATE PRISON.

By Mr. Burton of Union—Petition of W. S. Carver and 39 others of Vinalhaven, asking for such enactment as will lead to the establishment of a reformatory prison for women.

#### TEMPERANCE.

By Mr. Pattangall of Machias—Bill an act to regulate the purchase and sale of intoxicating liquors by cities and towns.

#### TAXATION.

By Mr. Weeks of Fairfield—Bill an act to amend chapter 65, of the Public Laws of 1895, entitled an act in relation to State taxes on organized plantations taxed by the State as wild lands.

#### ORDERS.

On motion of Mr. Noble of Lewiston, Ordered, That, the Senate concurring, the time for the reception of petitions and bills for private and special legislation be extended until Monday, February 15, 1897, and that all petitions and bills presented after that date be referred to the next Legislature.

#### REPORT OF COMMITTEES.

Mr. Walton from the committee on legal affairs, reported ought to pass on bill an act to amend section 31, chapter 83, of the Revised Statutes, relating to

unpaid executions issued by deceased trial justices. Printed under rule.

Mr. Floyd from the Penobscot county delegation, reported ought to pass on bill an act to legalize the doings of the county commissioners of Penobscot county in making temporary loans, and to authorize said county to borrow money and issue bonds. Printed under rule

Mr. Blanchard from the committee on education, reported ought to pass on resolve in favor of the town of Jefferson. Printed under rule.

The committee of Hancock county members of the Legislature, which was instructed by an order of the Legislature to inquire into the expediency of changing the general term of the court of county commissioners so as to conform in time with the general term of the supreme judicial court, reported bill an act to amend section 6, of chapter 78, of the Revised Statutes, relating to the general term of the county commissioners' court of Hancock county, and that the same ought to pass. Printed under rule.

Mr. Spear from the committee on railroads, telegraphs and expresses, reported ought to pass on bill an act relating to the expenditure of the railroad commissioners. Printed under rule.

#### READ AND ASSIGNED.

An act to repeal section 42, chapter 140, of the Revised Statutes, relating to resentencing convicts sentenced to the State prison.

An act to change the name of the Sanford Agricultural and Mechanical Association.

Resolve making an appropriation to cover deficiency for cattle killed on account of tuberculosis for the year 1896.

Resolve in favor of the town of Brunswick.

Resolve in favor of aid in building highway bridge across the Mattawamkeag river at Kingman.

An act to fix the term of office of the police officers of the city of Auburn.

An act to empower the Portland Elevator Company to lay a railroad track, lease its franchise, and for other purposes.

An act to legalize the lease of the Old

Town Street Railway Company.

An act to amend chapter 136, of the Public Laws of 1895, relating to contributions by husbands and fathers to the support of wives and children.

An act in relation to the bonds of trustees and guardians.
