Mr. Hamilton from the committee on the judiciary, on bill an act to amend section (blank) of chapter 121 of the Revised Statutes in relation to forgery and counterfeiting, reported ought not to pass for the reason that the same matter has been previously acted upon by the said committee.

Mr. Davis from the committee on inland fisheries and game reported ought not to pass on bill an act to repeal chapter 101 of the Private and Special Laws of 1857.

Mr. Smith from the same committee, on petitions praying for a close time for three years on all brooks that flow through the town of Albion in Kennebec county, reported that the petitioners have leave to withdraw, for the reason that the matter comes within the jurisdiction of the fish and game commissioners.

Mr. Staples from the same committee, on petition praying that the present law relating to the taking of smelts in Swan lake be repealed, reported leave to withdraw.

Mr. Staples from the same committee, on petition praying that the law

relating to close time on trout and salmon in Swan lake be extended to October 15th, reported leave to withdraw.

Mr. Blanchard from the committee on education, on bill an act to incorporate the Staples academy, reported that the same be referred to the committee on legal affairs.

Mr. Blanchard from the same committee, on petition of the city of Rockland, reported resolve providing for the payment to the city of Rockland the amount deducted from said city's proportion of the school fund for 1896 on account of an imperfect school return. Printed under rule.

Mr. Williams from the committee on financial affairs, reported ought to pass on bill an act to provide in part for the expenditures of government. Printed under rule.

Mr. Maxey from the committee on banks and banking, reported ought to pass on bill an act to amend the charter of the Maine Trust and Banking Co. Printed under rule.

An act additional to the act of 1868, chapter 453, to establish a ferry across the Penobscot river between Ayer's falls and Marsh rips, as amended by act of 1880, chapter 221.

An act relating to the expenditures of the railroad commissioners.

An act to amend section 6, chapter 78, Revised Statutes, relating to the general term of the county commissioners' court of Hancock county.
