#### COMMITTEE REPORTS.

Mr. Merrill for the committee on agriculture reported resolve of Somerset County Grange in favor of the cash versus the labor system for repairing highways, that the same be referred to the committee on judiciary. Report accepted and resolve referred.

# PASSED TO BE ENGROSSED.

An act relating to a branch railroad track in Ashland and Sheridan plantation.

# PASSED TO BE ENACTED.

An act to amend chapter 136 of the Public Laws of 1895, relating to contributions by husbands and fathers to the support of wives and children.

An act to legalize the lease of the Old Town Street Railway Company.

An act to extend the charter of the Maine Live Stock Insurance Company.

An act to amend an act establishing a municipa! court in the town of Waterville.

An act in addition to and to amend chapter 634 of the Private and Special Laws of 1893, as amended by chapter 50 of the Private and Special Laws of 1895, relating to the Hampden and Winterport Electric Railway and Light Company.

An act to amend section 11 of chapter 224 of the Private and Special Laws of 1849, relating to the Augusta municipal court.

An act to repeal chapter 503 of the Frivate and Special Laws of 1828 to regulate the taking of fish in Narraguagus river.

An act to empower the Portland Elevator Company to lay a railroad track and lease its franchise, and other purposes.

#### ORDERS OF THE DAY.

On motion by Mr. Chamberlain of Lincoln, Senate document No. 31, an act to provide for the preservation of deeds now in Lincoln county relating to land in Kennebec county in Kennebec Registry, was taken from the table and given its first reading.

Mr. Clason of Kennebec, moved to amend by striking out section 4 of said bill. The amendment was adopted and the bill as amended assigned for its second reading tomorrow.

On motion by Mr. Parsons of Piscataquis, Senate document No. 24, a communication from the committee appointed under resolve of 1895 relating to rates and price of board at the Insane hospital, was taken from the table and referred to the committee on Insane hospital.

# ORDERS.

On motion of Mr. Stetson of Bangor, Ordered, That Wednesday, February 10, 1897, after 11 o'clock, be set apart for the delivery of eulogies upon the late Ex-Governor Daniel F. Davis.

On motion of Mr. Hutchins of Penobscot,

Ordered, That the committee on education be instructed to inquire into the expediency of so amending our school laws that towns may have the power to elect a school supervisor or superintendent and invest him with the authority to employ, examine and certificate teachers and and inspect and manage schools and furnish school supplies, and with the advise of the committee as for reasons now set forth in the statutes, discharge teachers and suspend or expel disorderly pupils.

On motion of Mr. Wheeler of Gilead,

Ordered, That the committee on the judiciary inquire into the expediency of so amending that portion of section 38 of chapter 6 of the Revised Statutes, relating to poll taxes, as to establish a uniform rate of poll taxes throughout the State, and report by bill or otherwise.

# PASSED TO BE ENGROSSED.

An act to authorize the county of Androscoggin to make a loan and issue bonds therefor.

This bill was amended in the Senate by Amendment A, striking out the word "reimburse," in line 16, and inserting the word "repaid." The amendment was adopted and the bill was passed to be engrossed as amended in concurrence.

An act to amend section 1, chapter 121, Revised Statutes, relating to forgery.

An act to correct a clerical error in chapter 61 of the Public Laws of 1891, relating to migratory fish.

An act to provide for filling vacancies in the board of directors in the Maine General Hospital.

An act to amend section 17, chapter 60, Revised Statutes, relating to change of name in divorce proceedings.

An act to legalize the doings of the county commissioners of Penobscot county in making temporary loans, and to authorize said county to borrow money and issue bonds.

An act to amend the charter of the Maine Trust and Banking Company.

An act to provide in part for the expenditures of government.

On motion of Mr. Talbot of Lewiston, this act was laid on the table.

#### PASSED TO BE ENACTED.

An act to fix the term of office of the police officers of the city of Auburn.

On motion of Mr. Maxwell of Richmond,

Adjourned.
