Mr. Macomber of Augusta: The resolve under consideration has been before the House for nearly two weeks, and it has been on the table so that every gentleman has had ample opportunity, as it seems to me, to examine the conditions and everything connected with the proposition for the further building of this hospital at Bangor. I can see no advantage, no good, that can be subserved by further delay in this matter. A large number of members of this House have already visited Bangor, they have seen the condition of those buildings, and it seems to me that it is for the interests of all concerned that we should do something right away; and I move that when the question of laying the amendment and bill on the table is voted upon, it be by the yeas and nays.

The yeas and nays were ordered.

Mr. Walton of Skowhegan: I ask unanimous consent to address the House at the present time. On the 22d day of January, I introduced in this House an order which received a passage, calling for certain lists to be provided by the clerk, showing, first, the amount of money which had been appropriated by any measures introduced in this House; second, all measures which had been favorably reported by any committee; third, the amounts called for by measures introduced; and, fourth, the amounts appropriated by the last Legislature. This report was to be made each Wednesday morning. It was to take effect on the 3d day of February. Three weeks have passed. On the 3d day of February quest of the clerk of this House, I introduced an order which was joint in its purport, calling upon the secretaries of Mr. Walton of Skowhegan: I ask unantroduced an order which was joint in its purport, calling upon the secretaries of the various committees to furnish a list of the amounts called for in measures then penuing before their committees. It has been two weeks since that order received a passage. Yesterday, we received a statement of facts in regard to the Eastern Maine Insane hospital. This morning, the gentleman from Biddeford has presented an amendment. I submit, Mr. Speaker and gentlemen, that no harm can arise from this matter lying on the table. We have already passed measures which are pending before the Senate, and which have not received a passage, which they are now considering. I are, which they are now considering. I submit, also, that nothing will be gained by acting upon this measure at the present time. I will state also that I desire to submit an amendment to this resolve. by acting upon this measure at the present time. I will state also that I desire to submit an amendment to this resolve. I could not do it until we received the statement of facts which has been presented. I therefore ask that this matter lie upon the table; and I submit, further, that in the matter of appropriations it is necessary that we should go carefully. I am a new member in this House, I do not understand, perhaps, so well as some of the old members, how to ascertain in regard to the facts of these various matters which are submitted to various committees and reported favorably. We do not have one general committee on appropriations to hear all the matters and then report. We have various committees who receive evidence and who report favorably upon a vast number of measures, and we are called upon to decide whether we shall vote against the appropriation suggested by one committee or another. We cannot, gentlemen, pass them all, that is certain; and I ask, in the interests of true economy, that this matter shall lie upon the table. The question being on the motion of the gentleman from Skowhegan, Mr. Walton, to lay the resolve upon the table with the proposed amendment, the yeas and nays were called and the motion was adopted by a vote of 85 for to 49 against.
