Mr. Merrill offered an amendment, to strike out in section 3, the figure "3," after the word "section," and insert in place thereof the figure "4": insert a new section as follows: "Section 3. The provisions of this act shall not apply to cities."

was read a third time and was passed to be engrossed as amended.
On motion of Mr. Hamilton of Biddeford, the order fixing the tax rate for 1897 and 1898 was taken from the table.
The order then received a passage.
On motion of Mr. Blanchard of Wilton, the order relating to the election of railroad commissioners was taken from the table.

In Senate this order was amended by striking out the words, "committee on legal affairs," and inserting the words. "committee on railroads, telegraphs and expresses."

The question being on the adoption of the Senate amendment,

Mr. Wilson of Gorham: It is not generally known to the people of the State what the circumstances are as regards the railroad commissioners. It is underwhat the circumstances are as regards the railroad commissioners. It is understood that we have a railroad commission appointed by the Governor. It is thought that we have a railroad commission for whose service the State pays. But the commissioners are not paid by the State. They are paid in full by the railroads. It is not fully understood that we have no appeal from them. Their decision is final. We are here to represent the people of the State, and not steam railroads. We are here to look after the interests of our constituents and the welfare of the people at large, and, today, these conditions now existing must be changed in order that our people may have justice done them at the hands of our railroad commissioners. They must be elected by the compensation for their services direct from the State, and the State not be reimbursed by the railroads, as it is now. There is no man on the face of the earth but who will act for the interests of those from whom he receives his pay. It is but natural and just that they

should. When the railroads pull the string on these railroad commissioners, they dance, and they dance strong and they dance long, as many of us are fully aware. Now when we elect our railroad commissioners and they receive their pay from the State and there is an appeal from their decision, there will not go through so much railroad law as in the past. I beg to insist on the passage of the order, and move that the House insist on its action.
