SENATE.

Friday, Jan. 15, 1897.

Senate met according to adjournment and was called to order by the President.

Prayer by Rev. Mr. Cummings of Augusta.

Journal read and approved.

Papers from the House disposed of in concurrence.

On motion by Mr. Savage of Androscoggin, the Senate non-concurred with the House in its reference of the following petitions to the Kennebec county delegation and referred the same to the committee on inland fisheries and game.

By Mr. Williams of Augusta—Petition of Gen. W.S. Choate, Hon. Howard Owen, and 28 others of Augusta, praying for an appropriation sufficient to operate the Monmouth fish hatchery and feeding station and to pay for two wardens in Kennebec county, for the years 1897 and 1898; petition of Nathaniel W. Cole and 31 others for same; petition of James E. Kingsley and 32 others for same; petition of E. W. Whitehouse and 31 others for same; petition of Charles B. White and 32 others of Augusta for same.

By Mr. Golder of Belgrade—Petition of Charles B. Austin and 34 others of Belgrade for same; petition of Ronald C. McIlroy and 32 others of Winthrop for same.

By Mr. Searles of Chelsea—Petition of Hon. M. L. Rollins and Hon. James E. Blanchard and 12 others of Chelsea for same; petition of W. W. Washburn and 24 others of China for same; petition of A. A. Sampson and 26 others of Chelsea for same.

Ordered, That a joint special committee of three on the part of the Senate with such as the House may join be appointed, to which shall be referred all matters relating to the Eastern Maine Insane Hospital at Bangor.

The Chair appointed as such committee on the part of the Senate, Messrs. Weeks of Penobscot, Billings of Waldo and Maxwell of Androscoggin.

Subsequently this order came back from the House passed in concurrence and with the following joined on the part of the House, Messrs. Palmer of Bangor, Rodick of Eden, Macomber of Augusta, Murchie of Calais, Austin of Milford, Shepard of Buxton, and Fernald of Poland.

Upon motion by Mr. Stearns of Aroostook, it was

Ordered, that a joint select committee of three on the part of the Senate, with such as the House may join, be appointed to consider the Governor's message and report a reference of its several subjects to appropriate committees.

The Chair appointed as such committee on the part of the Senate, Messrs. Stearns of Aroostook, Engel of Penobscot and Reynolds of Cumberland.

Subsequently this order came back from the House passed in concurrence and with the following joined on the part of the House, Messrs. Murray of Pembroke, Winslow of Portland, Saunders of Ellsworth, Starbird of Litchfield, Rounds of Paris, Golder of Belgrade and Goodrich of Maxfield.

Upon motion by Mr. Clason of Kennebec, it was

Ordered, the House concurring, that the committees on reform school State prison, insane hospital, education, agriculture, military affairs and State college of agriculture and mechanic arts be authorized to visit the various institutions which they represent.

On motion of Mr. Roberts of Oxford, it was

Ordered, the House concurring, that the State library shall be held open from 8 o'clock A. M. to 6 o'clock P. M., and from 7 o'clock P. M. to 10 o'clock P. M., on each day when the Legislature is in session, and that the State librarian may employ one person in addition to his regular assistants to enable him to carry out this order, whose compensation shall be \$150.

On motion by Mr. Chamberlain of Lincoln, it was

Ordered, that a joint select committee of three on the part of the Senate, with such as the House may join, be appointed to receive proposals from the publishers of the Maine State Year Book for furnishing the State with a sufficient number of copies for the years 1897 and 1898.

The chair appointed as such committee on the part of the Senate, Messrs. Chamberlain of Lincoln, Parsons of Piscataquis and Ferguson of Sagadahoc.

Subsequently this order came back from the House passed in concurrence and with the following joined on the part of the House, Messrs. Floyd of Brewer, Maxcy of Gardiner, Durgin of Orono, Davis of Steuben, Ayer of Vassalboro, Currier of Farmington, Day of Turner.

On motion by Mr. Drummond of Cumberland, it was

Ordered, the House concurring, that when the Senate and House adjourn, they adjourn to meet on Monday afternoon next, at 4.30 o'clock.

Subsequently this order came back from the House passed in concurrence.

On motion by Mr. Savage of Androscoggin, the vote of yesterday was reconsidered whereby the following petitions were referred to the Kennebec county delegation, and they were reported to the committee on inland fisheries and game.

By Mr. Clason of Kennebec—Petition of Hon. P. O. Vickery and Thomas Leigh, Esq., and 34 others of Augusta praying for appropriations sufficient to operate Monmouth fish hatchery and feeding station and to pay for two wardens in Kennebec county for the years 1897 and 1898; petition of Oscar Holway and 26 others of Augusta for the same.

By Mr. Reynolds of Kennebec—Petition of Hon. J. H. Manley and 34 others of Augusta, for the same; also petition of John F. Hill and 34 others for the same; also petition of Edwin C. Burleigh and 31 others of Augusta, for the same; also, petition of Hon. J. Manchester Haynes and 30 others of Augusta, for the same.

Upon motion by Mr. Clason of Kennebec, Senate document No. 4, communication from the secretary of State in

reference to the secret ballot, was taken from the table and referred to the committee on legal affairs.

Upon motion by Mr. Savage of Androscoggin, Senate document No. 3, being report of commissioners relating to promotion of legislation in the United States, was taken from the table and referred to the committee on judiciary.

Upon motion by Mr. Savage of Androscoggin, the Senate adjourned.
