SENATE.

Wednesday, Jan. 27, 1897.

The Senate met according to adjournment and was called to order by the President.

Prayer by Rev. Mr. Chase of Eallowell.

Journal of yesterday read and approved.

Papers from the House disposed of in concurrence.

An act authorizing the United Indurated Fiber Co. of New Jersey, to generate and supply compressed water and electric power with the several petitions in favor of the same, came from the House referred to the committee on railroads, telegraph and expresses.

On motion by Mr. Clason of Kennebec, the Senate non-concurred with the House in its reference and referred the matters to the committee on judiciary.

A communication was received from the secretary of State, transmitting the report of the commissioners on sea and shore fisheries and the same was referred to the committee on shore fisheries.

REPORT OF COMMITTEES.

The committee on judiciary to which was refered bill, an act relating to the charter of the Damariscotta and Newcastle Railroad Company, reported that the same be referred to the committee on railroads, telegraphs and expresses. The report was accepted and bill referred.

The committee on judiciary to which was referred bill, an act to amend section 1, chapter 121 of the Revised Statutes, relating to forgery, reported that the same ought to pass. Mr. Savage for the committee. The report was accepted and tabled for printing.

The committee on judiciary to which was referred bill, an act for filling vacancies in the board of directors in the Maine General Hospital, reported that the same ought to pass. Mr. Drummond for the committee. Report accepted and tabled for printing.

The committee on shore fisheries, to which was referred bill, an act to amend chapter 61 of the Public Laws of 1891, relating to migratory fish, reported the same in new draft under title of "An act to correct a clerical eror in chapter 61 of the Public Laws of 1891" and the same ought to pass. Mr. Wyman for committee. Report accepted and tabled for printing.

The Androscogging delegation to which was referred bill, an act to authorize the county of Androscoggin to make a loan and to issue bonds therefor, reported that the same ought to pass. Mr. Savage for the delegation. Report accepted and tabled for printing.
