Monday, March 22, 1897. The Senate met according to adjournment and was called to order by the President.

This bill came up on its first reading, and on motion by Mr. Poor of Oxford, was laid on the table pending first read-

Bill an n act to incorporate the West-Windham & Harrison Railway brook, Windham & Harrison Ranway Co., and to authorize municipalities in Cumberland county to aid in the con-struction of its ranway. This bill came up on its first reading. Mr. McCullough of Washington, offered

Mr. McCullough of Washington, offered amendments A and B.

Amendment A. Amend section 13 by adding thereto the following: "Nothing herein contained shall be construed as granting to said Westbrook, Windham & Harrison Rainroad Co. the right to run over the tracks of the Portland Railroad Co. or to make extensions into terri-Co., or to make extensions into territory already occupied by the latter company, nor as granting to said last-named pany, nor as granting to said last-named company the right to run over the tracks of said Westbrook, Windham & Harrison Railroad Co., or to make extensions into the territory lying easterly or northeasterly of the Presumpscot river."

The same gentleman, for the same com-mittee, reported legislation inexpedient, on bill an act in reference to the chronic insane. Report accepted.

"Resolved, That for the purpose of continuing the work provided for by chapter 18, of the Resolves of 1895, and completing certain portions thereof, the Governor and Council are hereby discovered to take immediate asters to con-Governor and Council are hereby rected to take immediate steps to Governor and Council are hereby directed to take immediate steps to construct and complete in a manner to be fire-proof, upon the site named in said chapter, one pavilion for the accommodation of the insane of the State, and to complete, equip and furnish, so far as necessary, the buildings already commenced; and for that purpose the sum of \$75,000 is hereby appropriated, to be expended during the year 1897, and \$100,000, or so much thereof as may be necessary, during the year 1898, under the direction of the Governor and Council, as aforesaid. The Governor and Council, and perfect to superintend the work of construction. The above amount, \$175,000, is to complete, equip and furnish the buildings already begun, and to include one pavilion; and the total cost for all such buildings and furnishings, when completed and ready for occupancy, shall not exceed the amount of this appropriation."

On motion by Mr. Chamberlain of Lincoln, bill an act to prevent incompetent persons from conducting the business of apothecaries, was taken from the table. The bill was read once, and Mr. Chamberlain offered the following amendments, which he explained had been agreed to by all parties interested.

Senate amendment C. Amend by adding to section 6: "A permit may also be granted, upon written application to said

commissioners, to storekeepers in towns or villages where there is no apotnecary store, to sell the usual medicines and store, to sell the usual medicines and poisons used as home remedies, and for the necessary agricultural purposes and for such permit a fee of \$1 shall be charged, payable to said commissioners, and said storekeepers shall satisfy the commissioners of their fitness to keep and sell such medicines and poisons."

The amendments were severally adopted, and on motion by Mr. Savage, the rules were suspended, bill read the second time and passed to be engrossed.

Amend section 2, by striking out all of said section after the words "Montague" in line 39, and insert in lieu thereof the following: "Then said corporation may enforce said lien in the manner provided in sections 38 and 39, of chapter 91, of the Revised Statutes, for enforcing liens on logs and lumber."

The amendment was adopted and the The amendment was adopted and the bill passed to be engrossed as amended.

On motion by Mr. Roberts of Oxford, bill an act to amend section 3, of chapter 11, of the Revised Statutes, of 1883, as now amended, relating to discontinuing schools and conveying school children,

was taken from the table. House amendment "A" v was adopted in concurrence.

On motion by Mr. Roberts, the Senate non-concurred with the House in the non-concurred with the House in the adoption of House amendment "B."

On motion by Mr. Witham of Cumberland, the bill with amendments was laid on the table.

On motion by Mr. Clason of Kennebec, the report of the committee on sea and shore fisheries, reporting leave to with-draw on several petitions praying that no smelts be taken in the Kennebec river or its tributaries except with hook and line, was taken from the table and the report of the committee accepted in concurrence.

On motion by Mr. Savage, an act in regard to right of exceptions was taken from the table and indefinitely postponed.
