Nelson Dingley, I de-sire to offer the following order: When from some point of vantage we are permitted to look out over a mighty forest, we see scattered sparingly here and there a few trees towering above their fellows, like mighty rulers. So, here and there among their fellow men, occasionally there appears a great leader, command-ing the attention and respect, the confi-dence and devotion of markind dence and devotion of mankind.

Conspicuous among the distinguished men the State of Maine has produced, whose fame and field of action have not State or even of the nation, stands Nel-son Dingley. Honest, able, learned, pure in private and in public life, he has en-deared himself to the people and en-shrined himself in their confidence and affection.

As a token of respect to his memory and in response to that silent sorrow which oppresses us all at his death, it is

Ordered, That a committee consisting of the President of the Senate and two senators on the part of the Senate, with such members as may join on the part of the House, be appointed to attend the funeral at Lewiston, Wednesday, Jan. 18, at 10 o'clock A. M.; that the secretary transmit a copy of this order to the fam-ily, and that as a further mark of respect to the memory of the dead, the Senate stand adjourned.

The order was passed and the President appointed as such committee on the part of the Senate, Messrs. White of Andros-coggin and Hamlin of Hancock. Adjourned.

# ORDERS OF THE DAY.

The Speaker announced that he had appointed as a committee to attend the funeral of Hon. E. K. O'Brien of Thom-aston, who died during the recess of the House, Messrs. Brown of Warren, Teel of St. George, Hahn of Waldoboro, Wood of Camden, Kallock of South Thomaston, Peaslee of Wiscasset, and Ledyard of Dath Bath.

Mr. Macomber of Augusta, moved that the House proceed to ballot for a United States senator.

M., and that as a further mark of re-spect the Senate stand adjourned.

Mr. Harris of Auburn: Mr. Speaker, the State of Maine is indeed in the shadow of a great sorrow. We sit here with of a great sorrow. We sit here with bowed heads. A distinguished son of Maine, who, by his life, character and public services, has placed himself well in the front ranks of the men of his gen-eration, our own fellow-citizen, Nelson Dingley, is dead. It is not my purpose at this time to enter into any extended eulogy which may more fittingly be done at some other time. The order from the

Senate aptly expresses the sentiments of this House on this occasion. I therefore move its adoption in concurrence; and that the House join the Senate in ap-pointing a committee of seven, of whom the Speaker shall be chairman, to attend the funeral at Lewiston, tomorrow. The motion was agreed to.

The Speaker appointed on the part of the House, Messrs. Harris of Auburn, Manley of Augusta, Murphy of Lewiston, Brown of Falmouth, Hicks of Rockland, and Donham of Hebron.

The Speaker also appointed, as Speaker pro tem. during the absence of the Speaker, Mr. Philbrook of Waterville. Mr. Manley of Augusta: Mr. Speaker, the House has heard with profound sor-row of the death of Hon. Nelson Dingley. This is not the time to refer to his pure life or to his illustrious public services. And it seems to me to be eminently fitting that this should be done. For it was in this hall that he commenced his great legislative career. He was six times this hall that he commenced his great legislative career. He was six times elected a member of this House. He was twice its honored Speaker. He was twice elected Governor of this State. He was 10 times elected to that great parlia-mentary body, the national House of Rep-resentatives. His life has been given to his State and to his country. And by his upright life, his pure character, his un-tiring industry, he has won for himself immerishable fame, and he has added glory and honor to the State and the nation. And. Mr. Speaker, as a further mark of respect to his memory, I move that the House do now adjourn. The motion was agreed to.
