### HOUSE.

Monday, Jan. 23, 1899.

Papers from the Senate disposed of in concurrence.

On motion of Mr. Chase of Portland, the rules were suspended, the bill received its several readings at the present time and was passed to be engrossed.

On motion of Mr. Philbrook of Waterville, this order was laid on the table.

On motion of Mr. Gurnsey of Dover, Ordered, That the committee on legal affairs be directed to inquire into the expediency of revising the Public Laws of the State of Maine, and report a resolve relating thereto, or otherwise.

On motion of Mr. Manley of Augusta, this order was laid on the table.

Mr. Manley of Augusta: I gave notice the other day that I would introduce an order, which I now have here, and I desire to say that I have fixed the 15th of February in the order because that is the birthday of the late Mr. Dingley.

Ordered, The Senate concurring, that a committee, consisting of the Governor, President of the Senate and Speaker of the House, be appointed to arrange for suitable memorial exercises to be held in the House of Representatives on Wednesday, the 15th of February, that the Executive department and members of the Legislature may pay their tribute of respect to the memory of the late Nelson Dingley.

The order received a passage.

# ORDERS OF THE DAY.

On motion of Mr. Philbrook of Waterville, the House reconsidered the vote of Friday, whereby it concurred with the Senate in referring to the judiciary committee an act relating to the extension of the charter of the Franklin, Somerset & Kennebec Railway Co., and on further motion by the same gentleman, the House non-concurred with the Senate in its reference and referred the bill to the committee on railroads, telegraphs and expresses.

On motion of Mr. Smith of Presque Isle, the report of the secretary of State in relation to the expense of the Australian ballot law was taken from the table and referred to the judiciary committee.
