Wednesday, Jan. 25, 1899. Prayer by Rev. Mr. Phillips of North Augusta.

Papers from the Senate disposed of in concurrence.

#### SENATE BILLSREAD AND ASSIGNED.

Resolve for the purpose of operating fish hatcheries and feeding stations for fish and for the proper enforcement of the inland fish and game law.

An act to extend the charter of the Maine Charitable Mechanic Association.

An act to amend chapter 203, of the Public Laws of 1893, relating to the education of the deaf, dumb and blind.

Resolve to provide means for examination of claims for State pension.

On motion by Mr. Chase of Portland, the rules were suspended and bill, an act to change the name of Colby University, was taken up out of order, and on further motion by the same gentleman it was passed to be enacted.

#### ORDERS.

On motion of Mr. Kilborn of Bethel, Ordered, That the committee on judiciary inquire into the expediency of so amending the constitution that a citizen of the United States, not less than 30 years of age, who has been five years a resident of the State, may be eligible to the office of Governor, though he be not a natural born citizen of the United States.

On motion of Mr. Bird of Rockland,

Ordered, That the committee on railroads, telegraphs and expresses be requested to inquire into the expediency of so amending chapter 207, Private and Special Laws of 1895, and chapter 344, Private and Special Laws of 1897, so that the acts shall apply to present wants of company and report by bill or otherwise.

On motion of Mr. Guernsey of Dover, Ordered, The Senate concurring, that the committee on inland fisheries and game inquire into the expediency of requiring the county attorneys and sheriffs of the several counties to enforce the laws for the protection of game; the fines collected to go one half to the county attorneys and sheriffs and the other half to the counties, making such changes in the laws relating to game protection as

may be needed, and report by bill or otherwise.

On motion of Mr. Purington of Woolwich.

Ordered, That the committee on sea and shore fisheries be required to inquire into the necessity of amending the law pertaining to Nequasset stream in Woolwich and other towns in Sagadahoc county, and report by bill or otherwise.

On motion of Mr. McFadden of Dresden.

Ordered, That the State superintendent of schools be requested to furnish a detailed statement for the school year ending June 30, 1898, showing the number of free high schools; the whole amount paid by the State in aid of same; the amount raised by towns in aid of same, number of scholars registered and average attendance on same.

Also the number of academies or private institutions of learning receiving aid from the State; amount special appropriation for each, and amount received by them under the free high school act; amount of fund, if any, possessed by each, with the whole number of scholars, and average attendance of each; and that the same be printed and laid upon the desks of members.

On motion of Mr. Chick of Clifton,

Ordered, The Senate concurring, that a list of the committees of this Legislature together with the order of proceedings and rules of each branch and the joint rules be printed in pamphlet form, 300 copies for the use of the Senate and 600 copies for the use of the House.

On motion of Mr. Pierce of Blaine,

Ordered, That the State treasurer be and hereby is requested to furnish forth-with for the information of this House, a detailed statement of the State tax assessed against and paid by the electric street railway companies for the years 1895, 1896, 1897 and 1898.

#### REPORTS OF COMMITTEES.

Mr. Brown from the committee on military affairs, reported "leave to withdraw" on petition of 17th Maine Regiment Association and 3d Army Corps Union, for the erection of a monument to the memory of Major General Hiram G. Berry.

Report was accepted and sent to the Senate.

Mr. King from the committee on interior waters, reported "ought to pass" on bill "An act authorizing the construction of a wharf into the tide waters of Penobscot river in the town of Bucksport."

The report was accepted and bill ordered printed under joint rules.

#### PASSED TO BE ENGROSSED.

Resolve providing for the payment to the town of Jay the amount deducted from said town's proportion of the school fund for the year 1898 on account of an imperfect school return.

#### ORDERS OF THE DAY.

On motion of Mr. Philbrook of Waterville, the order instructing the committee on legal affairs to inquire into the expediency of creating the office of State auditor in accordance with the recommendations relating thereto contained in the inaugural address of Governor Powers, and report what legislation is necessary or otherwise, was taken from the table.

On motion of Mr. Guernsey of Dover, the order was withdrawn.

On motion of Mr. Hassell of Sebec, Adjourned.
