By Mr. Blanchard of Franklin—Bill an act to authorize the town of Kingfield to purchase the property and franchises of the Kingfield Water Co. and to incorporate the Kingfield water commissioners.

By Mr. Grindle of Hancock-Bill an act to incorporate the Bluehill and Bucksport Railroad Co.

TOWNS.

By Mr. McFaul of Machias—Petition of John U. Chandler and 20 others, nonresident tax-payers of Roque Bluffs, for annexation of Roque Island and adjacent island to the town of Roque Bluffs.

Petition of Foster M. Thompson and 31 others of Roque Bluffs, for same.

Ordered, That the committee on inland fisheries and game have the use of the Hall of Representatives for public hearings to be held February 1 and 22 at 2.30 P. M.

On motion of Mr. Morey of Lewiston,

Ordered, That the committee on legal affairs enquire into the expediency of amending the laws relating to tramps, and report by bill or otherwise.

On motion of Mr. Donham of Hebron.

Ordered, That the committe on judiciary be directed to inquire into the expediency of so amending the Public Statutes as to require contractors upon public or private works to indemnify municipalities in which they operate, for any expenses which said municipalities may necessarily incur by reason of non-resident laborers who have been employed by said contractors falling into distress in said municipalities on account of the non-payment of wages due them from such contractors.

REPORTS OF COMMITTEES.

Mr. Manley from the committee on the judiciary, reported ought not to pass on bill an act to establish a municipal court in the city of Eastport.

Mr. Philbrook from same committee, reported same on bill an act to establish the West Washington municipal court. The reports were accepted and sent to the Senate.

Mr. Philbrook from the committee on the judiciary, reported ought to pass on bill an act relating to the Waldo and Penobscot Agricultural Society.

Mr. Hurd from the committee on banks and banking, reported ought to pass on bill an act to incorporate the Maunfacturers Trust Company.

Mr. Macfarlane from the committee on inland fisheries and game, reported ought to pass on bill an act for the protection of fish in the west outlet of Moosehead lake.

The reports were accepted and bills ordered printed under joint rules.

Mr. Peabody from the committee on Indian affairs, reported ought to pass on resolves in favor of Thomas Bailey, representative of the Passamaquoddy Tribe of Indians.

The report was accepted and resolve ordered printed under joint rules.

Mr. Manley from the committee on the judiciary, reported ought to pass on bill an act to amend sections 2, 7 and 13, of chapter 180, of the Private and Special Laws of 1869, relating to parishes of the Protestant Episcopal church.

The report was accepted. On motion of Mr. Manley of Augusta, rules were suspended, bill read three times, and was passed to be engrossed.

PASSED TO BE ENGROSSED.

Bill an act to amend the charter of the Maine Charitable Mechanic Association.

Bill an act to amend chapter 203, of the Public Laws of 1893, relating to the education of the deaf, dumb and blind.

ORDERS OF THE DAY.

Bill an act to provide for the establishment and maintenance of free public libraries in cities and towns and for the purchase of books for the use of plantations out of the money raised and collected from the licensing of dogs.

Referred in the House, January 25, was called up and on motion of Mr. Guernsey of Dover, the vote whereby the bill was referred to the committee on library, was reconsidered and on motion of same gentleman the bill was tabled and ordered printed pending reference.
