ORDERS.

On motion of Mr. Leavitt of Eastport,

Ordered, That the committee on railroads, telegraphs and expresses inquire into the expediency of so changing the law relating to the organization of railroad corporations under the general lay that the hearing before the railroad commissioners as to public convenience of the proposed lines shall be had on presentation of the articles of association, rather than on the petition for approval of location as the order of procedure is now arranged.

REPORTS OF COMMITTEES.

Mr. Virgin from the committee on the judiciary, reported leave to withdraw on petition of John S. Harlow and others that stenographers be authorized to take evidence given before the grand jury.

Mr. Smith from same committee, reported ought to pass on bill an act to improve the condition of highways.

Mr. Peabody from the committee on interior waters, reported ought not to pass on bill an act entitled "an act to incorporate the Piscataquis River Improvement Company."

Mr. Brown from the committee on military affairs, on resolve in favor of Howard Whittier reported that same be referred to the committee on pensions.

The reports were accepted and sent to the Senate.

Mr. Philbrook from the committee on the judiciary, on bill an act to prevent the wearing of boots or shoes in hotels or other public places with spikes or spindles in the soles thereof, reported ought to pass in new draft bill an act to prevent the wearing of spike boots or shoes in public places.

Same gentleman from the same committee, reported ought to pass on bill an act to amend Chapter 154 of the Private and Special Laws of 1895, relating to the charter of the Wiscasset Water Company.

Mr. Merrill from same committee, reported same on bill an act to authorize the Skowhegan Electric Light Company to issue bonds.

Mr. Harris from same committee, reported same on bill an act to amend

Section 6 of Chapter 156 of the Public laws of 1895, entitled "An act to amend Section 6 of Chapter 35 of the Revised Statutes relating to intelligence offices."

Mr. Manley from same committee, reported ought to pass in new draft under same title bill "an act to incorporate the Brownville Water Company.

Mr. Morey from the committee on legal affairs, reported ought to pass on bill an act to amend Section 4 of Chapter 71 of the Revised Statutes relating to licenses to sell real estate.

Mr. Reed from the committee on intrior waters, reported ought to pass in new draft under same title bill an act to amend Chapter 491 of the Private Laws of the year 1893.

The reports were accepted and bills ordered printed under joint rules.
