PASSED TO BE ENGROSSED.

An act to incorporate the Manufacturers' Trust Co.

An act to authorize the Webster Woolen Co. to supply the village of Sabattus with water for municipal purposes.

PASSED TO BE ENACTED.

An act to amend sections 2, 7 and 13, chapter 180, Private and Special Laws of 1869, relating to parishes of the Protestant Episcopal church.

Thursday, Feb. 2, 1899.

Papers from the Senate disposed of in concurrence.

On motion of Mr. Wilson of Gorham, the following Senate order was laid on the table:

Ordered, That the trustees of the University of Maine be instructed to obtain for the benefit of the members of the Legislature the salary and perquisites received by the president, professors and instructors, and all other attaches, including clerks, stenographers and typewriters, and all others drawing compensation at the University of Maine, and the duties of each, and report the same as soon as practicable to the Legislature.

The order was passed.

Whereas, Chapter 30, of the Revised Statutes and the acts of every session of the Legislature since the revision of 1883, contain laws pertaining to inland fisheries and game, and whereas, chapter 40, of the Revised Statutes and the acts of the Legislature in every session passed since 1883, contain laws pertaining to inland fisheries and game, and sea and shore fisheries as well, all combined and intermingled, thereby creating much confusion, therefore be

Ordered, That the Senate concurring, that the committee on inland fisheries and game be directed to inquire into the expediency of consolidating into one chapter and revising and amending the laws Public, Private and Special pertaining to inland fisheries and game and report by bill or otherwise.

On motion of Mr. Philbrook of Waterville, this order was laid on the table. On motion of Mr. Bird of Rockland.

Ordered, The Senate concurring that the several joint standing committees be and are hereby instructed to make their final reports on or before March 3, 1899.

On motion of Mr. Virgin of Portland, Ordered, That the committee on judiciary inquire into the expediency of amending the law relative to the sale of real estate for non-payment of taxes, and report by bill or otherwise.

On motion of the same gentleman, Ordered, That the committee on judiciary inquire into the expediency of amending the law relating to the support of paupers so that any town in the State that has or may hereafter furnish pauper supplies to any person whose settlement has been or shall be made void by the action of the Legislature shall be reimbursed by the State upon pauper settlement, and report by bill or otherwise.

REPORTS OF COMMITTEES.

Mr. Hopkins from the committee on legal affairs, on bill an act to secure the secret ballot, reported that same be referred to the committee on judiciary.

Mr. Mcfarlane from the committee on inland fisheries and game, on bill an act providing for a State hunting license and to obtain revenue for the protection of moose, deer and caribou. reported that same be referred to the next Legislature.

Same gentleman from same committee, reported leave to withdraw on petition of L. M. Blanchard and 212 others in favor of electing fish game wardens.

Same gentleman from same commitreported same on petition of Charles L. Brown and others to be allowed to take and transport for sale white perch during the months of July and August from East Machias river, its lakes and tributaries.

Same gentleman from same committee, reported ought not to pass on bill an act to protect tern in the county of York.

Same gentleman from same committee, reported same on resolve to restock with smelts the brooks tributary to the Penobscot river between

north and south line of the town of and analysis of concentrated commer-Winterport.

Same gentleman from same committee, reportel legislation inexpedient on order to inquire into the expediency of requiring the county attorneys and sheriffs of the several counties to enforce the laws for the protection of game: the fines collected to go, onehalf to the county attorneys and sheriffs and the other half to the counties: making such changes in the laws relating to game protection as may needed, and report by bill or other-

Mr. Gentleman from same committee reported same on bill an act to amend Section 1 of Chapter 436 of the Special Laws of 1834 entitled "an act to incorporate the city of Bangor, approved Feb. 12th, 1834."

Mr. Morey from same committee, reported same on bill an act to amend Chapter 136 of the Public Laws of 1895.

Mr. Burns from the committee on financial affairs, on petition of E. B. Winslow and others, reported resolve in favor of the Home for Friendless Boys in Deering.

Mr. Drummey from the committee on railroads, telegraphs and expresses, reported ought to pass on bill an act to amend Chapter 207 of the Private and Special Laws of 1895 as amended by Chapter 344 of the Private and Special Laws of 1897, relating to the Rockland and Vinal Haven Telegraph and Telephone Company.

Mr. Bird from same committee, reported same on bill an act to amend Section 2 of Chapter 96 of the laws of the year 1887 providing for the extension of railroads.

Mr. Manley from the committee on financial affairs, reported ought to pass bil an act to provide in part for the expenditures of government for the year 1899.

The report was accepted. On motion of Mr. Manley of Augusta, rules were bill tabled and ordered suspended. printed.

Mr. McFadden from the committee on towns reported ought to pass bill an act to annex the city of Deering to the city of Portland.

On motion by Mr. Wilson of Gorham, the rules were suspended and the bill received its two readings at the present time.

On motion by Mr. Leavith of Eastport, the rules were suspended, the bill read the third time and was passed to be engrossed.

Mr. Farrell of Van Buren, moved that the bill be laid on the table pend-

Mr. Mcfarlane of Greenville, said: The purpose of this bill is simply to prevent the wilful and malicious destruction of property. The drivers, going into the woods, get into the public conveyances, a car for instance, and I have seen them take their feet and deliberately put them on the back of the car seat and rip the cushion from one end to the other. I have seen them go into a public house, where a new floor had been put down, and deliberately take a foot and scrape the entire surface, destroying the floor itself. This bill has not been introduced for the purpose of taking away any man's rights, but it was introduced for the purpose of protecting the rights of others. It is a simple matter and it seems to me that it ought to

ORDERS OF THE DAY.

(The Speaker in the chair). Mr. Virgin of Portland: The House, yesterday, voted to refer to the judiciary committee a large number of remonstrances against an increase of the salaries of the justices of the supreme

judicial court. I move that the vote be reconsidered.

The motion was agreed to.

Mr. Virgin: I simply wanted to give a reason for this. The judiciary committee reported the measure to the Senate, yesterday, as they now have no further jurisdiction over the matter, but it is proper that these remonstrances should be placed on file, and for that reason I made that motion, and I now move that these remonstrances be placed on file with other petitions or remonstrances referring to the same matter.
