On motion of Mr. Bird of Rockland, Ordered, That the committee on education be requested to inquire into the expediency of placing fire insurance upon the Normal school buildings of the State.

Mr. Merrill from the committee on judiciary, reported ought not to pass on bill an act to amend Section 2 of Chapter 142 of the Revised Statutes relating to minors.

The report was accepted and sent to the Senate.

Mr. Harman from the committee on shore fisheries, reported ought to pass in new draft under same title bill an act to amend Chapter 285 of the Public Laws of 1897.

Mr. McFaul from the Washington county delegation, on petition reported bill an act to change time for holding sessions of county commissioners in Washington county.

The reports were accepted and bills ordered printed under joint rules.

Resolve in favor of the roads in the Indian township, Washington county.

Resolve in favor of Thomas Bailey, representative of the Passamaquoddy tribe of Indians.

#### ORDERS OF THE DAY.

On motion of Mr. Manley of Augusta, the following order was taken from the table: Ordered, That the commit-

tee on legal affairs be directed to inquire into the expediency of revising the Public Laws of the State of Maine and report a resolve relating thereto, or otherwise.

Mr. Manley moved to amend the order by striking out the words "legal affairs" and inserting the word "judiciary."

The amendment was adopted.

Mr. Manley of Augusta: I move to take from the table House bill No. 42, an act to provide in part for the expenditures of government for the year 1899. I desire to have this bill take its first and second reading at the present time, and that tomorrow morning at 11 o'clock be assigned as a special assignment for its third reading and passage to be engrossed.

Mr. Gardner of Patten: I would suggest that, as to those of us who are new members, so early an assignment gives us hardly time to look into it, and if the gentleman from Augusta (Mr. Manley) does not object I would ask, for one, for a little more time.

Mr. Manley: You may have all the time you wish, tomorrow. I am not asking for any hurried action on the bill. And I will divide the motion. I move that it take its first and second readings at the present time.

The motion was agreed to.

The bill was then read the first time. Mr. Guernsey of Dover: Pending its second reading I move that it lie upon the table.

Mr. Manley: I raise the point of order that the House has just voted that the bill should take its first and second readings.

The Speaker: The Chair sustains the point of order of the gentleman from Augusta (Mr. Manley).

Mr. Guernsey: I move that we reconsider the vote by which it takes its first and second readings at this time. It is an important matter, it covers appropriations that will make an extensive inroad into the State treasury, covers appropriations of nearly \$1,600,000, and there are amendments that are likely to be made to it, or at least offered, in this House. And I believe, as it was understood when it was laid on the table that it should placed on the desks of the members. last week, to give us more opportunity to look into it, that it should not be hurried through at this time, and I

hope the House will reconsider the

Mr. Manley: If the gentleman desires more time I am perfectly willing that the third reading shall be taken at any day that he proposes. I am not trying to hasten the bill through. If it takes its second reading, tonight, it does not hasten its progress at all. This bill does not appropriate a single penny except in conformity with the laws of this State, and the gentleman from Dover (Mr. Guernsey) ought to have had ample time to familiarize himself with the law, being a lawyer and in full practice.

It is an unusual thing to attempt to take out of the hands of the chairman of a committee a bill which is placed in his charge and which he must explain and defend upon the floor of this House. I am willing that the gentleman (Mr. Guernsey) should have all the time he desires; but I do object to his proposition to lay it upon the table and put it under his control. The bill properly belongs in the control of the chairman of the committee on financial affairs. If any member desires that the third reading should be postponed to a later date, I am perfectly willing to agree to that; but I do not want the bill, in this unusual way, taken out of the hands where it belongs and placed in the hands of another member to control it as he sees fit.

The question being on the motion to reconsider the vote whereby the bill was to take its first and second reading at the present time,

The motion was lost.

The bill was then read the second time.

Mr. Manley moved that tomorrow morning at 11 o'clock be assigned for its third reading.

The motion was agreed to.
