REPORTS OF COMMITTEES.

Mr. Merrill, for the committee on financial affairs, reported ought to pass, resolve in favor of portraits of the past presiding officers of the State Senate.

Mr. Whitehouse, for the committee on interior waters, reported ought to pass, bill an act to extend the charter of the Maine Water and Electric Power Co.

Mr. Blanchard, for the committee on education, reported ought to pass, resolve in favor of summer training schools for teachers, and the distribution of educational documents.

Mr. Blanchard, for the committee on inland fisheries and game, reported ought to pass, bill an act to repeal so much of section 5 of chapter 30, R. S., as relates to bounty on bears.

Mr. Weeks, for the committee on library, having had under consideration estimates and appropriations for the Maine State library for the years 1899 and 1900, reported ought to pass, resolve in favor of the Maine State library for the years 1899 and 1900.

The reports were severally accepted and matters tabled for printing under joint rule.

Mr. Hill of Belfast, offered the following amendment: Amend by striking out the words "two thousand dollars" in the first line and substituting therefor the words, "one thousand dollars for the year 1899 and one thousand dollars for the year 1900."

Mr. Macomber of Augusta, moved that the resolve be laid on the table pending the adoption of the amendment.

Mr. Manley of Augusta: I think my colleague does not understand the situation. This amendment, as I understand it, was offered by the gentleman from Belfast. It does not change the amount appropriated. The gentleman from Belfast simply moves that this sum shall be divided into two years, and I think that that was the intention of the finance committee when the matter was heard before it. This is a very worthy object, one of those little homes where great good is being done for the children; they are being reared and made good men and women; and the women of Belfast and other sections of the State have given their time and money and assistance in this matter and I certainly hope that this small sum, for this charitable object, will be given.

The amount appropriated is not changed at all by the amendment of the gentleman from Belfast, as I understand it. He simply desires that one-half shall be appropriated in the year 1899 and one-half in the year 1900.

Mr. Hill of Belfast: That is correct. I offered this amendment at the suggestion of the State treasurer. It in no way changes the amount appropriated, but simply divides it so that one-half is payable in 1899 and the other half in 1900, instead of making the whole sum payable at once.

Mr. Macomber: If that is correct, I will withdraw my motion to lay on the table. I understood that the proposed amendment cut down the appropriation, which, it seemed to me, should not be done without further consideration. I withdraw my motion.

The amendment was then adopted and the resolve was read the second time and passed to be engrossed as amended.
