# REPORTS OF COMMITTEES.

Mr. Virgin from the committee on the judiciary, reported leave to withdraw on petition of William J. Wheeler and Joseph H. Stewart, that they and their successors and associates be incorporated under the name of South Paris Water Company.

Mr. Hopkins from the committee on legal affairs, reported ought not to pass on bill an act amendatory to chapter 170, Acts of 1895, entitled "an act to regulate the practice of medicine and surgery."

Mr. Chase from the same committee, reported same on bill an act relative to the election of selectmen, overseers of the poor and assessors.

Same gentleman from same committee, reported legislation inexpedient on order to inquire into the expediency of amending section 12, of chapter 79, of the Revised Statutes, relating to the election of selectmen, assessors and overseers of the poor.

Mr. Wood from the committee on shore fisheries, reported leave to withdraw on petition of George A. Storer and others that section 17, of chapter 61, of the Public Laws of 1891, relating to shad and alwives in the Androscoggin river and Merrymeeting bay.

Same gentleman from same committee, reported same on petition of J. P. McKellon and others of South Thomaston, that a law be enacted to prevent torching of fish in waters adjoining weirs, as present law already covers matter in question.

Mr. Peabody from the committee on Indian affairs, reported leave to withdraw on petition of the Governor of Passamaquoddy Tribe of Indians, that the line between their reservation and the town of Perry be located.

Mr. Dawson from the committee on pensions, reported leave to withdraw on petition of Matthias A. Cullan for increase of pension.

Mr. Ryerson from the committee on library, reported ought not to pass on bill an act to provide for establishment and maintenance of free public libraries in cities and towns and for the purchase of books for the use of plantations out of the money raised and collected from the licensing of dogs.

Mr. Virgin from the committee on the judiciary, on bill an act to amend chapter 570, of the Private and Special Laws of 1874, as amended by chapter 85, of the Private and Special Laws of 1857, reported ought to pass in new draft bill an act granting William S. Hopkins the right to establish and maintain a ferry between North Haven and Vinalhaven.

# ORDERS OF THE DAY.

Mr. Gardner of Patten: Mr. Speaker, I wish to introduce an order at this time. In explanation I might say that the object of this order is to ascertain from the railroad corporations of this State the amount of free transportation furnished during the year 1898, as bearing on the financial aspect of a certain bill now before this House.

Ordered, That the committee on railroads, telegraphs and expresses are hereby directed to ascertain and report whether any of the railroad corporation of ithis State issued any passes during the year 1898, and if so to report the number of the kinds of passes so issued to persons not in the employ of such corporations; and for that purpose said committee is hereby empowered to compel the attendance of the officers of such corporations and to require the production of all necessary books and papers.

Mr. Chase of Portland, moved that the order be laid on tht table.

Macomber of Augusta: As a Mr. member of the railroad committee I would be very glad to try to get this information, but it strikes me that this information is impossible to obtain. How can we compel railroad companies of this State to furnish the information called for in the order? If it is impossible to do this it seems to me to be entirely unnecessary to pass such an order. I don't know of any way, and I don't know how the committee could go to work to get all these corporations to furnish such information. Congress has tried this same thing. They never succeeded, and I don't believe this Legislature can.

Mr. Gardner: The railroad corporations of this State are public corporations, and it is perfectly within the province of this Legislature to require them to supply to this Legislature this information.

Mr. Chase: I rise to a point of order. There is a motion before the House to lay this order on the table, and a motion to lay on the table is not debatable.

Mr. Speaker: The Chair sustains the point of order made by the gentleman from Portland (Mr. Chase).

The question being on the motion to lay on the table,

The motion was agreed to.

On motion of Mr. Burns of Westbrook,

The vote whereby the petition of Charles T. Ames and 30 others of Westbrook, in favor of an act to create a lien upon monumental work was referred to the committee on legal affairs was re-considered, and on motion of same gentleman the petition was referred to the committee on manufactures and sent to the Senate.

On motion by Mr. Smith of Presque Isle,

Communication from State treasurer transmitting detailed statement of the State tax assessed against and paid by the electric street railway companies for the years 1895-1896-1897 and 1898, House document No. 19, was taken from the table and ordered filed.

On motion by Mr. Walker of Starks,

Resolve in favor of Anson Academy was taken from the table, read once and Wednesday next assigned for sepond reading.

Ordered, The House concurring, that when the Senate and House adjourn, they adjourn to meet on Monday, February 13, at 4.30 o'clock P. M.
