# HOUSE.

Tuesday, Feb. 21, 1899.

Prayer by Rev. Mr. Crosby of Augusta.

Mr. McFADDEN of Dresden: I wish to call the attention of the House a moment to some slight errors in the record in the Journal of Friday's proceedings. In the journal report, and in the newspaper report, I find that, in the speech of the gentleman from Presque Isle, as reported, the complimentary allusion to myself for the effort I had made to get things called by their right names, was dropped out and does not appear at all. I regret that that is sobecause it was a valuable compliment which he paid me, and I should have been very glad if it had appeared in the report.

Then in the report of my own remarks, on page 209 of the journal that is laid upon our desks, the report makes me say, "But we have made our vows to the Catholic fraternity of the State." What I did say was, "We have made our bows." You see there is a great difference although it is a change in only a single letter. A bow is an act of courtesy, while vows bind us forever. I did not mean to say that we had gone that far.

The Speaker: The chair would call the attention of the gentleman from Dresden to'the fact that the reports of the speeches are no part of the journal record kept by the clerk. They are a part of the stenographic report that appears in the Daily Kennebec Journal and in the pamphlets which are laid on the desks here, but at the present time it would be impossible to rectify the error otherwise than the gentleman's remarks will appear in the report of today.

### ORDERS OF THE DAY.

Pending its adoption, Mr. Chase of Portland, moved that the bill and amendment be tabled. Subsequently the motion was withdrawn.

Mr. Philbrook of Waterville, offered House amendment "B" and pending its adoption both bill and amendments were tabled on motion of Mr. Chase of Portland.

Resolve in favor of the Maine Eye and Ear Infirmary was taken from the table and Tuesday next assigned for its consideration.

On motion of Mr. Gardiner of Patten, Resolve providing for an office for the

Mr. Gardner of Patten, moved that the rules be suspended and the resolve take its second reading and pass to be engrossed.

The motion was lost and Wednesday of next week was assigned for the second reading of the resolve.
