## SENATE.

Thursday, Jan. 19. 1899.
Senate met according to adjournment.
Prayer by Rev. Mr. Lesher of Augusta.
Journal of yesterday read and approved.
Papers from the House disposed of in concurrence.
A communication was received from the secretary of State, fransmitting the report of the trustees, resident officers and visiting committee of the Maine insane hospital, and was referred to the committee on insane hospital.

Mr. Plummer for the committee on legal affairs, which was instructed by an order of the Legislature to inquire into the expediency of the State supporting and maintaining the large bridges, reported legislation thereon inexpedient. Report accepted.
Mr. Vickery for the committee on inland fisheries and game, reported ought to pass on resolve for the purpose of operating fish hatcheries and feeding stations for fish and for the proper euforcement of the inland fish and game laws.
Tabled for printing under rule.
Mr. Blanchard for the Franklin county delegation reported ought not to pass on bill "An act relating to the compensation of county commissioners for Franklin county." Report accepted.

## ORDERS OF THE DAY.

On motion by Mr. Stearns of Aroostook, the following order was taken from the table and passed:
Ordered, The House concurring, that a joint special committee consisting of three members on the part of the Senate and seven on the part of the House, be appointed to whom shall be referred all petitions, bills and orders and other papers specially relating to salaries.
On motion by Mr. Hamlin of Hancock, Senate document 4, communication from the executive transmitting the second biennial report of the board of com-
missioners for the promotion of uniformity of Iegislation in the United States, was taken from the tabie and referred to the committee on judiciary.
