SENATE.

Tuesday, Feb. 21, 1899.

The Senate met according to adjournment and was called to order by the president.

Prayer by Rev. Mr. Cochrane of Hallowell.

Journal of yesterday read and approved.

Papers from the House disposed of in concurrence.

(Senator Witham of Cumberland, in the chair.)

The following House bill came up for its first reading:

Eill an act to set off certain territory from Pittsfield Village Corporation.

On motion by Mr. Merrill of Somerset, the bill was laid on the table pending second reading.

HOUSE BILLS READ AND ASSIGNED.

Bill an act to incorporate the Ripley Water Company of Andover, Maine.

Bill an act to authorize registers of probate to receive petitions in vacation, and the judge of probate to order notice thereon in vacation.

Bill an act to repeal chapter 111 of the Private and Special Laws of 1872, entitled "An act authorizing the city of Gardiner to raise money for the maintenance of a public library."

Bill an act to increase the salary of the register of probate in and for the county of Aroostook.

Bill an act to increase the salary of the judge of probate in and for the county of Aroostook.

Bill an act to set off certain lands from Oxford Village Corporation.

Bill an act entitled "An act to amend section 32 of chapter 285 of the Public Laws of 1897, regarding taking of smelts in tide waters."

Bill an act authorizing the Hallowell Granite Works to lay and maintain pipes in the city of Hallowell for the use and distribution of compressed air.

Bill an act to amend section 1 of chapter 298 of the Public Laws of 1889 relating to hawkers and peddlers.

Bill an act to incorporate the Bath Trust Company.

Bill an act to authorize the Stevens Lumber Company to erect and maintain a dam across the Aroostook river in the town of Fort Fairfield. Bill an act to amend chapter 126 of the Public Laws of 1895 relating to the Penobscot tribe of Indians. As amended by House amendment A.

The following communication was received from the Executive:

STATE OF MAINE.

EXECUTIVE DEPARTMENT.

Augusta, Feb. 21, 1899.

To the Honorable President of the Senate, and Speaker of the House of Representatives:

I have the honor to transmit herewith a communication just received from the Hon. William P. Frye, United States Senator, in reply to a formal invitation extended to him by the Legislature of Maine to become the guest of the State at his earliest convenience. (Signed.) LLEWELLYN POWERS.

UNITED STATES SENATE.

Washington, D. C., Feb. 16, 1899. The Governor of Maine, the President of the Senate, and the Speaker of the House of Representatives.

Gentlemen: I have received your letter of February 9, enclosing an order of the Legislature of Maine, requesting you to extend to me an invitation to visit the State Capitol during the present session as the guest of the State.

The distinguished honor thus tendered me is most highly appreciated. I am conscious that no effort of mine entitles me to it, and that it is conferred upon me only as one of the commissioners appointed by the President to negotiate a treaty of peace with Spain. I accepted that important mission with great reluctance, largely induced to do so because I regarded the appointment as an honor to my State which I had no right to refuse. I performed its duties conscientiously, with a single purpose to serve well country and the peoples which might under the terms of the treaty, come within our protection.

That my action meets the approval of the Legislature of my State is exceedingly gratifying to me. To be the "guest of the State" where I was born, where I have always lived, and of the State which has so honored me for the last quarter of a century would give me a pleasure which I cannot express in words; hence my profound regret that I am compelled to decline the invitation. There are only two weeks

more in this session, the last of the Fifty-fifth Congress, and they are crowded with proposed legislation of unexampled importance to the country. It so happens that I have charge of several measures affecting the commercial interests of the nation. Duty compels me to forego the pleasure and the honor of being the "guest of the State." gusta. Mr. McFADDEN of Dresden: I wish to call the attention of the House a moment to some slight errors in the record in the Journal of Friday's proceedings. In the journal report, and in the newspaper report, I find that, in the speech of the gentleman from Presque Isle, as reported, the complimentary allusion to myself for the effort I had made to get things called by their right names, was dropped out and does not appear at all. I regret that that is so because it was a valuable compliment which he paid me, and I should have been very glad if it had appeared in the report.

Then in the report of my own remarks, on page 209 of the journal that is laid upon our desks, the report makes me say, "But we have made our vows to the Catholic fraternity of the State." What I did say was, "We have made our bows." You see there is a great difference although it is a change in only a single letter. A bow is an act of courtesy, while vows bind us forever. I did not mean to say that we had gone that far.
