#### SENATE.

Tuesday, Feb. 28, 1899.

The Senate met according to adjournment and was called to order by the president.

Prayer by Rev. Mr. Phillips of Augusta.

Journal of yesterday read and approved.

Papers from the House disposed of in concurrence.

House report of committee on interior waters, reporting leave to withdraw on petition of Warren B. Chute and 18 others for improvement of Songo and Chute rivers, came from the House read and accepted.

On motion by Mr. Witham of Cumberland, the report was laid on the table pending acceptance in concurrence.
