SENATE.

Friday, March 10, 1899.

The Senate met according to adjournment and was called to order by the President.

Prayer by Rev. Mr. Mead of Augusta.

Journal of yesterday read and approved.

(Senator Plummer of Penobscot, in the chair.)

Papers from the House disposed of in concurrence.

Bill an act to incorporate the Kennebec Water District.

This bill came up for its first reading and on motion by Mr. Weeks of Somerset, was laid on the table pending first reading.

Bill an act to amend the charter of the Westbrook, Windham and Harrison Railway Company, extend the same and change the name of said company.

This bill came up for its first reading, was read once, and on motion by Mr. Witham of Cumberland, the rules were suspended, the bill read the second time and passed to be engrossed.

Bill an act to amend Chapter 72 of the Special Laws of 1887, in relation to the taking of fish in Nequasset lake.

This bill, passed to be engrossed in the Senate, came back from the House amended by House amendment A.

Pending the reconsideration of the action of the Senate on this bill, on motion by Mr. Chamberlain of Lincoln, it was laid on the table.

The following resolves came from the House passed to be engrossed under suspension of the rules.

Mr. HARGRAVES of York: I would like to ask the Senate to allow the rules to be suspended and that these resolves have their several readings and pass to be engrossed at the present time.

I would say that these are to enable the treasurer's department to meet the bills incurred by the towns for expenses during the late war and to provide in 1900 for a renewal, if necessary, of the loan already negotiated of \$100,-000.
