Prayer by Rev. Mr. Plummer of Hallowell.

Papers from the Senate disposed of in concurrence.

Bill, An Act to amend Chapter 145 of the Private and Special Laws of 1887, entitled "An Act to provide sewerage for the town of Houlton," and Bill, An Act to amend Chapter 227 of the Private and Special Laws of 1880 entitled "An Act to supply the people of Houlton with pure water," came from the Senate referred in that branch to the committee on legal affairs.

Mr. McFaul from the committee on legal affairs, on bill, An Act to amend Section 4 of Chapter 91 of the Revised Statutes relating to notice of foreclosure on a mortgage of personal property, reported ought to pass.

Mr. Campbell from same committee, on bill, An Act to amend Section 57 of Chapter 38 of the Revised Statutes relating to the weight of a bushel of beans, reported ought to pass.

Mr. Barker from same committee on bill, An Act to incorporate the Union Gas and Electric Power Company, reported ought to pass.

Mr. McFaul from same committee, on bill, An Act to extend the charter of the Eastport bridge, reported ought to pass.

Mr. Manson from same committee, on bill, An Act to extend the powers of the Katahdin Pulp and Paper Company, reported ought to pass.

Mr. Allan from same committee, on bill, An Act to amend and consolidate Chapter 142 of the Revised Statutes relating to Reform School, reported ought to pass.

Mr. Eaton from committee on appropriations and financial affairs, on Resolve providing for a special epidemic or emergency fund, reported ought to pass.

Mr. Page from same committee, on Resolve in aid of the Children's Aid Society of Maine, reported ought to pass.

Mr. Pettingill from same committee, on Resolve in aid of the Temporary Home for Women and Children at Portland, reported ought to pass.

Mr. Leavitt from committee on agriculture, on bill, An Act to amend Section 35 of Chapter 124 of the Revised Statutes as amended by Chapter 25 of the Public Laws of 1891, relating to the transportation of animals, reported ought to pass.

Mr. Shackford of Poland, from committee on towns, on bill, An Act to incorporate the city of Camden, reported ought to pass.

Messrs. Staples, Clark, Allan, Oakes, Morey and McFaul, a majority of the committee on legal affairs, on bill, An Act to enable women paying taxes to vote in municipal elections, reported in a new draft bill, An Act to enable women to vote in municipal elections, and that it ought to pass.

Messrs. Barker, Campbell, Manson and Pierce, a minority of same committee, on same bill reported ought not to pass.

On motion of Mr. Allan of Portland, these reports, pending the acceptance of either, were laid on the table with the accompanying bill to be printed, and Wednesday of next week, was assigned for their consideration.

First Reading of Printed Bills and Resolves.

An Act to regulate the placing of permanent moorings in harbors.

Passed to Be Engrossed.

An Act to enlarge the powers of the Berwick, Eliot and York Street Railway.

An Act to confer additional powers upon the Lincoln County Street Railway.

An Act relating to the Bar Harbor Electric Light Company.

An Act to fix the salary of the Judge of Probate for Hancock county.

An Act to amend Chapter 258 of the Public Laws of 1893 as amended by Chapter 130 of the Public Laws of 1895 relating to the taxation of savings banks.

Mr. Bodwell offered amendment A to this bill by inserting at the end of the bill the following words: "Section 3. This Act shall take effect when approved."

The amendment was adopted, the bill was read the third time as amended and was passed to be engrossed.

Orders of the Day.

Mr. Mills of Stonington moved a suspension of the rules to introduce two orders out of order. The motion was agreed to.

Ordered, That the committee on shore fisheries be allowed a stenographer and that the secretary be authorized to employ the same.

Ordered, The Senate concurring, that the report of the committee on shore fisheries on bill, An Act to amend chapter 285 of the Public Laws of 1897 relating to sea and shore fisheries, reporting that the same ought not to pass, be taken from the files and recommitted to the committee.

The orders received a passage.

On motion of Mr. Drew, of Portland, the Senate order extending an invitation to Hon. Martin Dodge and President Morse to address a joint session of the Legislature on Thursday evening, Febru-ary 5th, on the subject of good roads, was taken from the table.

Mr. DREW: I suppose the question now is on the passage of the order.

MR. WEEKS of Fairfield: Mr. Speaker, I rise for information. I would like to inquire of the gentleman from Portland (Mr. Drew) if in his opinion, if this order passes, the Legislature is bound to a joint session tomorrow evening? I simply want to get information on this point from the luminous mind of the gentleman from Portland.

Mr. DREW: That is my impression that it does. That is the way it reads.

Mr. WEEKS: At what hour is the joint

session to be held, I would inquire?
The SPEAKER: The chair cannot inform the gentleman. That depends entirely on the action of the House and

Senate, I suppose.

Mr. WEEKS: Suppose the gentlemen who are invited decline to come here, what business is there before the joint convention? I suppose the gentlemen from Portland in that case would furnish

a substitute?

Mr. OAKES of Auburn: Can we be informed what the order is?
The SPEAKER: The order reads as

The SPEAKER: follows:

Ordered, The House concurring, that this Legislature extend an invitation to Hon. Martin Dodge, director of the Office of Public Roads, and President Morse of the Inquiries Department of Agriculture of Washington, D. C., to address the Legislature of Maine, on Thursday evening, Feb. 5, and that Representatives' Hall be obtained for that purpose. And that two members of the Committee on State Lands and State Roads be delegated to proceed to Concord, N. H., and present a formal invitation to come to Maine and address the Legislature in joint session.

And what will the gentleman from Auburn (Mr. Oakes) do with the order? (Laughter.) The gentleman from Auburn moves that it lie upon the table.

Mr WEEKS: I merely make this as a suggestion to the gentleman from Auburn, whether or not it would not be proper to send this order to the committee on

revision of the statutes? (Laughter).

The question being on the motion to lay the order on the table the motion was

agreed to.

A message was received from the Senate through its Secretary proposing a convention of the two branches of the Legislature forthwith in the Hall of the House for the purpose of electing a Treasurer of State.

On motion of Mr. Littlefield of Rockland, the House concurred in the proposition for a convention and the Clerk was charged with the duty of informing the Senate to that effect.

Subsequently the Clerk reported that he had performed the duty assigned him. Thereupon the Senate came in and a convention was formed.

In Convention.

On motion of Mr. Knowlton, Messrs. Knowlton of Penobscot, Currier of Franklin. Newcomb of Eastport, Josselyn of Portland, Furbish of Rangeley, Foss of Hancock and Spear of Warren were ap-pointed a committee to receive, sort and count votes for Treasurer of State.

Having attended to the duty assigned it, Mr. Knowlton from the committee, re-

The report was accepted and Hon. Oramandal Smith was declared duly elected Treasurer of State for the current politi-

cal year of 1903 and 1904.
On motion of Mr. Staples of Cumberland the Secretary of the convention was directed to notify Hon. Oramandal Smith of his election as Treasurer of State for the political years of 1903 and 1904.

On motion of Mr. Hyde of Sagadahoc, the Secretary of the convention was directed to notify the Governor and Council of the election of Hon. Oramandal Smith as Treasurer of State for the current political years of 1903 and 1904.

The purposes of which the convention was formed having been accomplished, the convention was dissolved and the Senate retired.
