HOUSE.

Tuesday, Feb. 10, 1903.

Prayer by Rev. Mr. Cashmore of Gardiner.

Papers from the Senate disposed of in concurrence.

Bill, An Act to confer additional powers upon the Lincoln County Street Railway, came from the Senate amended by Senate amendment A, by striking out in the sixth line the word "Damariscotta."

On motion by Mr. Weeks of Fairfield the vote was reconsidered whereby this bill was passed to be engrossed, Senate amendment A was adopted, and the bill was then passed to be engrossed as amended.

Mr. DREW of Portland: Mr. Speaker, I move that the rules be suspended that I may introduce a resolve and a bill at the present time.

Mr. WEEKS of Fairfield: Mr. Speaker, I desire to object to the introduction of any petitions, bills or resolves under suspension of the rules unless a good reason can be assigned for their immediate consideration. The introduction of bills under the rules at the proper time will not delay the action to be taken by the committees, if they are allowed to go there in their regular order by being placed in the box. That course will assist the clerk and the officers of the House in the orderly conduct of the business; and unless there is some grave reason why this bill should be presented at the present time under a suspension of the rules, I shall have to object in behalf of the business of the House and in behalf of the orderly conduct of business.

Mr. DREW of Portland: Mr. Speaker, I can only say that the reason for my offering the bill and resolve out of order, was this: There have been several hundred, I may say thousands, of petitions in favor of establishing a home and school for the feeble minded. The committee do not wish to order notice on those petitions, and have been waiting for an act and resolve to come before them on which to order notice. I am imformed that unless this

bill and resolve are introduced at this time, they cannot in the due course of time get round to the committee so that notice may be ordered this week at their usual meeting; and the friends of the measure are very anxious that the public notices shall be ordered. I am exceedingly sorry to ask the House to suspend the rules, but I hope they will this time.

Mr. WEEKS: Mr. Speaker, It is very unusual, indeed I may say it is a thing I never heard of in my experience, a committee refusing to order notice and hearing upon petition properly presented to a Legislature; and while I don't know the reasons, at the same time if that is the fact-and the gentleman from Portland states that it is and I have no reason to doubt it-if that is the fact I withdraw my objection, but 1 wish to notify members of the House that in the future I shall object to the introduction of bills, petitions and resolves out of order unless the very best reasons are assigned for it. I withdraw the objection to the bill and resolve presented by the gentleman from Portland.

The motion to suspend the rules was agreed to and Resolve in favor of the Maine home and school for feeble minded children, and bill, An Act to provide for the care and education of feeble minded children, were referred to the committee on public charities and State beneficiaries.

Mr. SMITH of Hartland: Mr. Speaker, I move that the rules be suspended to introduce an order at this time.

Mr. WEEKS: Much as I dislike to do this, I object to the introduction of this order at the present time. I don't know what it is, but after the gentleman from Hartland has explained what the order is, I may withdraw my objection.

The SPEAKER: I will read the order: "Ordered, That J. F. Frederick, first folder, be excused from further attendance at this session of the Legislature, and that his pay be made up to the end of the session, and that L. J. Brann be appointed first folder to the vacancy thus created."

Mr. WEEKS. Mr. Speaker, it strikes me that this is a matter that can be laid over until tomorrow morning and taken up in the regular order of business; and I object to a suspension of the rules.

Mr. SMITH: I will not insist on the order prevailing at this time. I withdraw my motion to suspend the rules.
