Papers from the Senate disposed of in concurrence.

Senate Bills on First Reading.

An Act to authorize the State Land Agent to convey to the Fish River Railroad Company rights of way over public roads owned by the State.

An Act to authorize the Bangor and Aroostook Railroad Company to extend yard tracks across a way in Houlton.

An Act relating to the width of the location of the Fish River Railroad.

An Act to ratify certain doings of the Eliot Bridge Company.

An Act to amend Chapter 407 of the Private and Special Laws of 1846 entitled "An Act to incorporate the Penobscot log Driving Company.

On motion of Mr. Ross of Bangor this bill was tabled for printing.

On motion of Mr. Shaw of Bath, the clerk was charged with and conveyed a message to the Senate notifying that body of the appointment to committees as announced by the speaker yesterday.

The clerk subsequently reported that he had performed the duty assigned him.

By Mr. Allen of Sanford: Bill, An Act to amend charter of Sanford Light and Water Company and to consolidate with Springvale Aqueduct Company and Butler Spring Water Company.

By Mr. Parrott of Oxford: Bill, An Act to amend Section two of Chapter 508 of the Private and Special Laws of 1885, as amended by Chapter 134 of the Private and Special Laws of 1887, chapter 527 of the Private and Special Laws of 1893 and chapter 425 of the Private and Special Laws of 1901.

By Mr. Allen of Sanford: Bill, An Act to authorize the town of Bucksport to retire its bonded indebtedness and to issue new bonds.

By Mr. Drew of Portland: Bill, An Act amending Section 6 of Chapter 495 of Special Laws of 1885 entitled "An Act to incorporate the People's Ferry Company."

By Mr. Davis of Waterville: Bill, An Act to increase the capital stock of the Ticonic foot bridge.

By Mr. Smith of Presque Isle: Bill, An Act amendatory of Section one of Chapter 221 of the Public Laws of 1897 relating to waiving the provisions of a will by the widow or widower, and to wills in which no provision is made for the widow or widower, and the interest which the widow or widower shall have in the personal estate of the testator or testatrix.

Mr. MEAD of Bridgton: Mr. Speaker, I understand that there are other candidates for this position, and I move that this order be laid on the table until tomorrow.

By Mr. Taylor of Wiscasset: Remonstrance of Mrs. W. D. Blake and 18 others, women of Wiscasset, against conferring suffrage upon women.

By Mr. Benner of Waldoboro: Remonstrance of Joseph B. Welt and 15 others of Waldoboro against reduction in savings bank tax.

Reports of Committees.

Mr. Littlefield from the committee on elections, to which was referred the communication of Hon. Byron Boyd, secretary of State, transmitting to the Speaker of the House of Representatives the official returns of votes for Representatives to the seventy-first Legislature given in on the 8th of September last in the several cities, towns and plantations of the State, reported that said official list of Representatives prepared by the honorable secretary of State and duly submitted, is a true list of persons elected to said House of Representatives, except that Alonzo M. Garcelon, Frank A. Morey and Michael A. Coyne, shown by said list to be elected from the city of Lewiston, and acting as Representatives until the fifth day of February 1903, were declared by this House not legally elected, but that Jacob \mathbf{R} Little. George B. Haskell and Stephen J. Kelley were declared legal representatives from the city of Lewiston, and that with this correction said list submitted by the honorable secretary of State is the true and correct list of the Representatives to the seventy-first Legislature of Maine.

Mr. Howe from the committee on taxation, on Bill, An Act additional to Chapter 6 of the Revised Statutes of 1883 providing for a tax on direct inheritances, reported ought not to pass.

Mr. Smith of Hartland from the committee on towns, on Bill, An Act additional to and amendatory of Chapter 54 of the Private and Special Laws of 1895 creating the Rumford Falls village corporation, reported ought to pass. Mr. Page from the committee on appropriations and financial affairs, to which was referred the official bond of Oramandal Smith, State treasurerelect, reported that the committee find the bond in due and legal form, the sureties good and sufficient, and recommend that the same be approved and the bond deposited with the secretary of State.

The report was accepted and the bond was approved.

Mr. Butler from the committee on commerce, on Bill, An Act to amend Section 43 of Chapter 284 of the Public Laws of 1901, reported that the same be referred to the committee on shore fisheries.

Mr. Drew from the committee on the judiciary, on petition of Albert W. Paine praying for an act to provide for voting by proxy at public elections, reported leave to withdraw.

Mr. Oakes from the committee on legal affairs, on Bill, An Act to repeal Chapter 228 of the laws of 1901 relating to fees and taxable costs, reported ought not to pass.

Mr. Newcomb from same committee, on Bill, An Act to grant Paul Castor a certificate of registration to practice medicine, reported ought not to pass.

Mr. Allen of Sanford from the committee on the judiciary, on petition of Frederic Danforth and 26 others of Gardiner, reported Bill, An Act to incorporate the Gardiner water district, and that it ought to pass.

Mr. Littlefield from same committee, on Bill, An Act to amend Sections 27, 28, 29 and 30, of Chapter 79 of the Revised Statutes relating to attorneys at law, reported ought to pass.

Mr. Barker from the committee on legal affairs, reported in a new draft Bill, An Act to legalize the doings of the Crosbyville chapel at Bangor, Maine, and that it ought to pass.

Mr. Oakes from same committee, on bill. An Act to amend the charter of the city of Portland, reported ought to pass.

Mr. Campbell from same committee, on bill. An Act in relation to the election of school committee of the city of Portland, reported ought to pass.

Mr. Eaton from the committee on apprepriations and financial affairs, on bill, An Act in relation to the salaries

Mr. Bodwell from same committee, on Resolve providing for the compensation of steamboat inspectors for the years 1900, 1901 and 1902, reported ought to pass.

Mr. Cordwell from the committee on inland fisheries and game, on petition of B M. Fernald and others of Poland, reported bill, An Act to amend Section 5 of Chapter 42 of the Public Laws of 1899, as amended by Chapter 326 of the Private and Special Laws of 1901 relating to fishing through the ice in Thompson's pond, and that it ought to DASS.

Mr. Hill of Buxton from the committee on towns, on bill, An Act to amend Section 12 of Chapter 3 of Revised Statutes of 1883, as amended by Chapter 335 of the Public Laws of 1885, reported ought to pass.

Mr. HILL of Buxton: Mr. Speaker, I move that the rules be suspended and that the bill receive its three readings at the present time and be passed to be engrossed-for this reason: That is one of the best laws for towns, in my opinion, that can be enacted, and I would like for the towns to have the benefit of that law at the coming annual election which will be held next month, and the warrants for the several town meetings will have to be issued within ten days.

WEEKS Fairfield: Mr. Mr of Speaker, I would like to have the bill read or explained by some gentleman who is familiar with its contents.

The clerk read the bill.

Mr. WEEKS: Mr. Speaker, I don't want to discuss the merits of this bill but I do object to its going through under a suspension of the rules. It is an important public matter, and I believe for one that it should be printed under the joint rules and that we should have time to think it over and see whether we want such a law. I therefore believe that the motion of the gentleman from Buxton ought not to prevail, and I desire for one to enter my objection.

Mr. SMITH of Presque Isle: Mr. Speaker, I wish to state that I heartily concur in all that has been said by the Augusta, Winthrop & Gardiner Railgentleman from Fairfield (Mr. Weeks),

of the justices of the supreme judicial and I hope that the bill will take its usual course.

> The question being on the motion that the rules be suspended and that the bill take its three readings and be passed to be engrossed at the present time.

The motion was lost.

The bill was then laid on the table for printing under joint rules.

An Act to amend the charter of the Home for Aged Men in Portland.

An Act to amend Section 30 of Chapter 450 of the Private and Special Laws of 1893, incorporating the city of Eastport.

An Act establishing the salary of the county treasurer of the county of York

An Act authorizing and empowering the Springer Lumber Company to erect and maintain piers and booms in the Mattawamkeag river.

An Act amendatory of Chapter 279 of the Private and Special Laws of 1901, entitled "An Act to incorporate the Mattagammon Manufacturing Company."

An Act to amend Chapter 64 of the Private and Special Laws of 1899. as amended by Chapter 472 of the Private and Special Laws of 1901, relating to the Wilson Stream Dam Company.

An Act to extend the charter of the Mattanawcook Manufacturing Company.

An Act to legalize the doings of St. Francis Plantation, Aroostook county.

An Act to correct an error in Chapter 79 of the Public Acts of 1899, and to amend Section 2 of Chapter 60 of the Revised Statutes.

Orders of the Day.

On motion of Mr. Peaslee of Upton, House document No. 54 was taken from the table.

The bill was then read the third time and was passed to be engrossed.

On motion of Mr. Putnam of Houlton, House document No. 46 was taken from the table, and on further motion by the same gentleman it was referred to the committee on legal affairs in concurrence with the Senate.

Bill, An Act to establish a street and sewer commission for the city of Bath, came from the Senate amended by Senate amendment A, by adding the following: "Section 13. This Act shall take effect when approved."

On motion of Mr. Sewall of Bath, the vote was reconsidered whereby this bill

was passed to be engrossed. Senate amendment A was adopted, and the bill was then passed to be engrossed as amended.

On motion of Mr. Allen of Wellington, Adjourned.
