1903.

The President thereupon directed the secretary to call his name, and in response to such call voted Yea.

The President thereupon declared that 13 had voted to accept the minority report, in concurrence with the House, and 12 had voted not to accept said report, and that a majority having voted in favor of the acceptance of the report in concurrence, the report was accepted.

On motion by Mr. Gardner of Penobscot, the Senate adjourned to meet on Thursday, February 19, 1903, at 10 o'clock

Papers from the Senate disposed of in concurrence.

On motion of Mr. Allen of Sanford, the vote was reconsidered whereby the order relating to the University Maine received a passage, and on motion of Mr. Littlefield of Rockland, Senate amendment A was adopted. The order then received a passage as amended.

Mr. Oakes from same committee, reported in a new draft bill, An Act to incorporate the Union Gas Company, and that it ought to pass.

The reports were accepted and bills and resolves ordered printed under joint rules.

Mr. Blake from the committee on salaries, on bill, An Act to increase the salary of the county attorney of York county, reported ought to pass. (Referred to the committee on appropriations and financial affairs.)

Messrs. Dudley, Titcomb, Pike, Libby, Thompson, Cole, Downing and Hill, a majority of the committee on temperance, on resolve for an amendment to the constitution by abrogating and annulling amendment 5 adopted on the 8th day of September, 1884, relating to the manufacture and sale of intoxicating liquors, reported ought not to pass.

Messrs. Tartre and Kelley, a minority of same committee, reported that same ought to pass.

Mr. Kelley moved that the minority report be substituted for the majority, and that pending action on the motion it and the reports lie on the table and that Wednesday, March 4, be assigned for their consideration.
