#### HOUSE.

Tuesday, Feb. 24, 1903.

Prayer by the Rev. Mr. Mosher of Augusta.

Mr. Page of Skowhegan announced the attendance of Representative-elect Savage of Bingham, and was charged with the duty of conducting him before the governor to take and subscribe the necessary oaths to qualify him to enter upon the discharge of his official duties.

Subsequently Mr. Page reported that he had attended to the duty assigned him, and thereupon Mr. Savage appeared and took his seat.

Papers from the Senate disposed of in concurrence.

Bill, An Act to increase the salary of the county attorney of Oxford county, came from the Senate referred to the Oxford county delegation. On motion of Mr. Weeks of Fairfield it was referred to the committee on salaries in non-concurrence.

Resolve in favor of Mathias Cullnan, came from the Senate, passed to be engrossed in that body, the House having non-concurred in that action and having accepted the report of the cemmittee on appropriations and financial affairs, ought not to pass.

Mr. WEEKS of Fairfield: Mr. Speaker, 1 would ask if there is a printed resolve accompanying the papers?

The SPEAKER: There is; it is Senate Document No. 68.

Mr. WEEKS: I understand that this is a resolve that was introduced into the Senate, referred to the committee on pensions, and that that committee heard the evidence, examined all the witnesses, and reported that the resolve ought to pass. It was then referred under joint rule 18 to the committee on appropriations and financial affairs. That committee reported that the resolve ought not to pass. Now I know nothing about the facts of the case but I would like to know upon what grounds the financial affairs committee has reversed the action of the committee on pensions who looked into this matter carefully. candidly and conscientiously, and reported to the Legislature. I say I simply ask for

information, and I think it is fair that this information should be given to this House in every case where the committee on appropriations and financial affairs reverses the action of the primary committee. For one I am going to say right here and now, that I do not believe in this joint rule 18. I believe it is a hinderance, that it is putting the Legislature under guardianship. For one I don't believe but I think it is fair. in it: since we are under this rule, that the committee on appropriations and financial affairs, when they reverse the action of the first committee, should give their reasons to this House for so doing; and I simply ask that the committee do so in this case.

Mr. PETTENGILL of Rumford: Mr. Speaker, it is my misfortune not to hear the remarks of the gentleman from Fairfield, who has preceded me. But in regard to the reason why the committee on financial affairs did not report favorably on this resolve, I will say that in this particular case we invited the chairman of the committee on pensions to come before us, and from his statement it appeared that this man was a member of the militia. and received what injury he did receive in his service as a militiaman. Now your committee on appropriations and financial affairs feel that if the State is to adopt the policy of pensioning the militia, it should be by a general bill and not in these specific cases. As a committee we cannot see why a man in the militia should be placed in a preferred class as compared with a man who served in the Civil War for instance. We have a general pension bill, and the committee felt that in all these cases of a man who serves in the militia, or a man who may have served in the Aroostook War or the Spanish War or in the Civil War, there certainly should be no preferred class for the militia. That is the reason why we reported adversely; and if they are to be pensioned, it seems to me that it should be by a general bill.

Mr. WEEKS: I would like to inquire whether this Mathias Cullnan receives a pension now under a special act passed by the Legislature; then I would like to know what is the extent of his disability and under what circumstances those disabilities were contracted. It may be that this is a case that demands our especial attention. Those are the questions I would like to ask, and I think this House would like to have full and complete information about it. If the gentleman from Rumford (Mr. Pettengill) is able to state the facts, I for one should like to hear them.

Mr. PETTENGILL: I would state for the information of the gentleman from Fairfield (Mr. Weeks) that the printed statement of facts, accompanying the resolve, answers his interrogatories.

The SPEAKER: The chair would suggest that there is no motion before the House.

Mr. PETTENGILL: I move that the House insist and join a committee of conference.

The motion was agreed to.

The Speaker appointed on that committee, Messrs. Swett of Portland, Davis of Waterville and Libby of Mechanic Falls, Mr. Pettengill declining to serve.
