Mr. Kelley from same committee, to which was referred order of the Legislature relating to the expediency of enacting a law whereby all paupers now supported by towns shall be supported by counties, reported legislation thereon inexpedient.

Mr. Bailey from the committee on inland fisheries and game, on bill, An Act to prevent ice fishing in Pleasant pond in Turner, reported that same be referred to the commissioners of inland fisheries and game as the subject matter of the bill properly comes under their jurisdiction.

Mr. Dilling from same committee, on bill, An Act to protect fish and game on township number 18, Washington county, with petition for same reported that same be referred to the Washington county delegation.

Mr. Little from same committee on Resolve in favor of the society of the Sisters of Charity for the use of Healey Asylum of Lewiston, reported ought to pass.

On motion of Mr. Littlefield of Rockland, Resolves in favor of Eben O. Garey and in favor of John Bradbury, were taken from the table.

WEEKS Fairfield: Mr. of Speaker, I come this morning as usual in cases of this kind, bearing olive branch of peace; and I wish to say that our offers have been accepted and that second Aroostook war is ended happily, and I offer the following motion touching these two resolvest That Senate Documents 10 and 12 and all the accompanying papers be committed to the committee on pensions with instructions to report forthwith a bill to pension all poor, needy, deserving soldiers of the Aroostook War at a rate of not exceeding four dollars per month.

This meets with the approval of the distinguished chairman of the committee on appropriations and financial affairs; and I hope it meets with the approval of the battle-scarred veteran from Bath. (Laughter.)

MR. PETTINGILL: I will say that that is the exact point on which we declined to approve the bills, and I second the motion.

The motion was agreed to.

Mr. Thompson of Orono, presented a report of the president of the trustees of the University of Maine, in accordance with an order of the Legislature, and moved that it be tabled for printing pending ts reference.
