Papers from the Senate disposed of in concurrence.

Certain petitions for and remonstrances against resubmission came from the Senate, that body non-concurring with the action of the House in referring them to the committee on temperance and ordering them placed on file.

On motion of Mr. Davis of Waterville, the House receded and concurred with the Senate.

Adjournment Order.

On motion of Mr. Smith of Presque Isle, the rules were suspended and that gentleman introduced the following order:

Ordered, The Senate concurring, that when the Senate and House adjourn they adjourn to meet on Tuesday next, March 3d, A. D. 1903, at four o'clock in the afternoon.

MR. DAVIS of Waterville: Mr. Speaker, I would like to amend that by making the time four-thirty on Monday afternoon. There are many of us who would like to get through with this session sometime this summer. I think we should conserve our energies and our time. I think all the members can get back on the trains in time to hold an afternoon session on Monday.

MR. BUZZELL of Old Town: Mr. Speaker, I second the motion.

PETTENGILL of Rumford: Mr. Speaker, I hope that the amendment will not prevail, and for this rea-Probably three-fourths of the municipalities in our state have their elections next Monday. It is almost universally the case with the towns in the section of the State from which I come. Our municipal elections are matters of so much importance that it is the duty of every representative to attend the election in his city or town. Now, if we attend our elections on Monday, it will be impossible for us to be here earlier than four o'clock on Tuesday afternoon. There is no member in this Houes more anxious than myself to complete this session, but we shall gain nothing by a meeting on Monday. We won't have a quorum. And if we have our session on Tuesday at four o'clock we have lost no time; and I certainly hope that the amendment will not prevail.

MR. BURRILL of Ellsworth: Mr. Speaker, I wish to say practically the same as the gentleman from Rumford. We have a municipal election in our town on Monday and I certainly want to be there, and I think that is the situation with a large proportion of the members of this House; and I hope the amendment will not prevail.

MR. DAVIS: Mr. Speaker, I had forgotten, not being interested in poli-

tics (Laughter) that there was an election on Monday. I withdraw the amendment I offered.

MR. BUZZELL: Mr. Speaker, I withdraw my second.

MR. SEWALL of Bath: Mr. Speaker, before acting upon that order of the gentleman from Presque Isle, I would suggest that there is a resolve on the table to be called up on Tuesday.

MR. PETTENGILL: In regard to that very matter of our assignment of Tuesday. I would say that we will have a session on Tuesday. We will lose no time. The assignment will come up Tuesday afternoon just the same, only it will be at four o'clock instead of ten o'clock.

The question being on the passage of the order.

The motion was agreed to.
