HOUSE.

Thursday, March 12, 1903. Prayer by Rev. Mr. Webber of Hallowell.

Mr. Davis of Waterville, was here called to the chair and presided during the session.

Papers from the Senate were disposed of in concurrence.

The following petitions, bills, etc., were were presented and referred:

Judiciary.

By Mr. Drew of Portland, bill, An Act to incorporate the Peak's Island Water and Light Company.

By Mr. Gannett of Augusta, bill An Act to incorporate the Augusta Water District.

Legal Affairs.

By Mr. Oakes of Auburn, bill An Act to amend Chapter 96 of the Public Laws of 1899, entitled "An Act to prevent incompetent persons from conducing the business of pharmacist.

By Mr. Thornton of Ashland, bill, An Act to incorporate the Munsungin Telephone Company.

By Mr. Littlefield of Rockland, bill, An Act to amend Chapter 44 of the Public Laws of 1899 relating to acceptance of bequest by cities and towns.

Interior Waters.

By Mr. Cook of Casco, bill, An Act to permit the Long Lake Railroad Company to construct a wharf in Long Lake in the town of Naples.

Also, bill An Act to authorize the town of Naples to maintain and operate a draw-bridge at the foot of Long Lake in the town of Naples.

Mr. LITTLEFIELD of Rockland: Speaker, pending the first reading of the bill I move that it lie on the table and be specially assigned for Tuesday of next

Mr. WEEKS of Fairfield: Mr. Speaker, I thought I had the assurance of the gentleman from Rockland that this matter was not to be contested in the House but was to go along in regular order. If it does not, I would like to have the matter taken up, tomorrow morning, and disposed of. I know of no reason why there ed of. I know of no reason why there should be any delay in the House in this matter except a reason which may be entirely outside of the House. I think the matter ought to go right along and that we ought not to encumber our pages with unnecessary business; and I would ask the gentleman from Rockland if we cannot take this matter up, tomorrow morning, and dispose of it?

Mr. LITTLEFIELD: Mr. Speaker, would say that I intended to get a chance to speak to the gentleman from Fairfield in relation to the matter; but I should prefer to have it assigned for Tuesday. I don't think there will be any contest in the House in relation to it; but at the request of parties interested I should prefer not to change the date of assignment at this

time.

Mr. WEEKS: Mr. Speaker, I don't know that there is to be any contest in this matter, but it would seem that a request has been made to the gentleman quest has been made to the gentleman from Rockland by parties in interest, that this matter should go over until Tuesday. I feel that it ought to go right along. We are drawing near the close of the session, and it is imperative, in order to close up our business in two weeks, that we take these matters up and push them along; and if the gentleman from Rockland insists upon his motion, I shall ask that the motion be amended so we may take it up tomorrow morning. I think that is suffi-This matter was thoroughly cient delay. discussed before the committee and I think the different members of the committee well understand it, and if it is to be dis-cussed on the floor of this House it will be discussed by members of the committee, probably, who have had this mat-ter before them for weeks, and I can see no reason in a delay of three or four days, throwing this matter over into next week which will probably be the next to the last week of the session. I move that the motion be amended by making it "tomorrow morning.

Mr. LITTLEFIELD: I will say to the gentleman from Fairfield that I will make the motion to assign it for tomorrow morning, reserving the right, if further delay should be necessary, to make a further motion for more delay tomorrow

morning

Mr. WEEKS: I don't think we can curtail the rights of the gentleman from Rockland in any way, and I don't think we would desire to I would like to have a fair understanding that this matter is

to be taken up tomorrow morning.

Mr. LITTLEFIELD: I simply made that suggestion so that the gentleman from Fairfield could not say tomorrow morning that I had agreed that the matter should be considered tomorrow morning whether or no. I make the motion that the matter lie on the table pending its first reading, and be now assigned for tomorrow morning.

was then read a second time and assigned

for tomorrow morning.
On motion of Mr. Dudley of Augusta, bill, An Act to extend the charter of the Bluehill Trust and Banking Company was taken from the table, and on further motion by the same gentleman the bill was re-committed to the committee on banks and banking.

On motion of Mr. Josselyn of Portland, bill, An Act to regulate the sale and analysis of concentrated commercial feeding

stuffs, was taken from the table.

Mr. Josselyn further moved that the bill be re-committed to the committee on agriculture with instructions to return to agriculture with instructions to return to this House in new draft, providing for the appropriation for the operating expenses of the bill of \$1000 for the year 1903 and \$1000 for the year 1904, instead of the pro-posed annual tax of \$60 per annum; also to eliminate from the bill any and all parts of same inconsistent with these instructions

The motion was agreed to and the bill was re-committed with instructions.
