By Mr. Powers of Houlton: Bill, an act to amend section 9 of chapter 81 of the Revised Statutes relating to the appointment of deputy clerk of courts.

By Mr. Thurlough of Fort Fairfield: Petition of D. E. Edwards and 25 others of Fort Fairfield for an act preventing the throwing of refuse into the Aroostook river.

Ways and Bridges.

By Mr. Sawyer of Milbridge: Resolve in aid of repairing the bridge across the Narcaguagus river in the town of Milbridge.

Also petition for aid to repair Great Bridge, Milbridge, Washington county.

Inland Fisheries and Game.

By Mr. Newbegin of Gray: Bill, an act to prohibit fishing in the tributaries of Little Sebago lake in Gray and Windham, Cumberland county.

By Mr. Walker of Lovell: Petition of Harold L. Gray and others of Fryeburg asking that gray squirrels be protected on certain lands in Fryeburg.

By Mr. Blanchard of Blanchard: Bill, an act to regulate fishing in Marble brook, Marble pond, Chase brook or Blackstone brook, and Bolt brook, in Piscataouis county.

By Mr. Littlefield of Rockland: Petition of W. E. Vinal and 15 others in relation to fishing in Branch and Meadow brooks in Thomaston and Rockland.

By Mr. Sawyer of Milbridge: Bill, an act to repeal the first clause of subdivision entitled "In Washington county," of section one of chapter 407 of the private and special laws of 1903, entitled "An act to consolidate and revise

certain laws relating to closing certain lakes and ponds to ice-fishing, etc."

An act to authorize the Dover Gas Light Company to acquire the property and franchises of the United Gas and Electric Company.

An act to authorize the United Gas and Electric Company to sell its propLight Company.

An act to authorize the construction of a wharf or wharves into the tide waters of the Penobscot river in Bucksport.

Resolve in favor of the Young Woman's Home at Lewiston.

Passed to be Enacted.

An act relating to the Winthrop and Wayne Light and Power Company.

An act to regulate fishing in Cobbosseecontee stream, Kennebec county.

An act to amend chapter 227 of the private and special laws of 1880 entitled, "An act to supply the people of Houlton with pure water," as amended by chapter 497 of the private and special laws of 1889, as amended by chapter 148 of the private and special laws of 1903.

Finally Passed.

Resolve in favor of the purchase of the Maine State Year Book and Legislative Manual for the year 1905-6.

On motion of Mr. Turner of White-field the rules were suspended and that gentleman introduced bill, an act to assist in building a bridge across the Penobscot river betwen the towns of Wiscasset and Edgecomb, and on further motion by Mr. Turner it was referred to the committee on ways and bridges.

On motion of Mr. Tupper of Bangor the rules were suspended and that gentleman introduced a petition of William Thompson and others asking that certain islands be set off from Jonesport and annexed to Roque Bluffs, and on further motion by Mr. Tupper the petition was referred to the committee on towns.

On motion of Mr. Treworgy of Surry the rules were suspended and that gentleman introduced a petition of Dr. W. E. Emery and others to enact legislation that will be for the best interests of said petitioners and on further motion by Mr. Treworgy the petition was referred to the committee on appropriations and financial affairs.

On motion of Mr. Wilder of Pembroke the rules were suspended and that gentleman introduced a petition of J. C. Rogers, M. D., and 15 others of Pembroke for legislation that will be

for the best interests of the State and people interested, and on further motion by Mr. Wilder the petition was referred to the committee on appropriations and financial affairs.

On motion of Mr. Fawsette of Garland the rules were suspended and that gentleman introduced a petition of W. A. Bumps, M. D., and 14 others to enact legislation that will tend to forward the best interests of the petitioners, and on further motion by Mr. Fawsette the petition was referred to the committee on appropriations and financial affairs.

Papers from the Senate disposed of in concurrence.

Orders of the Day.

On motion of Mr. Tupper of Bangor House document No. 23, an enabling act authorizing the city of Bangor to change its charter, was taken from the table, and on further motion by the same gentleman it was referred to the Bangor Delegation.

Mr. Swett of Portland moved that the use of Representatives' Hall be extended to the committee on appropriations and financial affairs for a hearing on appropriation for the institution and workshop for the blind, on Thursday afternoon, February 9, at 2 o'clock.

Mr. SWETT: Unless it may occasion some confusion for our committee I will say that I ask this, not for the committee on appropriations and financial affeirs, but for the friends of the institution.
