Wednesday, February 1, 1905. Prayer by Rev. Mr. Josselyn Gardiner.

Journal of yesterday read and approved.

Papers from the Senate disposed of in concurrence.

Bill, an act to prohibit sales of merchandise in bulk in fraud of creditors, referred in the Senate to the committee on the judiciary, was tabled in House for printing pending its reference in concurrence, on motion of Mr. Reed of Portland.
