#### HOUSE.

Thursday, Feb. 2, 1905.

Prayer by Rev. Mr. Hope of Augusta.
Journal of yesterday read and approved.

Papers from the Senate disposed of in concurrence.

The House order directing the committee on towns to inquire into the claims of towns for reimbursement for one-half of the money they have actually raised and expended on State roads, under the provisions of Chapter 23 of the Revised Statutes, and report by bill, resolve or otherwise, comes from the Senate amended by striking out the word "towns" and inserting the word "claims."

The House reconsidered the vote whereby the order received a passage, the amendment was adopted and the order then received a passage as amended.

Resolve in favor of the Waldo General hospital comes from the Senate, that branch having rejected the report of the committee on appropriations and financial affairs reporting "ought not to pass" and having recommitted the resolve to the committee.

In the House the report of the committee was accepted in non-concurrence.

Mr. POOR of Belfast: Mr. Speaker, the report of the committee was thoroughly investigated in the Senate and it appears that the committee on appropriations and financial affairs did not have a satisfactory hearing owing to the attorney employed by the hospital being unable to be present, and also on account of the storm which prevented many ladies of the Hospital Aid Society from being present. The Senate voted to recommit the resolve to the committee, and if it is in order I move that the vote be reconsidered whereby the House accepted the report of the committee and that the resolve be recommitted to the committee on appropriations and financial affairs in concurrence with the Senate.

The question being on reconsidering the vote whereby the report of the committee was accepted, the motion was agreed to.

The question then being on concur-

ring with the Senate in recommitting the resolve to the committee on appropriations and financial affairs, the motion was agreed to.

An Act to incorporate the Island Falls Water Company.

Resolve in favor of the trustees of the University of Maine. (Tabled pending its second reading on motion of Mr. Higgins of Limerick.)

An Act to provide for the treatment of persons suffering from the effects of habitual use of narcotics.

Resolve in favor of the Aroostook Normal school.

## Senate order passed in concurrence. Passed to be Enacted.

An Act to authorize the Northern Seaport Railroad Company to lease or sell its railroad to the Bangor & Aroostook Railroad Company.

An Act to authorize the Northern Maine Seaport Railroad Company and the Bangor Investment Company to build wharves and piers in and near Cape Jellison Harbor.

An Act to authorize the Northern Maine Seaport Railroad Company to locate and build its road across an inlet of Cape Jellison Harbor,

An Act to authorize the Northern Maine Seaport Railroad to locate across tide waters of Passagassawaukeag river.

An Act to authorize the Bangor & Aroostook Railroad Company to guarantee the first mortgage bonds of the Northern Maine Seaport Railroad Company.

#### Orders of the Day.

On motion of Mr. Higgins of Limerick, Bill, An Act to amend Chapter 11 of the Revised Statutes was taken from the table.

Mr. Higgins offered an amendment to the title by adding thereto the words, "relating to the recording of deeds," so it shall read, "An Act to amend Chapter II of the Revised Statutes relating to the recording of deeds."

The amendment was adopted and the bill as amended was then referred to the committee on legal affairs.

On motion of Mr. Downs of Berwick, Adjourned.
