#### HOUSE.

Friday, February 3, 1905.

Prayer by Rev. Mr. Hayden of Augusta.

Journal of yesterday and read and approved.

Papers from the Senate disposed of in concurrence.

#### Senate Bills on First Reading.

Resolve for the purpose of operating fish hatcheries and feeding stations for fish and for the protection of fish.

Resolve in favor of the president and trustees of Bowdoin College.

An act to amend chapter 407 of the private and special laws of 1903 relating to fishing in Long pond. Hancock county.

This comes from the Senate amended by Senate amendment A, by adding thereto, "This act shall take when approved." In the House amendment was adopted, and the bill was then read a second time as amended and assigned for tomorrow morning.

An act to repeal section 15 of chapter 33 of the Revised Statutes relating to bounties on porcupines.

In the House the report of the committee reporting ought to pass had been accepted and the bill passed to be engrossed, and it now comes from the branch non-concurring Senate that with the House in passing the bill to be engrossed, and recommitting the bill to the committee on legal affairs.

Mr. POWERS of Houlton: Speaker, I move that the House insist upon its former action in this matter. This was a matter which was heard before one of our strongest committees, after a proper notice for hearing was given and the committee unanimously reported that the bill ought to pass, and this House has agreed with the committee. I see by the papers that it is sent back to us under the terms of senatorial courtesy, which some people have been so uncharitable as to call child's play. Τ move that we insist on our former action.

By Mr. O'Brien of Lewiston: Bill, an act to amend section 22 of chapter 6 of the Revised Statutes of 1903 relative to the arrangement of voting shelves in the ward room.
