Mr. Reed from the committee on legal affairs on bill, an act to regulate and define the practice of optometry, reported ought not to pass.

Mr. Littlefield from the committee on judiciary, to which was referred the thirteenth report of the State Board of Health, reported legislation unnecessary.

Mr. Littlefield from same committee, on report of the commissioners on uniformity of laws for 1902, reported legislation unnecessary.

Mr. Gray from the committee on legal affairs reported ought not to pass on bill, an act to amend chapter 11 of the Revised Statutes relating to the recording of deeds.

Mr. Bliss from the committee on pensions reported ought not to pass on bill, an act to amend section four of chapter 145 of the Revised Statutes relating to the State pension law.

Mr. Kimbail from the committee on railroads and expresses, on bill, an act in relation to fares upon Washington County Railway, reported ought not to pass, legislation being inexpedient at the present time.

Mr. O'BRIEN of Lewiston: Mr. Speaker, I move that that report be laid on the table pending acceptance.

Mr. KIMBALL of Rockland. I would inquire of the gentleman if he wishes to table the bill at the request of Mr. Stevens, a member of the committee.

Mr. O'BRIEN: I cannor say that exactly, sir.

Mr. KIMBALL: The reason I ask the question is because when the first report of the committee was made there was a majority and minority report, Mr. Johnson of Calais putting in a minority report solely for the purpose of protecting his rights, and it was understood that the matter should be laid on the table this morning until Friday morning. Since that time Mr. Johnson has withdrawn his minority report which makes it a unanimous report of

the committee, and that matter was left in the hands of Mr. Stevens; and Mr. Stevens, I see, is absent, and I did not know but what you might be acting for him in the matter.

Mr. O'BRIEN: I moved that it lie on the table in order that I might be able to better inform myself as to its conditions.

The question being to lay the report on the table pending acceptance,

The motion was agreed to.

Mr. KIMBALL: I would ask the gentleman from Lewiston to assign a time to take it from the table.

Mr. O'BRIEN: I would say Friday morning, Mr. Speaker.

The SPEAKER: The chair understands that it is assigned for Friday morning?

Mr. O'BRIEN: Yes, sir.

Mr. Thompson from the committee on interior waters on bill, an act to incorporate the Penobscot River Power Company reported that the same be referred to the next Legislature.

Mr. Holmes from the committee on legal affairs on bill, an act to regulate the practitioners of optometry in the State of Maine, reported that the same be referred to the next Legislature.

Mr. Gray from same committee on petition of E. S. Dixon and 13 others praying for the enactment of bill presented by the Grange legislative committee, reported that the same be referred to the committee on taxation.

Mr. Baxter from the committee on legal affairs on petition of A. S. Lord and 14 others in favor of legislation to prohibit sales of merchandise in bulk in fraud of creditors, reported the same be referred to the committee on the judiciary.

Mr. Holmes from the committee on legal affairs on bill, an act to establish the Caribou Municipal Court, reported that the same be referred to the Aroostook county delegation.

Mr. Newcomb from the committee on judiciary reported ought to pass on bill, an act to provide for recording of condemnation proceedings.

Mr. Johnson from the same committee reported ought to pass on bill, an act to incorporate the Messalonskee Electric Company.

Mr. Merrill from the same committee reported in a new draft bill, an act to enlarge the corporate rights of the Piscataquis Woolen Company to do electric lighting, and that it ought to pass.

Mr. Merrill from same committee reported ought to pass on bill, an act to extend the charter of the Caratunk Power Company.

Mr. Weatherbee from the committee on legal affairs reported ought to pass on bill, an act to amend section 25 of chapter 114 of the Revised Statutes relating to the relief of poor debtors.

Mr. Oakes from the same committee reported ought to pass on bill, an act additional to section 12 of chapter 107 of the Revised Statutes relating to easements.

Mr. Reed from the same committee reported ought to pass on bill, an act to incorporate the Farmington Society for the Prevention of Cruelty to Animals.

Mr. Holmes from the same committee reported ought to pass on bill, an act to organize Portage Lake Plantation.

Mr. Holmes from the same committee reported ought to pass on bill, an act to legalize the doings of the town of Masardis.

Mr. Gray from the same committee reported ought to pass on bill, an act to incorporate the president and trustees of the Farmington Home for Aged People.

Mr. Reed from same committee reported ought to pass on bill, an act to amend chapter 242 of the private and special laws of 1895 entitled "An act to incorporate the city of South Portland."

Mr. Reed from same committee reported in a new draft bill, an act authorizing and ratifying the construction and maintenance of a wharf from Macworth or MacKay's Island, so called, into the tide waters of Casco Bay in the town of Falmouth, Maine.

Mr. Baxter from same committee reported in a new draft bill, an act to abolish the common council and increase the membership of the board of aldermen of the city of Portland, and that it ought to pass.

Mr. Purinton from the committee on agriculture reported ought to pass on

bill, an act regulating the duties of the commissioner of agriculture relating to the manufacture and sale of dairy products and their imitations.

Mr. Purinton from same committee reported ought to pass on bill, an act to regulate the sale of imitation dairy products.

Mr. Purinton from same committee reported in a new draft bill, an act to regulate the sale of milk and cream, and that it ought to pass.

Mr. Sargent from the committee on interior waters reported cught to pass on bill, an act to authorize the Sebec Lake Lumber Company, its successors and assigns, to maintain a wharf and boom in Sebec Lake.

Mr. Davis from the same committee reported ought to pass on bill, an act granting Beioni Hebert and sons the right to erect and maintain piers and booms on the St. John river in the town o' Madawaska.

Mr. Percy from same committee reported ought to pass on bill, an act to authorize Joseph Long to build and maintain a toll bridge for foot passengers across the St. John river at or near Fort Kent and to build and maintain piers and abutments for supporting said bridge.

Mr. Sargent from same committee reported ought to pass on bill, an act to amend section one of chapter 274 of the private and special laws of 1901.

Mr. Thompson from same committee reported in a new traft bill, an act relating to the prevention and control and extinguishment of forest fires in plantations and unorganized townships, and that it ought to pass.

Mr. Bliss from the committee on pensions reported in a new draft resolve in favor of Harry B. Conway of Calais, and that it ought to pass.

Mr. Sparrow from the same committee reported in a new draft resolve in favor of Miss Fannie L. Jenkins of Newport, Maine, and that it ought to pass.

The reports were accepted and the bills and resolves ordered printed under joint rule.

Mr. Sewall from the committee on salaries to which was referred the report of the special committee on salaries and fees, reported accompanying bill, an act relating to bills of expenses of State and County officers.

Mr. SEWALL of Bath: Mr. Speaker, this is a very important bill affecting the salaries of State officers, and I think it would be advantageous to have it printed before acceptance of the report. As chairman of the committee on the part of the House I would like very much to have this bill thoroughly examined before the report is accepted. I move that this report lie on the table pending acceptance and that the accompanying bill be printed.

The motion was agreed to.

Mr. Sewall from the committee on salaries, to which was referred the report of the special committee on salaries and fees, reported an accompanying bill, an act relating to the compensation of trustees and visiting committees and the board of cattle commissioners. (Report tabled pending acceptance and bill ordered printed on motion of Mr. Sewall.)

On motion of Mr. Nash of Damariscotta, these petitions were referred to the committee on legal affairs.

On motion of Mr. Johnson of Hallowell, bill for change in the charter of the city of Hallowell was taken from the table, and on further motion by Mr. Johnson the bill was withdrawn by unanimous consent.

Mr. Trompson of Orono, stated that he had received from Henry Lord, President of the University of Maine, a detailed statement of salaries paid at the University of the Unive sity of Maine, in response to House order of February 16th, and moved that the same be tabled for printing.

The motion was agreed to.

On motion of Mr. Powers of Houlton, bill in relation to lands reserved for public uses in plantation of Kingsbury, was taken from the table.

The bill was then read twice and assigned for tomorrow morning for its third

reading.

On motion of Mr. Putnam of Danforth, the rules were suspended and that gentleman introduced a resolve making appro-priation for repairs of bridge across St. Croix river at Baring, and on further mo-tion by Mr. Putnam it was referred to the committee on ways and bridges.
