Senate Bills on First Reading.

Resolve in favor of Mathias A. Culnan of Belfast.

An act to enable the Sebago Lake, Songo River and Bay of Naples Steamboat Company to construct and maintain a wharf at the foot of Long Lake in the town of Naples, county of Cumberland.

This bill comes from the Senate amended by Senate amendment "A." In the House the amendment was adopted, the bill was read twice and assigned for tomorrow morning for its third reading.

Mr. MORRISON of Eden: Mr. Speaker, I have a resolve to introduce out of order and I wish to explain it so that the members of the House may understand its nature. Last evening at the Ball ex-Governor Robie asked me if I would introduce this resolve and a copy of the will of the late Helen A. Gliman, of Portland.

The will provides that one thousand dollars be given to the State of Maine Insane Asylum at Augusta, this to be held in trust by the State Treasurer, provided that not less than fifty dollars a year be appropriated by the Legislature for the pleasure and entertainment of the patients at the asylum.

Now, this may seem to be a rather high rate of interest to pay, but when you consider who this lady was, Mrs. Gilman, I do not think you will object to accepting this bequest. Mrs. Gilman was a daughter of Honorable Reuel Williams of Augusta. Dr. Sanborn informed me that in

about 1832 Hon. Reuel Williams came to about 1832 Hoh. Reuel Windams came to the State Legislature and offered to give the sum of twenty thousand dollars to the State provided that the State would give a like amount to found an insane asylum here in Augusta. It was accepted and he gave the twenty thousand dollars, and the building of an insane asylum was com-menced over across the river. Now, later on his son, a brother to this Mrs. Gilman, gave to the State of Maine one thousand dollars provided that the State appropri-ate forty dollars a year for the insane asylum at Augusta. I ask, Mr. Speaker, that the rules be suspended that I may have the honor and the opportunity of introducing this re-solve at the present time.
