#### SENATE.

Tuesday, February 14, 1905. Senate called to order by the President.

Prayer by the Rev. Mr. Hayden of Augusta,

Journal of yesterday read and approved.

Papers from the House disposed of in concurrence.

#### House Bills Read and Assigned.

An act granting additional powers, rights and privileges to the Bodwell Water Power Company of Oldtown, Maine.

The President announced that the "Order to investigate the office of State liquor commissioner," had been returned by the House, with committee joined on the part of the House.

The following bills, petitions and resolves were presented and referred:

#### Judiciary.

By Mr. Allen of York: Bill, an act to incorporate the Saco River Electric Power Company.

Also, Bill, an act to amend section 35 of chapter 65 of the Revised Statutes relating to costs of contested cases.

By Mr. Gardner of Penobscot: Bill, an act to extend the charter of the Patten Telegraph and Telephone Company.

By Mr. Shaw of Sagadahoc: Petition of H. D. Hammond and 34 others, officers and policy holders of the Oxford Co. People's Mutual Fire Insurance Co. of South Paris against any change in the Maine Standard Policy.

Also, petition of M. J. Dow and 16 others of Plymouth, against same.

Also, petition of M. S. Littlefield and 14 others, against same.

Also, petition of Joseph White and 2 others of West Bath against same.

By Mr. Stetson of Penobscot: Bill, an act to extend the charter of the Tyler-Fogg Trust Company.

By Mr. Gardner of Penobscot: An act to extend and amend the charter of the Patten Trust Company.

#### Agriculture.

By Mr. Simpson of York: Petition of H. H. Clark and 34 others asking for assistance to help destroy the browntail moth.

#### Interior Waters.

By Mr. Owen of Piscataquis: Petition of A. S. Drinkwater and 70 others in aid of bill, an act authorizing use of boats on Sebec river between Milo and the rips in said river for the purpose of transporting passengers and freight.

#### Inland Fisheries and Game.

By Mr. Bailey of Somerset: Petition of citizens of Hartland, Harmony, Palmyra and Athens for a close time on muskrats in those towns for a term of years to prevent their extinction.

#### Shore Fisheries.

By Mr. Clark of Hancock: Petition of F. E. Sherman and 50 others to prevent the use of purse and drag seines.

By Mr. Shackford of Washington: Remonstrance of Freedom Ramsdill and 37 others of Harrington against any change in the law for fishing for smelts in Harrington river.

Also, Protest of John E. Stewart and 35 others of Columbia against any change in the present law as to taking fish of all kinds in harbors and rivers except as by the present law provided, and that purse and drag seines be forbidden.

Also, protest of J. W. Allen and 24 others of Addison, against any change in smelt law in Pleasant river.

By Mr. Mills of Hancock: Petition of R. E. Dority and 35 others of Sedgwick relative to the use of purse and drag seines.

By Mr. Furbish of Franklin: Petition of Anson M. Oliver and 48 others of Georgetown and Phippsburg against resubmitting the 5th amendment to the constitution of Maine to a veto of the people.

Also, Petition of Willis Richardson and 18 others of Brooks, against same.

#### Salaries.

Mr. STETSON of Penobscot: Mr. President: I present an act making the salary of the Governor \$3000 per year, after January 1, 1907.

I wish to state that the chief executive has not been consulted in this matter. I have put it in by request of the committee on salaries, and I move its reference to that committee.

The motion prevailed.

#### Orders.

Mr. STETSON of Penobscot: Mr. President, I wish to say that I was requested to present an order which carries out the provisions of an order that was put in here some weeks ago by Senator Allen of York County, limiting the time for special legislation. I put this in at his request, but I wish to reserve my right to oppose the passage of the order.

The PRESIDENT: I will read the order for the benefit of the Senate: Ordered, the House concurring, that the time for the reception of bills and of petitions for private and special legislation be and hereby is entended to and including Tuesday, February 21, 1905.

Mr. ALLEN of York: Mr. President: I desire to state, at this time, that I am opposed to the passage of this order. The people of Maine interested in private legislation have had two years notice of the time this legislature would be in session. The first week of this session I introduced an order fixing today as the time limit for introducing private matters. I think the people have had ample opportunity

to prepare and present to this Legislature any matters which they may be interested in. My order was introduced at the time with the view of completing our duties here, as promptly and faithfully as possible, with a view to early adjornment; and if this order does not receive a passage and we attend to our duties here promptly, as we should, there is no reason why we cannot adjourn by the 10th or 15th of March, and return to our homes, no doubt much to the gratification and pleasure of our constituents; and have the Legislature adjourned, and out of the way.

#### Orders of the Day.

On motion by Mr. Staples of Knox: Resolve in favor of Maine General hos-

pital was taken from the table. On further motion by the same senator the same took its first reading and was assigned.

On motion by Mr. Tupper of Lincoln: Bill, "An Act repealing Chapter 443 of the Public Laws of 1901, relating to annual town meeting of Boothbay Harbor," was taken from the table. House report accepted in concurrence. The same senator offered Senate amendment A namely: Amend by striking out all of Section 2 and inserting the following: Section 2. At the annual town meeting to be held in January A. D. 1906, the legal voters of the town of Boothbay Harbor shall be called upon to give their vote upon the acceptance of this act. The vote shall be taken upon a written or printed ballot and shall be in answer to the following question: Shall the Act passed at the Legislature of nineteen hundred and five, entitled "An Act repealing Chapter 443 of the Public Laws of nineteen hundred and one, relating to the annual town meeting of Boothbay Harbor" be accepted? Those in favor of the acceptance shall vote "Yes" and those opposed "No." So much of this act as authorizes the submission of the question of its acceptance to the legal voters of the town of Boothbay Harbor, shall take effect upon its passage, but it shall not take further effect unless accepted by the legal voters of said town by a majority vote given upon the acceptance as herein provided." motion of the same senator, Thursday of this week, was assigned for consideration of the acceptance of the amendment.

On motion by Mr. Gardner of Penobscot, the vote whereby bill, "An Act to authorize the Northern Telegraph Company to extend its lines along the Northern Maine Seaport Railroad and to increase its capital stock" was passed to be enacted, was reconsidered. On further motion by the same senator the bill was tabled.

On motion by Mr. Allen of York, bill, An Act to provide for the appointment of receivers of corporations," was taken from the table. On further motion by the same senator, the bill was referred to the committee on judiciary.

On motion by Mr. Furbish of Frank-

lin, the vote whereby bill, "An Act to amend Section 1 of Chapter 26 of the private and Special Laws of 1887 as amended by Chapter 487 of the Private and Special Laws of 1899 relating to taxation of certain plantations" was passed to be engrossed, was reconsidered. On further motion by the same senator Senate amendment A adopted, namely: "Amend House Document 69 by prefixing the following: An Act to amend Section 1 of Chapter 26 of the Private and Special Laws of 1887, relating to taxation of certain plantations.

The President: The Chair will state to the Senate that the title of the original bill was not put in. The printers put in in the printed bill; and the proposed in the printed bill; and the proposed amendment offered by the Senator from Franklin is simply to give the bill a title. The bill as amended was passed to be

House Concurrent Resolution No. 10. Resolved by the House of Representatives of the 23d legislative assembly of the Territory of Arizona, the Council concur-

That we appeal to the justness and fairness of the members of the various state legislatures now in session, and call upon them to request and urge their respective representatives in the Senate of the United States to give careful and just consideration to the protest and objections advanced by the citizens of the territory of Arizona against the passage of the measure now pending before the Senate of the United States, designed and seeking to make one state of the territories Arizona and new Mexico.

Resolved that the Speaker of the House and the President of the Council be in-structed and they are hereby directed to send a copy of this resolution to the various state legislatures that are now
