#### SENATE.

Tuesday, March 7, 1905.

The Senate called to order by the President.

Prayer by Rev. Mr. Tanberg of Gardiner.

Reading of the records of yesterday read and approved.

Papers from the House disposed of in concurrence.

Resolve providing for an amendment to the constitution of the State, relating to the taxation of lands in unincorporated townships, and wild lands, so called, in the plantations. This resolve came from the House, having been referred in that branch to committee on legal affairs. On motion by Mr. Putnam of Aroostook this resolve was tabled pending reference in concurrence.

On motion by Senator Pierce of Aroostook petition of D. McDonald and 37 others of Machias, relating to passage of bill giving blacksmiths a lien on their work, was placed on file; also the same for petition of D. H. Libby and 26 others.

Senator Staples of Knox on the petition of Rev. C. A. Briggs and 101 others of Norway for the passage Sturgis bill; also petition of George A. Purington and 64 others of Farmington, in relation to the same, moved that the Senate non-concur, and on motion of the same Senator the same were placed on file.

#### House Bills Read and Assigned.

An act ceding to the United States jurisdiction over certain exclusive lands acquired for public purposes in this State, and authorizing the quisition thereof.

On motion of Mr. Mills of Hancock, bill, "An act to abolish the common council, and to increase the membership of the board of alderman of the city of Portland," was tabled.

An act to amend section 93 of chapter 4 of the Revised Statutes, relating to town and city by-laws and ordinances.

An order of the Legislature relating to the pay of out-going clerk and assistant clerk during the organization of the House, with report accompanying son for asking a suspension of the same, "Resolve in favor of W. S. rules, and the privilege of presenting

Cotton," which was read and assigned. Thursday was assigned for the consideration of this report.

An act pertaining to the duties the cattle commissioners.

Resolve in favor of Mrs. Fannie L. Jenkins of Newport, Maine, for State aid.

An act relating to the compensation of commissioners of inland fisheries and game. Tuesday was assigned for the consideration of this report.

An act relating to the compensation of certain State officers. On motion of Senator Staples of Knox this tabled and Thursday assigned for its consideration.

An act to enlarge the duties and fix the compensation of the attorney-gen-On motion of the same Senator eral. tabled, and Thursday assigned.

Senate Document No. 71 came from the House amended by House Amend-A, "Amend by inserting House Amendment A by inserting in section 4, line 8, after the word establish, 'under such reasonable restrictions and conditions as the selectmen of the town may impose,' so that said section as amended shall read as follows:"

Mr. Pierce of Aroostook .thereupon moved that the vote whereby this bill was passed to be engrossed be reconsidered, and the motion prevailed.

Mr. PIERCE of Aroostook: Mr. President, I desire to present a petition relative to amendment of the city charter of the city of Gardiner.

the same at the present time, is, Senator Heselton of Kennebec has been very ill, and therefore has been unable to take care of the matter. The matter has been endorsed by the citizens of Gardiner almost wholly, as I believe, and therefore I ask the privilege of presenting it at the present time.

Thereupon the bill, "An act to amend the city charter and city ordinances of the city of Gardiner, in relation to the election of the city marshal and the street commissioner," was presented and received, and upon motion by the same Senator was referred to the committee on legal affairs.

Senator Heselton of Kennebec, presented remonstrance of Rev. Osborne J. Hoffman and others of Winthrop against the passage of any act that shall permit sacred concerts on the Sabbath, which on the same Senator's motion was referred to the Committee on judiciary.

Mr. Clark of Hancock presented bill, "An act to amend section 88 of chapter 84 of the revised statutes, relating to the changing of jurors, which was referred to the committee on legal affairs.

Mr. Putnam of Aroostook presented resolve in favor of William H. Reid, State binder, which was referred to the committee on appropriations and financial affairs.

Mr. Brown of Kennebec presented petition of Norman K. Fuller and 42 others of Waterville against the passage of the manslaughter bill; and on motion by same Senator the same was placed on file.

Mr. Tartre of York presented petition of J. B. Jordan and 11 others of Saco, asking for the proper enforcement of the liquor law, which was referred to the committee on temperance.

Mr. Mills of Hancock presented petition of F. H. Smith and 25 others, in favor of enforcement of legislation relative to the prohibitory law, which was referred to the committee on temperance.

Mr. Potter of Cumberland presented petition of Felix Powell and others for the proper labeling of proprietary medicines.

Mr. Tartre of York presented petitions of J. B. Jordan and 12 others of Saco; also petition of J. Newton Brown of Eliot and 13 others; all for the proper labeling of proprietary medicines containing alcohol and narcotic drugs; and the same were referred to the committee on temperance.

Mr. Bailey of Somerset presented petition of Rev. Osburne J. Hoffman of Winthrop and others, relating to the same matter; which was referred to the same Committee.

The same Senator presented the petition of Rev. L. D. Libby and 61 others, citizens of Brighton, urging the passage of an act providing for the proper labelling of proprietary medicines, etc., and same was also referred to the Committee on Temperance.

The same Senator presented petition of F. G. Davis and 15 others of Norridgewock, requesting the enactment of the Milliken bili; also of W. H. Lang and 38 others for same; which was referred to the Committee on Temperance.

Mr. Heselton of Kennebec presented petition of W. T. Reynolds and others in favor of the act which provides for the proper labelling of proprietary medicines containing alcohol.

Mr. Curtis of Cumberland presented a remonstrance against bill relating to the labelling of proprietary medicines, 44 names; also a similar remonstrance against same containing 15 names, by the same Senator and referred to the same Committee.

Mr. Irving of Aroostook presented petition of J. L. Pinkerton and 4 others of Mars Hill, relative to the labelling of proprietary medicines, which was referred to the same Committee.

Mr. Brown of Kennebec presented petition of C. W. Jones and 19 others, citizens of China, in favor of an act providing for the proper labelling of proprietary medicines, etc., which was referred to the same Committee.

Mr. Allen of York presented petition of Herbert Tilden and 31 others for same, which was referred to the same Committee.

Mr. Ayer of Kennebec presented remonstrance of Norman K. Fuller and 43 others of Waterville, against the

passage of the Potter Manslaughter York and adopted. bill, which was placed on file.

Mr. Ayer of Kennebec presented petition of G. B. Youngman and 35 others took, "Resolve in favor of the town of of Oakland, in favor of the proper labelling of proprietary medicines, and the same was referred to the Committee on Temperance.

Also petition of Jackson Cayford and 18 others of Oakland in favor of same, which was placed on file.

#### Orders.

On motion of Mr. Potter of Cumberland it was ordered that a message be sent to the Governor and Council, requesting the return of "an act to amend the act of February 9, 1905, in relation to the assessment of taxes on the estates of deceased persons before the appointment of executors or administrators of such estates."

Mr. POTTER: Mr. President, I want to say in just a word that the bill referred to in that order cannot accomplish its object unless it takes effect on approval. That provision was omitted from the bill, and the purpose of recalling it from the Governor is to have that omission supplied. I would also say that no member of the Senate is responsible for the errors of the bill. as no one examined it with care when it was rushed through the other day, and I have an amendment to offer when it is returned if it is returned.

The order received a passage.

On motion of Mr. Putnam of Aroostook, House document 113, Resolve in favor of Jackman plantation, was taken from the table and the report of the committee was adopted. Mr. PUTNAM of Aroostook: President, before the vote is taken I wish to make a brief statement. These resolves properly are paid out of emergency funds, which amount to \$8000 a year. I think there is no doubt but they will be allowed.

On motion by the same senator the Senate concurred in the acceptance of the report of the committee thereon. The bill thereupon took its first reading and on further motion by the same senator, Senate amendment A,--"Add to Section 1 the following words: 'and pay from any funds in the treasury not otherwise appropriated," was adopted. On further motion by the same senator, under suspension of the rules, the bill took its second reading and was passed to be engrossed.

Mr. MILLS of Hancock: Mr. President, last Friday, I introduced a resolve calling for a special appropriation for the Gorham Normal school and made the statement that it was introduced at the request of the trustees of State Normal schools.

On motion by the same senator the report of the committee on judiciary on table documents Nos. 22 and 23, that the petitioners "have leave to withdraw," relative to similar subject matter, were accepted in concurrence; and on further motion by the same senator said reports were severally accepted in concurrence.

On motion by Mr. Knowlton of Penobscot, the Senate adjourned to meet, on Wednesday, March 8, 1905, at 10 o'clock in the forenoon.
