HOUSE.

Thursday, Jan. 3, 1907.
Prayer by Rev. Mr. Hope of Augusta.
Papers from the Senate disposed of in concurrence.

On motion of Mr. Irving of Presque Isle.

Ordered, That the Maine Federation of Women's Clubs be allowed the use of Representatives' hall for a public meeting Wednesday, Jan. 23, 1907.

The Speaker joined to the Senate committee to wait upon the Hon. William T. Cobb and inform him that he had been duly elected Governor of the State of Maine for the current political years of 1907 and 1908, Messrs. Peacock of Lubec, Hill of Monticello, Emery of Jay, Stearns of Norway, Farnham of Bath, Toleman of Portland and Thomas of Harpswell.

Mr. Peacock subsequently reported that the committee had discharged the duty assigned it, and that the Governor-elect was pleased to say that he accepted the office to which he had been elected, and would attend at such place and time as it might please the Legislature to designate for the purpose of taking the oaths required by the constitution to enable him to enter upon the discharge of his official duties.

A communication was received from the Senate through its secretary, proposing a joint convention of the two branches of the Legislature forthwith in the hall of the House of Representatives for the purpose of administering to the Hon. William T. Cobb, governor-elect, the oaths required by the constitution to enable him to enter upon the discharge of his official duties.

On motion of Mr. Mullen of Bangor, the Clerk was charged with and conveyed a message to the Senate signifying the concurrence of the House in the proposition for a convention.

Thereupon the Senate came in and a convention was formed,

IN CONVENTION.

On motion of Senator Sewall, Messrs. Sewall of Sagadahoc, Park-

hurst of Penobscot, Perkins of Kennebunkport, Knowlton of Monson, Dondero of Chelsea, Wood of Bluehill and Lynch of Washington, were appointed a committee to wait upon the Hon. William T. Cobb, governor-elect, and inform him that the two branches of the Legislature were in convention assembled in Representatives' hall, ready to administer to him the oaths required by the constitution to qualify him to enter upon the discharge of his official duties, and receive from him such communication as he might be pleased to make.

Senator Sewall subsequently reported that the committee had discharged the duty assigned it and that the governor-elect was pleased to say that he was ready to take the necessary oaths of office and would forthwith attend upon the convention.

Thereupon the governor-elect came in, attended by the council and heads of departments, and took and subscribed the oaths necessary to qualify him to enter upon the discharge of his official duties.

The Governor then communicated with the convention by address.

The Governor and suit then retired. The purposes for which the convention was called having been accomplished, it was dissolved and the Senate retired.

IN THE HOUSE.

The Speaker joined on the part of the House to the Senate committee to consider the Governor's message and report a reference of its several subjects to appropriate committees, Messrs. A communication was received from the Senate proposing a joint convention of the two branches of the Legislature forthwith in Representatives' hall for the purpose of electing a secretary of State, State treasurer, attorney general, commissioner of agriculture, State assessor, State binder and seven Exgcutive Councilors.

On motion of Mr. Montgomery of Camden the House concurred in the proposition, and the clerk was charged with and conveyed a message to the Senate to that effect.

Thereupon the Senate came in and a convention was formed.

and the Hons. Leroy F. Pike, Thurston S. Burns, W. Scott Libby, Charles D. Newell, Thomas G. Libby, Angus O. Campbell and Charles F. Daggett of their election as executive councillors.

The secretary subsequently reported that he had discharged the duty assigned him.

On motion of Senator Irving of Aroostook that gentleman was directed to inform the councillors-elect that the two branches of the Legislature were assembled in Representatives hall ready to administer to them the oaths required by the constitution to qualify them to enter upon the discharge of their official duties.

Senator Irving subsequently reported that he had performed the duty assigned him, and that the councillorselect were pleased to say that they would attend upon the convention for the purpose indicated.

Thereupon the councillors-elect came in and took and subscribed the oaths necessary to qualify them to enter upon the discharge of their official duties.

On motion of Senator Parkhurst of Penobscot, the secretary of the convention was charged with and conveyed a message to the Governor informing him of the election of the various State officers.

. The purposes for which the convention was formed having been accomplished, it was dissolved and the Senate retired.
