By Mr. Murphy of Portland—Petition of John J. Frye and 25 others of Portland for the creation of the Portland Water District.

## Inland Fisheries and Game.

By Mr. Wight of Newry—Petition of Lon E. Wight and 19 others, residents of Oxford county, parying that a law be enacted closing to all fishing for a term of five years Sunday river so called, a stream in Riley plantation, and in the towns of Newry and Bethel, in said county of Oxford, except that it may be lawful to fish in Sunday river below its junction with Bull branch on Thursday of each week during the open season for trout fishing; also that Bull branch, a stream in said Riley plantation, be closed to all fishing for a term of five years.

Also Petition of S. W. Bennett and 7 others of Magalloway plantation, Oxford county, praying that the law be amended so that fly fishing only be permitted on Rapid river; also that so much of Umbagog lake as is situated in the State of Maine be closed to all fishing except by the usual methods of casting with artificial flies and trolling, and that one party or boat-load of fishermen be permitted to catch and take but 10 pounds of fish in one day from this pond.

By Mr. Colcord of Searsport—Petition of Edwin W. Estabrooks and 49 others, citizens of Waldo county, praying that the open season on fishing for trout, salmon and smelts in Swan lake, in said Waldo county, be extended to October 15th.

By Mr. Knowlton of Monson—Petition of L. M. Gordon and 9 others, residents of Piscataquis county, praying that Big Lyford pond, in the county of Piscataquis, be closed to balt fishing for a period of five years.

By Mr. Labree of Cambridge—Petition of W. H. Watson and 74 others, of St. Albans, praying that a law be enacted to prohibit the taking of trout and salmon in Big and Little Indian ponds and tributaries, in the county of Somerset, for two years, and to prohibit ice fishing for other fish in these ponds except on Wednesday of each week for a period of four years; also that one family be prohibited from

catching or taking more than 15 pounds of pickerel on that day.

By Mr. Donigan of Bingham-Petition of W. R. Jordan and 9 others of Bingham and vicinity praying that a law be enacted making it unlawful for a person to catch with bait and hook more than 25 trout in one day in East Carry pond, in Somerset county, also that it be unlawful for a person to catch and kill with a fly more than 25 trout in one day, and that it shall be unlawful for any one person to catch and carry away more than 15 pounds of trout in one day from said pond.

# Orders of the Day.

On motion of Mr. Peacock of Lubec Resolve proposing an amendment to article four of the constitution of the State of Maine, establishing a people's veto through the optional referendum, and a direct initiative by petition and at general elections, was taken from the table, and on further motion by the same gentleman it was referred to the committee on the judiciary.

On motion of Mr. Mullen of Bangor the House took a recess until 11.55 o'clock.

After recess the House was called to order by the Speaker.

# In Convention.

At 12 o'clock the Senate and House met in convention in Representatives' Hall. The journals of both branches relating to the vote for United States Senator having been read, Sewall of Sagadahoc presented the following order and moved its passage;

Ordered, that Hon. William P. Frye of Lewiston be and hereby is declared duly elected senator in Congress for the term of six years, beginning on the fourth of March, A. D. 1907; and further ordered that the secretary of the convention forthwith inform the Gover-

and conveyed a message to the Senate nor of the election and declaration thereof by the Legislature of Hon. Wilthe term of six years beginning on the fourth of March A. D. 1907.

The order received a passage.

The PRESIDENT: And I declare William P. Frye of Lewiston elected to the Senate of the United States from the State of Maine for the term of six years beginning March 4th, 1907, and the secretary of the convention will convey the information to the Gover-

The secretary subsequently reported tnat he had performed the duty assigned him.

The Senate then retired.

#### In House.
