# Orders of the Day.

On motion of Mr. Milliken of Island Falls, bill, An Act to amend Section 15 of Chapter 80 of the Revised Statutes, was taken from the table.

On motion of Mr. Skidmore of Liberty, bill, An Act to amend Chapter 163, Public Laws of 1905, relating to the exemption of soldiers and sailors from poll tax, was taken from the table.

Mr. SKIDMORE: Mr. Speaker, in tabling this bill my purpose was to call the attention of the members of the House to the fact that this bill was treading on dangerous ground, that it created a class legislation, that is, it relieved from taxation a certain portion of our people who were well able to pay. The law relating to a poll tax by some is considered to be absurd and wholly wrong, but as for me I do not think so. It gives to those who are young and are just coming on the field of action, and who have not had the privilege that others have had to acquire property on which to be taxed, but by the payment of a poll tax a just and equal right to participate in the affairs of government.

Now there is a law on the statute books which this law calls attention to. which exempted all soldiers and sailors of the Civil War, from the payment of a poll tax who had taxable property that was not valued at \$500. So you see that in that respect it does not apply strictly to the poor and needy. There is another law also on our statute books which gives to the municipal officers of every city and town in this State the right to remit or abate the taxes, not only of soldiers and sailors of the Civil War, but of all persons who in their judgment were deemed worthy to be so exempted. So it seems to me that this law is not called for at the present time; and I have as much sympathy as anyone, I care not who, for the old soldier, for my people were in that war and did what they could towards its successfu! termi-. nation. But I do not believe it is right for any portion of our people to be relieved of a tax when they are able to pay it, and the national government has made ample provision-I do not say that in every case it has done that which is right and just to all, but I do say that in a majority of cases they have done that which was in keeping with the evidence and conditions which existed and which have been presented to them. They may have erred in some cases, and who can say that they have not, but in those cases there is a remedy for the soldiers, sailors and widows and those dependent upon them to appeal to the Pension Clerk of the State of Maine. And have been liberal there provisions past and there years is

ing at the present time still more provisions to continue the good work: and wherever the national government has failed to fulfill that condition, the State government through its pension clerk has come to the rescue and one what was right as far as they were able. So it seems to me that taking these facts into consideration there is ample law upon our statute books not only to protect the old soldier but to protect every one. Those I have talked with and those whom this law would benefit have objected to me to its passage, that it was wholly wrong and uncalled for, that they were ready and willing to bear their portion of the burdens of taxation. One of them called my attention to this fact, that there was living beside him a poor man with a large family who had no property; and he asked me how it would look for him to be relieved of a taxation and have one imposed upon that person. And there are many just such instances; and I have always found that wherever it was necessary for the old soldier to stand his burden, not only in time of war but in time of peace, he was ready to do so. If any one has any doubt of that let him go down into the rotunda of this Capitel where he can see there the colors which were borne by the hardy sons of Maine from the time of the firing upon Fort Sumpter until the close of that bloody period, and he will find that the hardy sons of Maine stood by their country and sought to uphold the principles of patriotism; and they are not afraid today to stand before the people in an honest and just cause as they did then. They are ready and willing to bear their burdens, and I believe that they are ready, no matter what the condition may be, to do their part towards sustaining the affairs of govern-
