On metion of Mr. Johnson of Waterville the order and amendment were ta-

bled for printing.

On motion of Mr. Weld of Old Town the bill, An Act relating to the exemption of soldiers and sanors from poll tax, was

taken from the table.

Mr. Weld offered an amendment by adding the following: "Provided, however, that any such said sailor or soldier who may desire to pay said tax, may, on or before the first day of April in each year, notify in writing the assessors of the city, town or plantation in which he may reside, of his desire to pay such tax, whereupon said assessors shall assess said tax against said soldier or sess said tax against sam some or sailor, and said soldier or sailor shall be legally holden to pay said tax."

The amendment was adopted, the bill

was read the third time and was passed

to be engrossed as amended.

On motion of Mr. Newbert of Augusta the bill relating to locations of street railroads was taken from the table and referred to the committee on railroads and expresses.

Mr. Safford of Kittery offered the fol-Mr. Sarrord of Kittery offered the following amendments to the titles of the foregoing bills: By adding to the title of the first the words, "relating to the docketing and records of warrants and appraisals of executors and administrators by registers of probate;" to the title of the second the words "relating to the line and recording of the warrants and of the second the words "relating to the filing and recording of the warrants and inventories by the register of probate returned by trustees of estates;" to the title of the third the words "relating to docketing of returns of warrants and record of appraisals of guardians by reg-sisters of probate;" and to the title of the fourth the words "relating to fees of reg-isters of probate on estates of non-resiisters of probate on estates of non-residents,"

The amendments were adopted, and the bills as amended were then referred to the committee on judiciary.
