Theriault to the seat occupied by him in this House. (Tabled pending acceptance of the reports on motion of Mr. Lord of Parsonsfield and Wednesday of next week assigned for their consideration.)

Majority and minority reports were presented by same committee, to which was referred remonstrance of Winfield S. Brown against the right of Lafay-

Mr. Stearns from the committee on legal affairs, on Bill An Act to amend Section 48 of Chapter 125 of the Revised Statutes, as amended by Public Laws of 1905, Chapter 70, relating to cruelty to animals, reported legislation inexpedient.

Mr. Danforth from the committee on mercantile affairs and insurance reported ought not to pass on Bill, An Act limiting the liability a surety company may assume upon any bond.

The reports were accepted and sent to the Senate.

#### Orders of the Day.

On motion of Mr. Flaherty of Portland the vote was reconsidered wherethe House accepted the report the committee judiciary on reporting ought to pass on "An Act to amend Section 36 of Chapter 101 of the Revised Statutes in relation to bail commissioners," and on further motion by the same gentleman the report was tabled.

On motion of Mr. Merrill of Monmouth the rules were suspended and remonthat gentleman introduced strances as follows: of C. H. Prescott and 45 others of Monmouth against removal of State capital; of J. E. Briggs and 28 others of Winthrop against same; of J. M. Prescott and 8 others of Monmouth against same; of B. C. Torsey and 30 others against same-which were referred to the committee on public buildings and grounds.

He also introduced under suspension of the rules remonstrance of M. C. French and 49 others against resubmission, which was referred to the committee on temperance.

Mr. Skidmore asked unanimous consent to suspend the rules in order that he might introduce six remonstrances against removal of the State capital.

Objection was made by Mr. Davies of Yarmouth.

On motion of Mr. Strickland of Bangor Resolve in favor of Eastern Maine Insane Hospital was taken from the table and referred to the committee on legal affairs.

On motion of Mr. Johnson of Waterville, Bill, "An Act to authorize the Somerset Railroad Company to extend its railroad from North West Carry in the town of Seboomook westerly and northerly to the Canadian line by one Railroad in Aroostook, Piscataquis and or more routes and authorize other railroad companies to purchase its

franchise and property" was taken from the table.

Mr. Johnson offered Amendment A to correct verbal inaccuracies in the bill.

The amendment was adopted, and the bill was then passed to be engrossed as amended

On motion of Mr. Dyer of Buckfield, Bill, "An Act creating a lien on horses, oxen, mules and other animals in certain cases, was taken from the table.

The bill was then read twice and assigned for to-morrow morning.

Mr. Horigan of Biddeford moved that the bill be indefinitely postponed.

M. DYER: Mr. Speaker, this was a bill presented to me by the request of a blacksmiths' association in my county who believed that they should have a lien on strike out horses and oxen for their sheoing. They believe that it is following out the custom of the State in granting liens to mechinics upon other articles upon which they perform work; and there is a precedent for it in a statute of Michigan which gives a lien on horses, oxen and mules for shoeing. When the question is put I demand the year and nays.

Mr. HORRIGAN: Mr. Speaker, my objection to the passage of this bill is that it is a certain species of class legislation and that it is unwise, and in a measure unjust. It would seem to me that it would be just as reasonable for some grocer or grain dealer to come here and ask for an act creating a lien for him upon an animal that consumed grain that he sold.

In the ordinary sense of the word the charge for shoeing a horse is a very small matter, something like a dollar or \$1.25, perhaps running up on heavy horses to \$1.75. That set of shoes will last that horse thirty days. Thirty days is the usual time upon which ordinary business is carried on in this respect. It would seem to me that a who was not blacksmith enough in looking after his accounts to collect the shoeing of that horse in thirty days, ought to lose it. And it also seems to me that the giving to that blacksmith, because he has been careless about collecting his bills, a

lien on animals, in preference to the man who sold him his grain or his hay or the harnesses or blankets or carriages or something else, is creating a certain species of legislation that is not only unwise but not for the best interests of the State of Maine; and it is for that purpose that I ask the members of the House to consider this matter and consider my motion to indefinitely postpone it.

The question being on the motion, shall the yeas aand nays be ordered,

The motion was lost.

The question then being on the motion to indefinitely postpone the bill,

The motion was agreed to.

On motion of Mr. Safford of Kittery Resolve requesting delegation in Congress to oppose the consolidation of pension agencies, was taken from the table and referred to the committee on federal relations.
